Alternatively you may request Brighton & Hove City Council to provide you with such still images from that record which, in their opinion, establish the contravention.

Service by post or electronically

- (1) This regulation makes provision about the service of documents under these Regulations, other than notices or orders made by a county court.
- (2) A notice or charge certificate which is required by these Regulations to be served by post-
 - (a) may be served by first class (but not second class) post, and
 - (b) where the person on whom it is to be served or to whom it is to be given is a body corporate, is duly served or given if it is sent by first class post to the secretary or clerk of that body.
- (3) Service of such a notice or charge certificate contained in a letter sent by first class post which has been properly addressed, pre-paid and posted is to be taken to have been effected on the second working day after the day of posting.
- (4) For the purposes of paragraph (3) "working day" means any day except-
 - (a) a Saturday or a Sunday,
 - (b) New Year's Day,
 - (c) Good Friday,
 - (d) Christmas Day, or
 - (e) any other day which is a bank holiday in England and Wales under the Banking and Financial Dealings Act 1971(1).

The specified Grounds The alleged contravention did not occur. (Please explain why you believe no contravention took place.) How to make representations in respect of this notice

If you believe that the penalty charge should not be paid you may make representations to Brighton and Hove City Council asking that the charge be cancelled.

Alternatively, if you do not have access to the internet complete the representation section of this form below and post it to Brighton and Hove City Council, PO Box 204, Sheffield, S98 1LS. Please quote the Penalty Charge Number in all correspondence.

Representations which are made after the expiry of the 28 day period specified on the first page of this Penalty Charge Notice may be disregarded. This Notice will be taken to have been served on the second working day after the day of posting unless you can show that it was not. If you submit your representations late, you should explain why.

The statutory grounds on which representations may be made are set out below together with an indication of the information which you should supply in support of your representations. It is important to provide all relevant information. Tick the relevant boxes and write your reasons in the box on the following page. This Notice **will** be cancelled if one or more of the specified grounds is established. This Notice **may** be cancelled for other compelling reasons even if none of the specified grounds apply. If the Notice is cancelled any sums already paid will be refunded.

If your representations are received in time or are received late but are taken into account, Brighton & Hove City Council will let you know its decision in writing not later than the last day of the period of 56 days beginning with the date on which your representation was served on it. If it fails to do so, this Notice will be cancelled and any sums already paid will be refunded. If your representations are rejected, you have the right to appeal against that decision to an independent Adjudicator. An appeal form will be sent with the letter rejecting your representations. The form will explain how and when to appeal to the adjudicator.
