ROAD TRAFFIC REGULATION ACT 1984 - SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for the Environment, Transport and the Regions, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of the waiting restrictions along the High Street, Colchester, hereby:-

- 1. authorises the erection at or within 5 metres of the sites marked with a red cross on the attached plan numbered GT46/9/4(Pt3) 4 of a traffic sign (hereinafter referred to as "the authorised sign A") conforming as to size, colour, and character with that shown at M in the attached schedule of drawings numbered GT46/9/4(Pt3) 5; and
- 2. authorises the erection at or within 5 metres of the sites marked with a blue cross on the said plan of a traffic sign (hereinafter referred to as "the authorised sign B") conforming as to size, colour, and character with that shown at N in the said schedule; and
- 3. authorises the erection at or within 5 metres of the sites marked with a green cross on the said plan of a traffic sign (hereinafter referred to as "the authorised sign C") conforming as to size, colour and character with sign V in the said schedule; and
- 4. authorises the erection at or within 5 metres of the site marked with a brown cross on the said plan of a traffic sign (hereinafter referred to as "the authorised plate A") conforming as to size, colour and character with the plate shown at J(A) in the said schedule; and
- 5. authorises the erection at or within 5 metres of the sites marked with a pink cross on the said plan of a traffic sign consisting of a plate (hereinafter referred to as "the authorised plate B") conforming as to size, colour, and character with that shown at W(A) in the said schedule; and





- 6. authorises the erection at or within 5 metres of the sites marked with a pink cross on the said plan of a traffic sign consisting of a plate (hereinafter referred to as "the authorised plate C") conforming as to size, colour, and character with that shown at W(B) in the said schedule; and
- 7. directs that the authorised plate A shall only be used with the sign shown in diagram 617 in Schedule 2 to the Traffic Signs Regulations 1994 (Part I of SI 1994/1519, "the 1994 Regulations"); and
- 8. directs that the authorised plates B and C shall only be used with the sign shown in diagram 801 in Schedule 4 to the 1994 Regulations; and
- 9. directs that the road markings shown in diagram 1018.1 and 1020.1 in Schedule 6 to the 1994 Regulations need not be used with the authorised signs A and B within the area covered by the restricted zone as shown on the said plan; and
- 10. directs that the road markings shown in diagrams 1025.1, 1025.3, 1028.2, 1028.3, 1028.4 and 1032 in Schedule 6 to the 1994 Regulations need not be used within the area covered by the restricted zone as shown on the said plan except where such markings are indicated; and
- 11. directs that it is a condition of this authorisation that the authorised signs and plates may be placed only to indicate the effect of a corresponding Traffic Regulation Order; and
- 12. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs and plates at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs and plates and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

sign B in the same manner as they apply to the sign shown in diagram 637.2 in Schedule 2 to those

Regulations.

The provisions of Regulations 12, 18 and 19 of the 1994 Regulations shall apply to the authorised

sign C in the same manner as they apply to the sign shown in diagram 661 in Schedule 2 to those

Regulations.

The provisions of Regulations 12 and 20 of the 1994 Regulations shall apply to the authorised plate

A in the same manner as they apply to the plate shown in diagram 618.1 in Schedule 2 to those

Regulations when used in conjunction with the sign shown in diagram 617.

The provisions of Regulations 12 and 20 of the 1994 Regulations shall apply to the authorised plates

B and C in the same manner as they apply to the plate shown in diagram 804.1 in Schedule 4 to those

Regulations when used in conjunction with the sign shown in diagram 801.

This authorisation replaces the earlier one issued on 13 May 1999 under reference GT46/9/4 which

has lapsed.
