## PERMIT CONDITIONS

### The permit is only valid in the allocated town/class - permits are not transferable between towns

- Long Stay permits are only valid in the class of car parks stated below, in the town you requested.
- The permit must be clearly displayed in the windscreen of your vehicle. Photocopies of permits are not permitted.
- The permit is only valid if the corresponding registration is on the permit. You may have up to two registrations on your permit. However, the permit only covers one vehicle at a time. If more than one car needs to park in any of the car parks at the same time, you will have to purchase a pay and display ticket for any vehicle not displaying the permit.
- If you permanently change your vehicle you must notify this office immediately and return your permit to the East Riding of Yorkshire Council, PO Box 299, Beverley, HU17 6FH so it can be amended.
- If you change your vehicle temporarily, i.e. need to use a hire car, you must notify this office immediately in writing, telling us the registration number and details of the new vehicle and how long it will be used for (maximum of 14 days).
- If your permit is stolen or lost, it will be replaced free of charge on receipt of an official police crime or lost property reference number.
- The issue of a permit does not guarantee an available car parking space.
- Refunds on permits will be based on the permit cost, less a deduction of 10% for each month or part month of use, together with a  $f_2 29.00$  deduction for administration charges.
- You should renew your permit BEFORE the expiry date in order to avoid getting a Penalty Charge Notice.
