TRAFFIC MANAGEMENT ACT 2004 NOTICE OF REJECTION OF REPRESENTATION

Thank you for your written representation received in connection with the above Penalty Charge Notice (PCN).

The Council has a statutory duty to consider each individual case, and where appropriate, exercise discretion. Unfortunately, on this occasion, the Council does not feel that the circumstances you have outlined warrant the PCN being waived. The Council's policy for dealing with informal and formal challenges has also been considered, a copy of which can be found on the Council's website www.gravesham.gov.uk/parking

Each point you have raised has been responded to below, which explains why the Council contend that the PCN should not be cancelled.

However, on this one occasion, \mathfrak{L} will be accepted as full payment if received by . Failure to pay the reduced amount by this date will result in the full charge being payable.

You now have 28 days to either pay the PCN or to appeal to the Traffic Penalty Tribunal Service. The 28 day period for paying or appealing starts from the date of service.

Both services can be accessed 24 hours a day, 7 days a week and payments are processed in real time. Please refer to your PCN or the Gravesham website for other payment methods.

PAYMENT OF PENALTY CHARGE

Unless you appeal to the Traffic Penalty Tribunal you must pay the PCN of £70.00 to Gravesham Borough Council within the 28 period which starts to run from the date of service. Failure to pay will result in the issue of a Charge Certificate by the Local Authority, which will increase the charge due by 50%. If the increased charge is not then paid within a further 14

days, the Council will then apply to the County Court to recover the charge as if it were a debt payable under a County Court Order.

APPEAL TO THE TRAFFIC PENALTY TRIBUNAL SERVICE

If you disagree with the council's decision you can appeal to the independent adjudicator at the **Traffic Penalty Tribunal**. The adjudicators are independent of the council and their decision is final.

You can appeal now by visiting the tribunal's website: www.trafficpenaltytribunal.gov.uk/appeal

The website explains what the adjudicator can consider and how to appeal. There is no charge for appealing and costs are not normally awarded. The website gives full details. You will need the information in the box below to hand when you begin your appeal.
