## Payment

**Telephone:** Call 01983 823714 Monday to Friday 8am to 6pm, Saturday 9am to 1pm.

**Online Banking:** Payment should be made from your bank to the Council using the details given here. Account Number: 47672552, Sort Code: 541034. Please quote 'PCN«PCN\_Ticket\_Number»'. If making payment from abroad you will need the following: IBAN - GB26NWBK54103447672552, BIC - NWBKGB2L

**Post:** Please make cheques payable to Isle of Wight Council and write your penalty charge notice number and the vehicle registration number on the reverse of the cheque. Please note that postal payments should be sent recorded delivery.

## Appeal

If you disagree with the council's decision you can appeal to the independent adjudicator at the **Traffic Penalty Tribunal**. The adjudicators are independent of the council and their decision is final.
