

If the penalty charge is paid not later than the last day of the period of 14 days beginning with the date on which the notics is served, the penalty charge will be reduced by 50 percent. After this date you will be required to pay the full amount. It is your responsibility to ensure that your payment is received by the Council on time. Payments by telephone or over the web are the most reliable ways of ensuring that your payment is received on time.

WHAT HAPPENS NEXT

Challenges to Maidstone Borough Council will be considered prior to a Notice to Owner being served in writing to Maidstone Borough Council, P.O box No249, Maidstone, Kent ME 16 8BQ, or online at http://pcn.maidstone.gov.uk. All cases will be considered on their individual circumstances. If we receive your challenge not later than the last day of the period of 14 days beginning with the date on which the notice is served, progression of the charge will be put on hold pending a reply. If your challenge is rejected the Council will usually re-offer the 14 day discount period. Telephone challenges will not be accepted.

If the penalty charge is not paid before the end of the 28 day period as specified on the front of this notice or successfully challenged, the Council may serve a Notice to Owner on the owner of the vehicle requesting payment of the penalty charge. The Notice to Owner will describe how the owner can make representation to the Council and if rejected how to appeal to an independent Adjudicator.
