If you challenge this penalty charge notice within 14 days of the date that it is served and the challenge is rejected, the Enforcement Authority will extend the period within which the penalty charge may be paid.

# IF THE PENALTY CHARGE IS NOT PAID OR CHALLENGED

WARNING: If the penalty charge is not paid or challenged on or before the end of 28 days of the date of service, then the North East Lincolnshire Council Enforcement Authority may serve a Notice to Owner (NtO) on the owner of the vehicle requiring payment of the penalty charge. The owner can then make representations to the North East Lincolnshire Council Enforcement Authority. If those representations are rejected, the owner may appeal to an independent adjudicator.

If you challenge this penalty charge notice, but an NtO is issued, then the owner must follow the instructions on the NtO.
