NOTE: The person appearing to be in charge of the vehicle was served with a penalty charge notice (PCN) which allowed 14 days for payment of a 50% discounted penalty charge; otherwise the full penalty charge became due. Either no payment has been received or any payment received has been insufficient to clear the penalty charge.

A penalty charge of £ «PCN\_ is now payable by you as the owner and must be paid not later than the last day of the period of 28 days beginning with the date on which this Notice is served. This Notice will be taken to have been served on the second working day after the day of posting (as shown above) unless you can show that it was not.

You may make representations to North Lincolnshire Borough Council as to why this penalty charge should not be paid. These representations should be made not later than the last day of the period of 28 days beginning with the date on which this Notice is served and any representations which are made outside that period may be disregarded.

NOTE: If you do not pay the penalty charge or make representations before the end of the 28 day period specified above the Council may increase the original penalty charge, or any outstanding balance, by 50% to £ «PCN\_Amount\_Outstand\_plus\_50» and take steps to enforce payment.

### **HOW TO PAY**

- On line www.northlincs.gov.uk, select 'Transport and Streets' on the front page and select 'Pay your parking fine'
- **Telephone** debit card payments. Ring 01724 297000 (Mon-Thur 9am-4.30pm, Fri 9am-4pm). Have your card details and PCN number ready.
- Post cheque/postal order, made payable to NORTH LINCOLNSHIRE COUNCIL, and using the

  2 working days for 1<sup>st</sup> class post and 5 for 2<sup>nd</sup> class.
- **Post Office** payment can be made by CASH, CHEQUE or DEBIT CARD at any Post Office. The barcode on the PCN will be used for this purpose..
- PayPoint payment can be made by CASH at any Pay Point outlet. The barcode on the PCN will be used for this purpose.
- In Person Cashiers, Civic Centre, Scunthorpe. The Angel, Brigg.

## **HOW TO MAKE REPRESENTATIONS**

If you believe that the penalty charge should not be paid you may make representations to North Lincolnshire Borough Council. Representations must be in writing and you may use this form. The representations may be made by:

Representations which are made after the end of the 28 day period specified on the first page of this Notice may be disregarded. This Notice will be taken to have been served on the second working day after the day of posting unless you can show that it was not. For more information on this, please turn to the last page of this Notice. If you submit your representations late, you should explain why.

The statutory grounds on which representations may be made are set out below together with an indication of the information which you should supply in support of your representations. It is important to provide all relevant information. Tick the relevant boxes and write your reasons in the box on the following page. This Notice will be cancelled if one or more of the specified grounds is established. This Notice may be cancelled for other compelling reasons even if none of the specified grounds apply. If the Notice is cancelled any sums already paid will be refunded.

If your representations are received in time or are received late but are taken into account, North Lincolnshire Borough Council will let you know its decision in writing not later than the last day of the period of 56 days beginning with the date on which your representation was served on itecht its lautoper do so, this Notice will be cancelled and any sums already paid will be refunded. If your

representations are rejected, you have the right to appeal against that decision to an Independent Adjudicator. An appeal form will be sent with the letter rejecting your representations. The form will explain how and when to appeal to the adjudicator.

### THE SPECIFIED GROUNDS

#### THE RULE RELATING TO SERVICE

The Civil Enforcement of Parking Contraventions (England) General Regulations 2007: Regulation 3

## "Service by post

- 3-(1) Subject to paragraph (5), any notice (except a penalty charge notice served under regulation 9) or charge certificate under these Regulations-
- (a) may be served by first class (but not second class) post; and
- (b) where the person on whom it is to be served is a body corporate, is duly served if it is sent by first class post to the secretary or clerk of that body.
- (2) Service of a notice or charge certificate contained in a letter sent by first class post which has been properly addressed, pre-paid and posted shall, unless the contrary is proved, be taken to have been effected on the second working day after the day of posting.
- (3) In paragraph (2), "working-day" means any day except-
- (a) a Saturday or a Sunday
- (b) New Year's Day
- (c) Good Friday
- (d) Christmas Day
- (e) Any other day which is a bank holiday in England and Wales under the Banking and Financial Dealings Act 1971.
- (4) A document may be transmitted to a vehicle hire firm (as defined in regulation 5 (4)) by a means of electronic data transmission where-
- (a) the vehicle hire firm has indicated in writing to the person sending the notice or document that it is willing to regard a document as having been duly sent to it if it is transmitted to a specified electronic address; and
- (b) the document is transmitted to that address
- (5) Nothing in this regulation applies to the service of any notice or order made by a county court
