



**ROAD TRAFFIC REGULATION ACT 1984 - SECTIONS 64 AND 65
AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS**

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of permitting certain classes of vehicle to proceed beyond vehicle prohibitions in the City of Nottingham hereby:-

1. authorises the erection at suitable sites on roads for which the City of Nottingham is the traffic authority of a traffic sign consisting of a plate (hereinafter referred to as "the authorised plate A") conforming as to size, colour and character with that shown on the attached drawing numbered GT50/117/0017-1, save that the indication of the time of day may be varied; and
2. authorises the erection at suitable sites on the said roads of a traffic sign consisting of a plate (hereinafter referred to as "the authorised plate B") conforming as to size, colour and character with that shown on the attached drawing numbered GT50/117/0017-2, save that the indication of the time of day may be varied; and
3. authorises the erection at suitable sites on the said roads of a traffic sign consisting of a plate (hereinafter referred to as "the authorised plate C") conforming as to size, colour and character with that shown on the attached drawing numbered GT50/117/0017-3, save that the indication of the time of day may be varied; and
4. authorises the erection at suitable sites on the said roads of a traffic sign consisting of a plate (hereinafter referred to as "the authorised plate D") conforming as to size, colour and character with that shown on the attached drawing numbered GT50/117/0017-4, save that the indication of the time of day may be varied; and



5. directs that the authorised plates A or B shall only be used with a sign to diagram 619 in Schedule 2 to the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations"); and
6. directs that authorised plate C shall be used with a sign to diagram 609 in Schedule 2 to the 2002 Regulations; and
7. directs that the authorised plate D may be added beneath a sign to diagram 953 in Schedule 5 to the 2002 Regulations; and
8. directs that it is a condition of the authorisation that the authorised plates A, B, C and D may be placed only to indicate the effect of a corresponding Traffic Regulation Order; and
9. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the placing of the authorised plates A, B C and D at or near the said site shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised plates A, B C and D and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 12 and 20 of the 2002 Regulations shall apply to the authorised plates A and B in the same manner as they apply to the plate shown in diagram 620 when used in conjunction with the sign to diagram 619 in Schedule 2 to those Regulations.

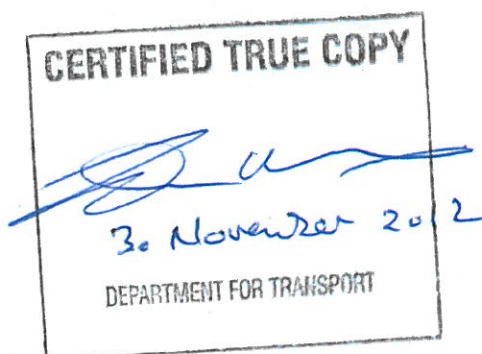

The provisions of Regulations 12 and 20 of the 2002 Regulations shall apply to the authorised plate D in the same manner as they apply to the plate shown in diagram 953.2 in Schedule 5 to those Regulations when used in conjunction with the sign to diagram 953 in Schedule 5 to those Regulations.
