RESIDENTS PARKING SCHEMES

CHARGES FOR PERMITS

A charge of £25 per permit is applicable to all permits issued for use in residents' permit schemes. This is in line with the County Council's budget proposals which were subject to consultation from November 2009 and confirmed on 25 February 2010.

This charge is to cover the cost of administration, the management of the permit scheme and the direct costs of permits. Please note that the charge is not a charge for parking. Permits enable holders to make use of permit holder only parking when available but is not a guarantee of a parking place space within the scheme or at a specific location within a scheme to which the permit applies.

The charge is applied **per each permit** issued so if permits are **lost**, the original will be cancelled and a further charge will be made to cover any replacement. Please note that the Residents Permits must be used within the vehicle stipulated on the permit. The enclosed sheet provides further information on how a Controlled Parking Zone operates.

Concessions

Resident's permits are provided free of charge to **vehicle-owning residents** who are **either Blue Badge holders** or are **aged 75 or over**. Where applicable, a free visitor's permit can also be issued to each household with a resident aged 75 or over or who holds a valid Blue Badge.

Residents eligible for concessions need to provide proof of their entitlement by including a **COPY** of appropriate documents as follows:

For Resident's Permit - A **COPY** of the blue badge (blue badge concession) or driving licence (age concession). Details must correspond with both the vehicle insurance documents and proof of residency.

For Visitor's Permit - A **COPY** of the blue badge (blue badge concession) or official document showing date of birth (age concession). Details must correspond with the proof of residency.
