



### HOW TO PAY

- By telephone Credit/ debit card payments only. Automated payment line 0345 520 1357 (24 hours / 7 days a week). Have vehicle details and PCN Number ready.
- Online at [www.nottinghamshire.gov.uk/parkingenforcement](http://www.nottinghamshire.gov.uk/parkingenforcement). Follow links from online payments.
- By post using the payment slip below to:  
Central Processing Unit, PO Box 10282, Nottingham, NG17 0DX.  
Allow 2 working days for 1st class post and 5 for 2nd class.
- Please do not send any payment if wish to challenge this penalty charge (see below).

The owner can then make representations to the Central Processing Unit and may appeal to an independent adjudicator if those representations are rejected. The NtO will contain instructions for doing this.
