

PENALTY CHARGE NOTICE (PCN)

The Traffic Management Act 2004, s78; Civil Enforcement of Parking Contraventions (England) General Regulations 2007; Civil Enforcement of Parking Contraventions (England) Representation and Appeals Regulations 2007

Where this Penalty Charge Notice (PCN) is issued for a contravention in an off-street car park, the enforcement authority is Rushmoor Borough Council. In all other cases the enforcement authority is Hampshire County Council, with Rushmoor Borough Council acting as its agent under delegated powers.

If you challenge this PCN within 14 days your representations will be considered. If we reject your challenge, we will decide in each case whether to extend the period within which the reduced penalty charge may be paid.

If the penalty charge is not paid or challenged

If the penalty charge is not paid before the end of the 28 day period specified on the front of this notice, or successfully challenged, the enforcement authority (*) may serve a Notice to Owner (NtO) on the owner of the vehicle, requiring payment of the penalty charge. The owner can then make representations to the enforcement authority and may appeal to an independent adjudicator if those representations are rejected. The NtO will contain instructions for doing this. If you challenge this PCN but the council issues an NtO anyway, the owner must follow the instructions on the NtO.

(*) Where the penalty charge is issued for a contravention in an off-street car park, the enforcement authority is Rushmoor Borough Council. In all other cases the enforcement authority is Hampshire County Council, with Rushmoor Borough Council acting as its agent under delegated powers.
