- By Post: using the payment slip below to: The Parking Shop, PO Box 152, Watford, Herts WD18 0YD, Allow 2 working days for 1st class post and 5 for 2nd class.
- In Person: at The Parking Shop, 71 73 Market Street, Watford, Herts WD18 0PS, Mon Sat 8am to 6.30pm

You cannot contest this penalty if you make payment.

## If you believe that the Penalty should not be paid and wish to challenge this PCN

If you challenge this PCN within 14 days and the challenge is rejected, the Council will extend the period within which the reduced Penalty Charge may be paid.

## IF THE PENALTY CHARGE IS NOT PAID OR CHALLENGED

If the Penalty Charge is not paid on or before the end of the 28 day period as specified on the front of this notice or successfully challenged, the Council may serve a Notice to Owner (NtO) on the owner of the vehicle requiring payment of the Penalty Charge. The owner can then make representations to the Council and may appeal to an independent adjudicator if those representations are rejected. The NtO will contain instructions for doing this.

If you challenge this PCN but the Council issues an NtO anyway, the owner must follow the instructions on the NtO.
