Please find your visitors permit attached below. This should be carefully detached and displayed in your visitor's windscreen, using the enclosed permit holder. If it is not clearly displayed a Penalty Charge Notice may be issued.

The conditions of use state that you must return this permit when you cease to be a resident of the property, and that it is not for your own use or another member of your household.

Please note that the permit only allows your visitor to park within the Parking Area «Permit_Valid_Location_Desc» for which your permit is valid, and within the permit spaces marked as parking bays for permit holders. If your visitor parks on double yellow lines or single yellow lines during restricted hours they may be issued with a parking ticket. Please ensure that your visitor parks their car with thought for others by leaving as small a gap as is practical, and note that if they park across driveways you will risk having your visitor permit cancelled.

Visitor permits are not valid in Three Rivers public car parks. You are advised that having a visitor permit does not guarantee your visitor a parking space and lost visitor permits will not be replaced.
