By Post payable to TMBC using the payment slip below to: Financial Services, Council Offices, Gibson Building, Gibson Drive, Kings Hill, West Malling, Kent, ME19 4LZ. Please write your PCN number on the cheque or postal order. You should retain proof of postage as you may need this if there is a query over late payment.

In person at our offices at Kings Hill - Monday to Friday 8:30am to 5pm, or at Tonbridge Castle - Monday to Friday 8:30am to 5pm, Saturday 9am to 5pm and Sunday 10:30am to 4:30pm

If you believe that the Penalty should not be paid and wish to challenge this PCN

Please quote the PCN number, the vehicle registration number and your full name and address in all contacts.

If you challenge this PCN within 14 days of service and the challenge is rejected the Council will usually reinstate the 14 day discount period.

If the Penalty Charge is not paid or challenged

If the Penalty Charge is not paid on or before the end of the 28 day period as specified on the front of this notice or successfully challenged the council may serve a Notice to Owner (NIO) on the owner of the vehicle requiring payment of the Penalty Charge. The owner can then make representations to the Council and may appeal to an independent adjudicator if those representations are rejected. The NIO will contain instructions for doing this. If you challenge this PCN but the Council issues an NIO anyway, the owner must follow the instructions on the NIO.

Enforcement authority

Where this PCN is issued for a contravention in an off street car park, the enforcement authority is Tonbridge and Malling Borough Council. In all other cases the enforcement authority is Kent County Council, with Tonbridge and Malling Borough Council acting as its agent.

If sending correspondence or payment by post it is always advisable to retain proof of postage as you may be asked to provide this in a case of undelivered payment or challenge.
