Your representations against the above Penalty Charge Notice have been carefully considered in the light of the circumstances at the time and in accordance with the Traffic Management Act 2004. Grounds for cancellation of the charge have not been established and this letter is the formal Notice of 'Rejection of Representations'.

Please find enclosed a copy of a photograph of your vehicle with the Penalty Charge Notice attached at the time of issue. Therefore your vehicle was in contravention as described above and was liable to the  $\pounds$  «PCN\_Amount\_of\_Full\_Fine» penalty charge. This must be paid before the end of the 28 days commencing on the date this notice has been served.

If you disagree with the council's decision you can appeal to the independent adjudicator at the Traffic Penalty Tribunal. The adjudicators are independent of the council and their decision is final.

You can appeal now by visiting the tribunal's website: www.trafficpenaltytribunal.gov.uk/appeal

The website explains what the adjudicator can consider and how to appeal. There is no charge for appealing and costs are not normally awarded. The website gives full details. You will need the information in the box below to hand when you begin your appeal.


Traffic Penalty England and Tribunal Wales

Failure to pay, or to lodge an Appeal, will result in a Charge Certificate being issued which will increase the original charge by 50% to (£«PCN CC Total») If this is not paid, legal proceedings will be commenced to recover the money.

Payment can be made as indicated on the attached sheet, making your remittance payable to Warrington Borough Council, quoting the Penalty Charge Notice «PCN\_Ticket\_Number».
