



**ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65
AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS**

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of traffic restrictions in Wolverhampton City Centre, hereby:

1. authorises the erection at the sites marked "RS302" and "RS1502" on the attached plan numbered GT50/187/0008-1 of a traffic sign (hereinafter referred to as "the authorised sign") conforming as to size, colour and character with that shown on the attached drawing numbered NP958.14; and
2. directs that, notwithstanding the provisions of Direction 21 of the Traffic Signs General Directions 2002 (Part II of S.I. 2002/3113), signs to diagram 609 or 613 in Schedule 2 to the Traffic Signs Regulations 2002 (Part I of S.I. 2002/3113, "the 2002 Regulations") and signs to diagram 953 in Schedule 5 to the 2002 Regulations may be used in combination with a plate to diagram 954.3 in Schedule 5 to those Regulations when the legend is varied to "Except buses, cycles, taxis and authorised vehicles", "Except buses, taxis and authorised vehicles" or "Except authorised vehicles" at the sites marked "RS108", "RS402", "RS403", "RS405", "RS406", "RS601", "RS602", "RS1009" and "RS1501" on the said plan; and
3. directs that it is a condition of this authorisation that the authorised sign shall only be placed to indicate the effect of a corresponding Traffic Regulation Order; and

4. directs without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised sign at the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised sign and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

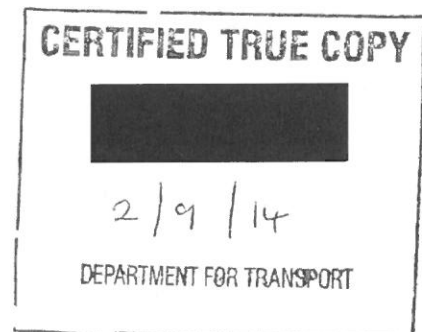
The provisions of regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign in the same manner as they apply to the sign shown in diagram 958 in Schedule 5 to those Regulations.
