NOTICE OF REJECTION OF REPRESENTATIONS

The Traffic Management Act 2004 – Part 6; Civil Enforcement of Parking Contraventions (England) General Regulations 2007; Civil Enforcement of Parking Contraventions (England) Representations and Appeals Regulations 2007.

Where the Penalty Charge Notice (PCN) was served for a contravention in an off-street car park the Enforcement Authority is Cambridge City Council. In all other cases the Enforcement Authority is Cambridgeshire County Council, with Cambridge City Council acting as it's agent.

Thank you for your representations in respect of the above parking contravention and the Notice to Owner dated <Date of Notice to Owner>. The PCN was correctly served and, whilst I understand the circumstances you have described, they are not sufficiently compelling for the PCN to be cancelled. Your representation has been rejected for the following reason:

The penalty charge of £<PCN amount> is now payable. This must be paid before the end of 28 days beginning with the date of service of this Notice. (CONTINUED)

You must now decide whether to PAY the penalty charge or whether to APPEAL. Please note, If you do not either appeal or pay the penalty charge within the 28 day period set above, the enforcement authority may serve a charge certificate on you increasing the penalty by 50%, to £<PCN amount + 50%>.

How to Pay

Payment should only be made if the Notice is not disputed

Online: by Debit or Credit card at www.cambridgeshire.gov.uk/parkingticket please ensure you have your card and vehicle details and PCN number ready.

By Telephone: using Debit and Credit Card, payment can be made anytime on **0843 357 1552** using touchtone facilities, or Monday to Friday 9am to 5pm (excluding bank holidays), on 01223 727900. Please ensure you have your card and vehicle details and PCN number ready.

By Post: using the payment slip below to: Parking Enforcement Services. PO Box 121, Cambridge. CB1 2WW. Cheques or postal orders should be made payable to **Cambridgeshire County Council** and include the Notice number and your address on the reverse. Allow 2 working days for 1st class and 5 for 2nd class. **Do NOT send cash. Post dated cheques will not be accepted**

How to Appeal

If you disagree with the council's decision you can appeal to the independent adjudicator at the **Traffic Penalty Tribunal**. The adjudicators are independent of the council and their decision is final.

You can appeal now by visiting the tribunal's website: www.trafficpenaltytribunal.gov.uk/appeal

The website explains what the adjudicator can consider and how to appeal. There is no charge for appealing and costs are not normally awarded. The website gives full details. You will need the information in the box below to hand when you begin your appeal.

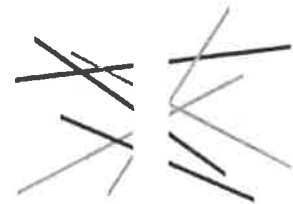

Costs

The Adjudicator will not normally make an order awarding costs and expenses to either an appellant or to an enforcement authority but **may** do so where the Adjudicator is of the opinion that one of those parties to the appeal has acted frivolously or vexatiously or that the conduct in making, pursuing or resisting an appeal was wholly unreasonable. No order for costs would be made without giving the affected party an opportunity of making representations against the making of the order. (CONTINUED)
