

**City of Coventry (Stoney Road)**  
**(Bus Lane) Order 2012**

The Council of the City of Coventry ("the Council"), in exercise of their powers under Sections 1(1), 2(1) and (2) and 124(1) and parts III and VI of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. This Order shall come into operation on the 16th day of April 2012 and may be cited as the "City of Coventry (Stoney Road) (Bus Lane) Order 2012".
2. (i) In this Order:-
  - (a) a reference to an article followed by a number is a reference to the Article of this order so numbered;
  - (b) "bus" has the same meaning as in regulation 22 of the Traffic Signs Regulations and General Directions 2002;
  - (c) "bus lane" means the length of road described in the First Schedule to this Order and indicated by signs as prescribed in the Traffic Signs Regulations and General Directions
  - (d) "cause" includes permit and causing shall be construed accordingly;
  - (d) "enactment" means any enactment, whether public general or local and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment;
  - (d) "pedal cycle" has the same meaning as in regulation 4 of the Traffic Signs Regulations and General Directions 2002;
  - (e) "traffic signs regulations and general directions" means The Traffic Signs Regulations and General Directions 2002 and any amendment thereto;
  - (f) "vehicle" includes any part of a vehicle
- (ii) The Interpretation Act 1978 shall apply for interpretation of this order as it applies for the interpretation of an Act of Parliament.
3. Save as provided in Article 4 of this order, no person shall, except upon the direction or with the permission of a Police Officer in uniform or a Civil Enforcement Officer as defined in the Traffic Management Act 2004 and appointed by the Council cause or permit any vehicle to be in/proceed in the bus lane specified in the First Schedule to this Order
4. Nothing in Article 3 of this Order shall apply to any vehicle listed in the Second Schedule to this Order
5. The restrictions, prohibitions and requirements imposed by this Order shall be read and construed as not being in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption to the provisions of this Order is without prejudice to the provisions of any other enactment.



## FIRST SCHEDULE

The nearside lane of Stoney Road (south carriageway) commencing at a point four (4) metres south west of its junction with Manor Road and continuing to a point forty-seven (47) metres north of its junction with Michaelmas Road

## SECOND SCHEDULE

Nothing in Article 3 of this Order shall apply to a:-

- (a) bus
- (b) pedal cycle
- (c) vehicle being used for police, fire or ambulance service purposes in circumstances of an emergency
- (d) vehicle being used for:-
  - (i) the removal of any obstruction to traffic
  - (ii) the maintenance, improvement or reconstruction of the length of road
  - (iii) the laying, erection, alteration or repair or any sewer, main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus
  - (iv) the repair, replacement, maintenance or cleaning of any bus stop or shelter
- (e) local authority, water or sewage undertaker in pursuance of statutory powers or duties
- (f) any vehicle being used in accordance with and indication given by a traffic sign which has been placed pursuant to Sections 66 and 67 of the Act.
- (g) vehicle accessing but not egressing from 41 and/or 43 Stoney Road in the City of Coventry
