I am directed by the Secretary of State to refer to your declaration form applying for the use of an approved device under a manufacturer's certification dated 19<sup>th</sup> April 2023.

After a review of the information provided in your submitted declaration form, the Secretary of State acknowledges that the device described in your application:

- meets the requirements, and is approved for the purposes of, Regulation 4 and Schedule 1 to the 2022 Regulations for the enforcement types specified above, and
- (Where bus lane is specified in enforcement type above and the applicant is a Traffic Authority within Greater London), is approved for the purposes of bus lane enforcement under Part II and paragraph 7(2) of Schedule 1 to the London Local Authorities Act 1996.

The device is therefore certified for use in relation to the civil enforcement of road traffic contraventions in the Portsmouth City Council area.
