**ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65
AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS**

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of the conditions of use of a bus gate on Southcote Lane, Reading, hereby:-

1. authorises the erection at or within 5 metres of the sites indicated with a schematic drawing on the attached plan numbered GT46/10/51(Pt1)-4 of a traffic sign consisting of a plate (hereinafter referred to as “the authorised plate”) conforming as to size, colour and character with that shown at ‘A’ on the attached drawing numbered GT46/10/51(Pt1)-5; and
2. directs that the authorised plate shall only be used in combination with the sign shown in diagram 879 in Schedule 4 to the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, “the 2002 Regulations”); and
3. directs that, notwithstanding the provisions of Direction 20(1) of the Traffic Signs Directions 2002 (part II of SI 2002/3113) the sign in diagram 953 in Schedule 5 to the may be used in combination with the authorised plate; and
4. directs that it is a condition of this authorisation that the authorised plate may be placed only to indicate the effect of a corresponding Traffic Regulation Order; and

5. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised plate at or near the said sites shall continue to have effect only until such day as may be appointed by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised plate and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

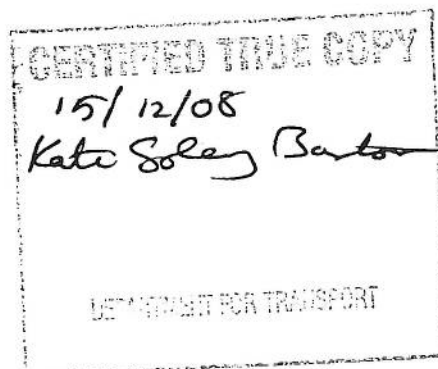
The provisions of Regulations 12 and 20 of the 2002 Regulations shall apply to the authorised plate in the same manner as they apply to the plate shown in diagram 953.2 when used in combination with the sign shown in diagram 953 in Schedule 5 to those Regulations.

Diagram 953 - 750 roundel

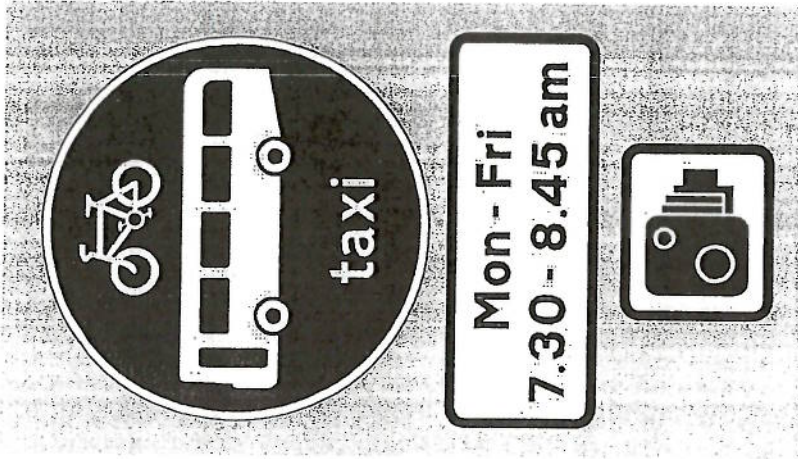
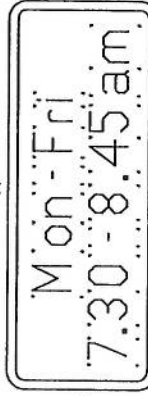


Diagram 879 - 75 x-height (525 x 440mm)
