



SHORT STAY

Miller Street Car Park

Park FREE for up to 2 hours!

There's no need to display a ticket

Maximum stay - 2 hours No return within 1 hour



FREE - for up to 2 hours



FREE - for up to 2 hours (park in standard bay)



PROHIBITED - vehicles over 5 tonnes

24 hours Monday to Sunday including Bank Holidays

You will be liable to a Penalty Charge if you do not:

- 1. Comply with the maximum stay and no return conditions.
- 2. Park wholly within a marked bay, where relevant.
- 3. Park only an authorised vehicle (less than 5 tonnes).
- 4. Comply with the Conditions of Use, opposite.

Conditions of Use

- 1. No vehicle other than a, motor car, motor cycle, goods vehicle (the unladen weight of which does not exceed 5 tonnes), invalid carriage or electric vehicle shall be left in this car park.
- 2. No person shall use any part of this car park for any other purpose than authorized parking.
- 3. The council may close all or any part of this car park, on any occasion for any reason. When the car park or part thereof is closed no person shall cause or allow any unauthorized vehicle to wait or be left in that car park or part thereof for the duration of the closure.
- 4. The driver of a motor vehicle using this car park shall stop the engine as soon as the vehicle is in position in the parking place and shall not start the engine except when about to change the position of the vehicle in or to depart from the car park.
- 5. A vehicle must be parked wholly within a parking bay. In car parks where bay markings are not provided vehicles must not be parked on the circulatory route or so as to obstruct the free movement of other vehicles within the car park.
- 6. No person shall use the vehicle whilst it is in the parking place in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of his skill or service
- 7. Where there is a sign/surface marking within a car park which indicates that a parking place or part thereof is available only for a specific vehicle class, then the parking place may only be used by that class of vehicle.
- 8. Where within a car park there is a sign/surface marking which indicates that a parking place or part thereof is available for 'Loading Only' then it is reserved solely for loading/unloading by a vehicle described para 1 above but only for as long as is necessary for the purpose of loading or unloading to take place.
- 9. A motorcycle must be parked wholly within a designated motorcycle parking bay. In car parks where designated motorcycle bays are not provided motorcycles may park in a car parking bay. Vehicles must not be parked on the circulatory route or so as to obstruct the free movement of other vehicles within the car park.
- 10. Where there is a sign/surface marking on the highway or within a car park which indicates that a parking place or part thereof is available only for a disabled person's vehicle, the driver of a vehicle other than the driver of: (a) an invalid carriage;
- (b) a disabled person's vehicle left by the driver who is a person to whom there has been issued by any local authority a Disabled Person's Badge provided such a badge is displayed in a conspicuous position on the vehicle shall not cause or allow it to wait or park in that parking place or part thereof.
- 11. Where there is a sign/surface marking on the highway or within a car park which indicates that a parking place or part thereof is available only for electric vehicles' then it is reserved solely for electric vehicles whilst recharging. An electric vehicle shall only occupy a bay as long as it is necessary to recharge the vehicle and hence shall be clearly attached to the recharge post using the appropriate cable.
