You will be liable to a Penalty Charge if you do not:

- 1. Clearly display a ticket or permit valid for the duration of your stay.
- Comply with the maximum stay and no return conditions (except permit holders).
- Clearly display a valid blue badge if you park in a disabled bay.
- 4. Park wholly within a marked bay, where relevant.
- 5. Park only an authorised vehicle (less than 5 tonnes).
- 6. Comply with the Conditions of Use, opposite.

Conditions of Use

- No vehicle other than a, motor car, motor cycle, goods vehicle (the unladen weight of which does not exceed 5 tonnes), invalid carriage or electric vehicle shall be left in this car park.
- 2. No person shall use any part of this car park for any other purpose than authorized parking.
- 3. The council may close all or any part of this car park, on any occasion for any reason. When the car park or part thereof is closed no person shall cause or allow any unauthorized vehicle to wait or be left in that car park or part thereof for the duration of the closure.
- 4. The driver of a motor vehicle using this car park shall stop the engine as soon as the vehicle is in position in the parking place and shall not start the engine except when about to change the position of the vehicle in or to depart from the car park.
- 5. The driver of a motor vehicle using this car park or other person on his behalf shall obtain a ticket by paying the appropriate charge as specified on the tariff boards/ticket machines. The ticket obtained shall be displayed on the inside of the front windscreen of the vehicle so that it is facing forwards and can be clearly seen from the front of the vehicle. The ticket shall be displayed at all times that the vehicle is on park.
- 6. A vehicle must be parked wholly within a parking bay. In car parks where bay markings are not provided vehicles must not be parked on the circulatory route or so as to obstruct the free movement of other vehicles within the car park.

- 7. No person shall use the vehicle whilst it is in the parking place in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of his skill or service
- 8. Where there is a sign/surface marking within a car park which indicates that a parking place or part thereof is available only for a specific vehicle class, then the parking place may only be used by that class of vehicle.
- 9. Where within a car park there is a sign/surface marking which indicates that a parking place or part thereof is available for 'Loading Only' then it is reserved solely for loading/unloading by a vehicle described para 1 above but only for as long as is necessary for the purpose of loading or unloading to take place.
- 10. If at any time while a vehicle is left in a parking place no ticket or permit is displayed indicating the payment of the appropriate charge it shall be presumed, unless the contrary is proven, that the said charge has not been duly paid for the authorised vehicle.
- 11. Where the front or rear of a parked vehicle overhands an adjoining bay, a pay and display ticket must be purchased for each bay used.
- 12. Solo motorcycles are exempt from pay and display charges and from displaying a ticket during the free parking period.
- 13. A motorcycle must be parked wholly within a designated motorcycle parking bay. In car parks where designated motorcycle bays are not provided motorcycles may park in a car parking bay. Vehicles must not be parked on the circulatory route or so as to obstruct the free movement of other vehicles within the car park.

- 14. Electric vehicles are exempt from pay and display charges whilst the vehicle is being recharged.
- 15. Where there is a sign/surface marking on the highway or within a car park which indicates that a parking place or part thereof is available only for a disabled person's vehicle, the driver of a vehicle other than the driver of:
- (a) an invalid carriage;
- (b) a disabled person's vehicle left by the driver who is a person to whom there has been issued by any local authority a Disabled Person's Badge provided such a badge is displayed in a conspicuous position on the vehicle shall not cause or allow it to wait or park in that parking place or part thereof.
- 16. Where there is a sign/surface marking on the highway or within a car park which indicates that a parking place or part thereof is available only for electric vehicles' then it is reserved solely for electric vehicles whilst recharging. An electric vehicle shall only occupy a bay as long as it is necessary to recharge the vehicle and hence shall be clearly attached to the recharge post using the appropriate cable.
- 17. Rochdale Borough Council accepts no responsibility for injury to persons or loss or damage to vehicles parked in this car park or their contents unless such injury, loss or damage is caused by the negligence of Rochdale Borough Council or its employees.
