(AMENDMENT 1) ORDER 2020**

THE KENT COUNTY COUNCIL acting as local traffic authority and in exercise of its powers under sections 1(1), 2(1) to (3), 3(2), 4(1) to (3), 32(1), 35(1), 45, 46, 49, 53 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Road Traffic Regulation Act 1984, hereby makes the following Order.

AMENDMENTS

The Kent County Council (Various Roads, Borough of Ashford) (Waiting Restrictions and Street Parking Places) Consolidation Order 2020 (hereafter referred to as "the Principal Order") is hereby amended and shall have effect as though:

In the interpretation to the Principal Order

"Restricted Parking Zone" (or "RPZ")	is an area in which all the streets are subject to waiting restrictions other than lengths of road where parking places are designated, whether these parking places bear road markings or not
