

ASHFORD BOROUGH COUNCIL (OFF-STREET PARKING PLACES) (AMENDMENT No. 2) ORDER 2022

The Ashford Borough Council (hereinafter referred to as "the Council") in exercise of its powers under Section 32, 33 35, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act"), and section 43 and Schedule 3 of the Roads Traffic Act 1991 ("the 1991 Act") Part 6 of the Traffic management Act 2004 ("the 2004 Act") and of all other enabling powers, and with the consent of the Kent County Council given under section 39(3) of the Act and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order:-

COMMENCEMENT AND CITATION

A – This order may be cited as "The Ashford Borough Council (Off-Street Parking Places) (Amendment No. 2) Order 2022" ("this Order") and shall come into force on the 29th day of June 2022.

B – Ashford Borough Council (Off-Street Parking Places) Consolidation Order 2019 shall have effect as though -

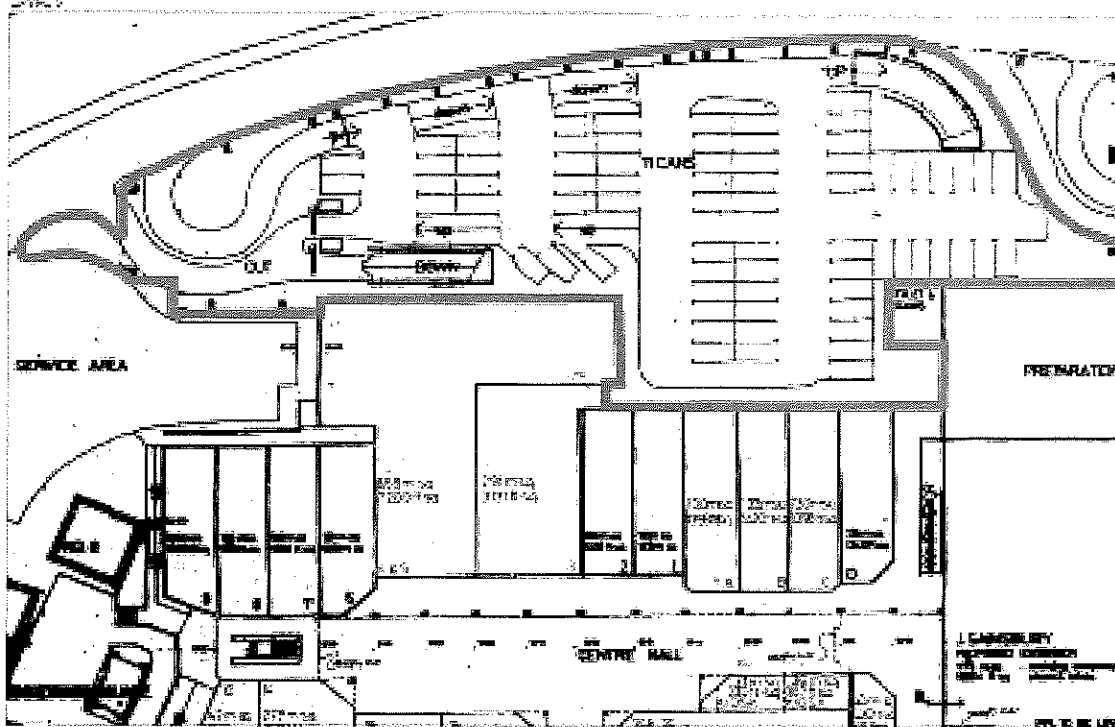
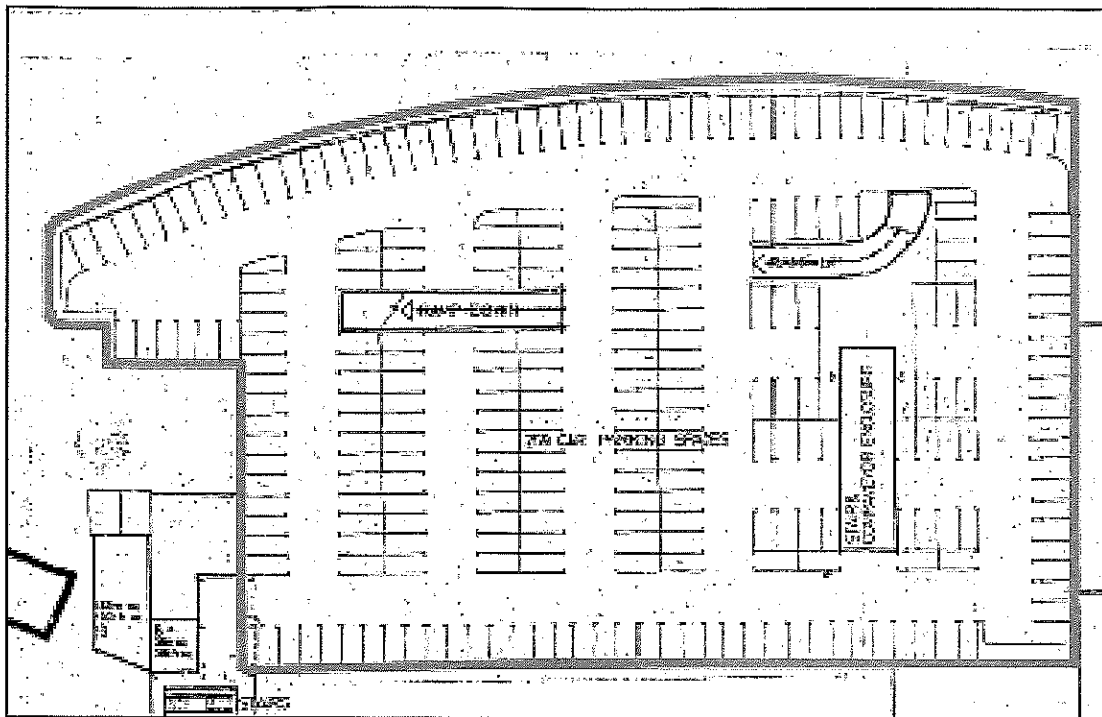
