ROAD TRAFFIC REGULATION ACT 1984

THE KENT COUNTY COUNCIL acting as the Local Traffic Authority and in exercise of its powers under Sections 1, 2, 32, 35, 36, 45, 46, 47, 49, 53, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ('the Act'), the Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

Citation and Commencement

This Order may be cited as "The Kent County Council (Various Roads, Borough of Ashford) (Waiting Restrictions and Street Parking Places) (Amendment No.10) Order 2021" ('this Order') and shall come into operation on the 2nd day of December 2022.

The Kent County Council (Various Roads, Borough of Ashford) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2020 ('the Consolidation Order') shall be modified to the extent identified in the Schedule to this Order.
