## **ROAD TRAFFIC REGULATION ACT 1984**

THE KENT COUNTY COUNCIL acting as the Local Traffic Authority and in exercise of its powers under Sections 1, 2, 32, 35, 36, 45, 46, 47, 49, 53 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ('the Act'), the Traffic Management Act 2004 and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

## **Revocations, Modifications and Amendments**

- 1. In this Order, the expression 'Order of 2020' means "The Kent County Council (Various Roads, Borough of Ashford) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2020" and all subsequent amendment Orders thereto;
- 2. The effect of this Order is to amend the Order of 2020 as follows:
  - The items specified in the Schedule 1 to this Order is hereby added to Appendix 12 – Mersham thereto

## Citation and Commencement

- 3. Section 5 of the Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- This Order may be cited as "The Kent County Council (Various Roads, Borough of Ashford) (Waiting Restrictions and Street Parking Places) (Amendment 11) Order 2021" ('this Order') and shall come into operation on the 17th day of March 2023.
