THE AYLESBURY VALE (OFF-STREET PARKING PLACES, AYLESBURY) ORDER 1999

Aylesbury Vale District Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 32, 33, 35, 35A, and Schedule 9 of the Road Traffic Regulation Act 1984 (as amended), and of all other enabling powers, and with the consent of Buckinghamshire County Council given under Section 39(3) of the said Act, and after consultation with the relevant Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act, hereby make the following Order:

PART I INTERPRETATION

- 1. This Order may be cited as the Aylesbury Vale (Off-Street Parking Places, Aylesbury) Order 1999.
- 2. In this Order except where the context otherwise requires the following words and expressions shall have the meanings hereby respectively assigned to them:-
 - "Bank Holiday" means the public holidays set out hereafter and any other day which may be designated as such in England: Christmas Day; Boxing Day; New Year's Day; Good Friday; Easter Monday; May Day; Spring Bank Holiday; Summer Bank Holiday;
 - "Chiltern Railways" means the Chiltern Railway Company Limited;
 - "Council" means the Aylesbury Vale District Council;
 - "Council officer" means any person employed by the Council under a contract of service, or any other person authorised in writing by the Council to perform the function concerned;
 - "disabled persons means any badge issued, or having effect as if issued, badge" under any regulations for the time being in force under Section 21 of the Chronically Sick and Disabled Persons Act 1970 (as amended) and of a form prescribed by those regulations;
 - "driver" in relation to a vehicle waiting in a parking place, means the person driving the vehicle at the time it was left in the parking place, but for the purposes of this Order and any legal proceedings taken thereunder if on the date a vehicle is left in a parking place a person is shown to have

been the registered keeper thereof by notification from the Driver Vehicle Licensing Agency or other appropriate registration authority, that person shall be deemed to have been the driver of the vehicle on that date unless the contrary is shown;

- "owner" means the person by whom a vehicle is kept and used and in relation to a vehicle which is subject to a lease, hiring agreement or hire-purchase agreement, means the person in possession of the vehicle under that agreement;
- "parking bay" means an area of land within a parking place which is delineated or indicated by markings and/or writing on the surface of the parking place, and/or signs bcated on or adjacent to the area of land concerned;
- "Parking Permit" means a permit or ticket issued pursuant to Article 18 or 19, as the case may be;
- "parking place" means any area of land (including any buildings thereon) provided by the Council for use as a parking place pursuant to Sections 32 and 33 of the Road Traffic Regulation Act 1984 (as amended), and which is identified by name in Column 1 of Schedule 1;
- "Rail Bays" means those parking bays to which reference is made in Article 11(1);
- "Rail Parking Ticket" means a ticket or permit issued by Chiltern Railways in accordance with Article 11(2) permitting the holder to park a vehicle in the Rail Bays;
- "Shopmobility means those parking bays to which reference is made in Article 12(1);
- "Shopmobility means a permit issued by the Council for the use of the Permit" Shopmobility bays.
- 3. In this Order:
 - (1) a reference to any Act of Parliament, or to any Statutory Instrument, Order or Regulation made thereunder shall include a reference to any amendment or re-enactment of the same;
 - (2) words importing the masculine gender include the feminine gender, words in the singular include the plural and vice versa and words importing individuals shall be treated as importing corporations and vice versa;

- (3) headings are for ease of reference only and shall not affect construction;
- (4) references to Articles and Schedules are to the Articles and Schedules respectively of this Order.

PART II MAKING OF THIS ORDER AND REVOCATION OF FORMER ORDER

- 4. This Order shall come into effect on 10th January 2000.
- 5. (1) the Aylesbury Vale (Off-Street Parking Places, Aylesbury) Order 1998 and the Aylesbury Vale (Off-Street Parking Places, Aylesbury) (Variation No 2) Order 1998 (hereinafter jointly and severally referred to as "the 1998 Orders") shall be revoked with effect from the date upon which this Order comes into effect.
 - (2) Nothing in this Order shall (or shall be deemed to):
 - (a) waive or excuse, or otherwise prevent the commencement or disposition of any proceedings for an offence under the 1998 Orders, or
 - (b) affect the validity, or prevent or prohibit the collection, of any charge (including any excess charge) which is or has become due and payable under the terms of the 1998 Orders,

in respect of the use of any parking place which is the subject of the 1998 Orders at any time prior to the date upon which this Order takes effect.

PART III USE OF PARKING PLACES

- 6. SUBJECT TO the following provisions of this Order, each parking place identified by name in Column 1 of Schedule 1 may be used as a place for the parking of such classes of vehicles in such positions and on such days and during such hours and on payment of such charges as are specified in relation to that parking place in Schedule 1.
- 7. Where in Schedule 1 a parking place is described as available for vehicles of a specified class, the driver of a vehicle shall not permit it to wait in that parking place unless it is of the specified class.
- 8. Subject to Articles 9 and 15, the driver of a vehicle making use of a parking place shall ensure that he leaves his vehicle within a parking bay.

- 9. Subject to Article 15:
 - (1) where the location(s) at which vehicles are to be parked within a parking place (or part of a parking place) are defined by parking bays, the driver of a vehicle making use of the part or parts of that parking place containing parking bays shall ensure that he permits his vehicle to wait wholly within the defined boundaries of a parking bay.
 - (2) where there are no parking bays within a parking place (or part of a parking place) the driver of a vehicle making use of that parking place (or of the part concerned) shall not permit it to wait other than in such position as may reasonably be specified by a Council officer.
- 10. The driver of a vehicle shall not permit it to wait within a parking place in such a manner as to prevent or hinder other persons or vehicles from obtaining access to the parking place or to any parking bay therein.
- 11. (1) Ten parking bays situated on level 1 of the Friarscroft Multi-storey Car Park are reserved for the exclusive use of persons who are authorised by Chiltern Railways to park their vehicles in those parking bays, and who duly display valid Rail Parking Tickets in accordance with the provisions of this Order. The parking bays concerned are identified by signs or markings stating "Chiltern Railways Reserved", or other appropriate words of identification.
 - (2) Any Rail Parking Ticket issued by Chiltern Railways authorising a person to park a vehicle in the Rail Bays shall only be valid for use of the Rail Bays, and only for such periods and upon such other terms (subject to the provisions of this Order) as are specified by Chiltern Railways.
 - (3) A Rail Parking Ticket shall only permit the holder to park a vehicle in the Rail Bays, and irrespective of the number of Rail Parking Tickets that are or may be concurrently issued by Chiltern Railways, no Rail Parking Ticket shall be valid at any time whatsoever in respect of any other parking place or parking bay.
- 12. (1) Ten parking bays situated on the ground floor of the Civic Centre Multistorey Car Park are reserved for the exclusive use of persons who are authorised by the Council to park their vehicles in those parking bays, and who duly display valid Shopmobility Permits in accordance with the provisions of this Order. The parking bays concerned are identified by signs or markings stating "Shopmobility reserved", or other appropriate words of identification.
 - (2) An application for a Shopmobility Permit permitting the holder to use the Shopmobility bays shall be made to the Council at the Shopmobility office in the Civic Centre Multi-storey Car Park or at such other office as the Council shall determine, and any Shopmobility Permit issued by the Council in response to such an application shall only be valid for use of

the Shopmobility bays and only for such periods and upon such other terms (subject to the provisions of the Order) as are specified by the Council.

(3) A Shopmobility Permit shall only permit the holder to park a vehicle in the Shopmobility bays, and irrespective of the number of Shopmobility permits that are or may be concurrently issued by the Council, no Shopmobility Permit shall be valid at any time whatsoever in respect of any other parking place or parking bay.

PART IV CHARGES

- 13. Subject to Articles 14 and 15, the driver of a vehicle proposing to use a parking place or a parking bay therein shall on entering the parking place pay the appropriate charge in accordance with the scale of charges specified in Column 6 of Schedule 1, by means of the purchase of an appropriately priced ticket or tickets according to the proposed period of parking, and where a charge is specified for a period the whole of that charge shall be due and payable for use of the parking place for any part of that period, PROVIDED THAT no charge shall be payable:
 - (1) in the case of all parking places:
 - (a) in respect of their use for the parking of a vehicle on a Sunday or Bank Holiday (other than in those instances where the parking place concerned is identified in Column 3 of Schedule 1 as not being available for use on Sundays and Bank Holidays), or
 - (b) in respect of their use for the parking of a vehicle where the driver of the vehicle concerned is the holder of a disabled persons badge, and duly displays the same on the vehicle in accordance with Article 22;
 - (2) by the driver of a vehicle left in a parking place who displays a valid Parking Permit permitting the parking of a vehicle in that parking place in accordance with the provisions of Article 20;
 - (3) in respect of the Rail Bays, by the driver of a vehicle left therein who displays a valid Rail Parking Ticket in accordance with the provisions of Articles 11 and 22;
 - (4) in the case of the Shopmobility bays, by the driver of a vehicle left therein who displays a valid Shopmobility Permit in accordance with the provisions of Articles 12 and 22.

- 14. The driver of a vehicle proposing to use:
 - (1) a parking bay in a parking place where there is a sign, surface marking or other marking or writing which indicates that the parking bay concerned is reserved for use by drivers of vehicles who hold and display a disabled persons badge, or
 - (2) any of the Rail Bays where the driver does not hold and display a valid Rail Parking Ticket, or
 - (3) any of the Shopmobility bays where the driver does not display a valid Shopmobility Permit

shall on entering that parking bay pay a charge of £10.00 (inclusive of Value Added Tax) for each hour of parking in that parking bay by means of the purchase of an appropriately priced ticket or tickets (and the whole of that charge shall be due and payable for use of that parking bay for any part of any hour) PROVIDED THAT no charge shall be payable:

- (a) in respect of the use of a parking bay reserved for use by drivers of vehicles who hold and display disabled parking badges, by the holder of a disabled persons badge who duly displays such a badge on the vehicle concerned in accordance with Article 22, and
- (b) in respect of the Rail Bays, by the driver of a vehicle left therein who holds and displays a valid Rail Parking Ticket in accordance with the provisions of Articles 11 and 22, and
- (c) in respect of the Shopmobility bays, by the driver of a vehicle left therein who displays a valid Shopmobility Permit in accordance with Articles 12 and 22.
- 15. Where:
 - (1) the location(s) at which vehicles are to be parked within a parking place (or part of a parking place) are defined by parking bays, and the driver of a vehicle permits his vehicle to wait wholly or partially outside the defined boundaries of a parking bay, or
 - (2) there are no parking bays within a parking place (or part of a parking place) and the driver of a vehicle permits his vehicle to wait other than in such a position as is reasonably specified by a Council officer

he shall pay a charge of £10.00 (inclusive of Value Added Tax) for each hour of such parking, by means of the purchase of an appropriately priced ticket or tickets (and the whole of that charge shall be due and payable for such parking for any part of any hour).

- 16. The driver of a vehicle shall not permit it to wait:
 - (1) in a parking bay or parking place for longer than the maximum period for which prior payment has been made for waiting in that parking bay or parking place (as specified in Schedule 1 or Articles 14 or 15 (as appropriate) or, in respect of the Rail Bays, by Chiltern Railways), or
 - (2) in the Hampden House Underground Car Park or Canalside (rear) Car Park outside of the days and hours of operation specified in relation to that parking place in Column 3 of Schedule 1, and shall pay to the Council on demand a charge of £50.00 (inclusive of Value Added Tax) to release any vehicle parked in either of the said parking places in contravention of this Article 16(2).

PART V METHOD OF PAYMENT OF CHARGES

- 17. The charge to which reference is made in Articles 13, 14 and 15, shall be payable by the insertion of a coin or coins of an appropriate value into the apparatus or device provided for such purpose at each parking place.
- 18. Save in relation to those classes of vehicle and parking places described in Items 7(2), 12(2), and 13 of Schedule 1, the owner of a vehicle may on application to the Council purchase a Parking Permit which shall be valid in such parking places (or where appropriate, in such parking bays in such parking places) as shall be specified by the Council from time to time during the period for which it is issued. The charge for such a Parking Permit shall be ascertained by reference to the location of the parking place and/or parking bay in respect of whose use it is issued, and the scale of charges for such a Parking Permit set out in Schedule 1.
- 19. The owner of a vehicle who is a residential occupier of a property whose postal address falls within one of the streets or the buildings in Aylesbury to which reference is made in Schedule 2 may on application to the Council purchase an annual Parking Permit for a concessionary charge of £80.00 (inclusive of Value Added Tax) (reduced pro rata for any period of less than 12 months), and that Parking Permit shall be valid in such parking places (or where appropriate, in such parking bays in such parking places) as shall be specified by the Council from time to time during the period for which it is issued.

PART VI DISPLAY OF TICKETS, DISABLED PERSONS BADGES AND SHOPMOBILITY PERMITS

20. Any ticket or tickets issued on payment of a charge to which reference is made in Article 13, and any Parking Permit shall be attached by the driver in a conspicuous position on the front windscreen of the vehicle (or in the case of a vehicle having no front windscreen in a conspicuous position on the body of the vehicle) in respect of which it was issued, and such ticket or Parking Permit shall be exhibited in that position at all times while the vehicle is parked in a parking place. The ticket or Parking Permit shall be so placed that the details shown on the front of the ticket or Permit are clearly visible to persons standing outside the vehicle.

- 21. Any ticket or tickets issued on payment of a charge to which reference is made in Articles 14 or 15 shall be attached by the driver in a conspicuous position on the front windscreen of the vehicle (or in the case of a vehicle having no front windscreen, in a conspicuous position on the body of the vehicle) in respect of which it was issued, and such ticket shall be exhibited in that position at all times while the vehicle is parked in the parking place. The ticket shall be so placed that the details shown on the front of the ticket are clearly visible to persons standing outside the vehicle.
- 22. Any disabled persons badge or Shopmobility Permit, and in the case of the Rail Bays any Rail Parking Ticket which is required to be displayed by the driver of a vehicle under the provisions of this Order shall be attached by the driver either in a conspicuous position on the front windscreen of the vehicle, or in such a position immediately behind the front windscreen of the vehicle as to permit it to be seen without difficulty from outside the vehicle, or in the case of a vehicle having no front windscreen, in a conspicuous position on the body of the vehicle, and such badge, Permit or Ticket (as the case may be) shall be exhibited in that position at all times while the vehicle is parked in the parking place. In any such case, the badge, Permit or Ticket shall be so placed that the details shown on its face are clearly visible to persons standing outside the vehicle.

PART VII EXCESS CHARGES

- 23. Notwithstanding and without prejudice to the provisions of Article 44, and subject to the provisions of Article 24, if at any time:
 - (1) a valid ticket or Parking Permit is not displayed in accordance with Article 20 on any vehicle left in a parking place, or
 - (2) a vehicle is left in a parking place for longer than the period for which advance payment has been made,

the driver shall pay to the Council on demand an excess charge of £35.00 (inclusive of Value Added Tax), PROVIDED THAT the Council shall accept the sum of £20.00 (inclusive of Value Added Tax) in settlement in lieu of the sum of £35.00, subject to the reduced amount being actually received by the Council before the expiration of 10 days from the happening of the event giving rise to the obligation to make payment of the standard charge (and for the avoidance of doubt the day of commission of the breach of the terms of this Order shall be taken into account in calculating that period of 10 days).

- 24. Notwithstanding and without prejudice to the provisions of Article 44, if at any time:
 - (1) a valid ticket is not displayed on a vehicle in accordance with Article 21, or
 - (2) a vehicle is left in a parking place in the circumstances specified in either Article 14 or Article 15 for longer than the period for which advance payment has been made,

the driver shall pay to the Council on demand an excess charge of £50.00 (inclusive of Value Added Tax), PROVIDED THAT the Council shall accept the sum of £35.00 (inclusive of Value Added Tax) in settlement in lieu of the sum of £50.00, subject to the reduced amount being actually received by the Council before the expiration of 10 days from the happening of the event giving rise to the obligation to make payment of the standard charge (and for the avoidance of doubt the day of commission of the breach of the terms of this Order shall be taken into account in calculating that period of 10 days).

25. A demand for payment of the excess charge specified in either Article 23 or Article 24 may be made in such form as may from time to time be considered appropriate by the Council, and may be issued by any Council Officer.

PART VIII USE OF PARKING PLACES

- 26. The driver of a vehicle using a parking place shall stop the engine as soon as the vehicle is in position in a parking bay or such location in the parking place as has been specified to him pursuant to the provisions of Article 9(2), and shall not start the engine except when about to change the position of the vehicle in, or to depart from, the parking place.
- 27. No person shall except with the permission of a Council Officer drive any vehicle in a parking place other than for the purpose of leaving that vehicle in the parking place in accordance with the provisions of this Order, or for the purpose of departing from the parking place.
- 28. Where in a parking place signs are erected, or surface or other markings are laid for the purpose of:
 - (1) indicating the entrance to, or exit from, the parking place, or
 - (2) indicating that a vehicle using the parking place shall proceed in a specified direction within the parking place,

no person shall drive or cause to permit to be driven any vehicle

- (a) so that it enters the parking place otherwise than by an entrance or leaves the parking place otherwise than by an exit so indicated, or
- (b) in a direction other than that specified,

as the case may be.

- 29. No person shall use any part of a parking place:
 - (1) as a means of proceeding by vehicle between one highway and another (whether any such highway shall be maintainable at the public expense or otherwise), or
 - (2) save with the prior written consent of the Council, as a means of vehicular access to any premises adjoining the parking place.
- 30. No person shall:
 - ride or otherwise use any bicycle in any parking place save for the purposes of obtaining access to any area allocated by the Council for the parking of bicycles within that parking place;
 - (2) leave any bicycle in any parking place, other than in any area allocated by the Council for the parking of bicycles within that parking place,

and in either case only during the days and hours of operation of the parking place concerned, as specified in Schedule 1.

- 31. No person shall in any parking place:
 - (1) by shouting or singing,
 - (2) by playing on a musical instrument, or
 - (3) by operating or permitting to be operated, any radio, gramophone, amplifier, tape recorder, compact disc player or similar instrument

cause or permit to be made any noise which is so loud or so continuous or repeated as would in the opinion of a Council officer give reasonable cause for annoyance to other persons in or adjacent to the parking place.

- 32. No person shall in a parking place:
 - (1) use any threatening, abusive or insulting language, gesture or conduct with intent to put any person in fear, or so as to occasion a breach of the peace or whereby a breach of the peace is likely to be occasioned, or
 - (2) throw or discharge any missile to the danger or annoyance of any other person in or adjacent to the parking place.

- 33. No person shall, without the prior written consent of the Council, hold or take part in any display, public show, performance or exhibition in a parking place, or place any vehicle or equipment in a parking place in connection with the same.
- 34. No person shall, without reasonable excuse, climb any wall or fence in or enclosing a parking place, or any tree, barrier, railing, post or other structure in a parking place.
- 35. No person shall wilfully damage or deface:
 - (1) any wall, fence, barrier, railing, post or other structure or surface,
 - (2) any vehicle, plant, equipment or apparatus, or
 - (3) any tree, bush, shrub or other soft landscaping

in a parking place.

- 36. No person shall use any part of a parking place or any vehicle left in a parking place:
 - (1) for sleeping or camping purposes, or
 - (2) for eating or cooking purposes, or
 - (3) save with the consent of the Council (which may be given upon such terms (including terms as to payment) as it considers to be appropriate):
 - (a) for the purpose of washing any vehicle, or
 - (b) for the purpose of servicing any vehicle or part thereof (other than as may be reasonably necessary to enable that vehicle to depart from the parking place).
- 37. No person shall in a parking place:
 - (1) skate or use any skateboard or similar mechanical device, or
 - (2) play or take part in any ball game.
- 38. No person shall:
 - (1) use a vehicle while it is in a parking place, or
 - (2) use any part of a parking place

for or in connection with the sale of any article to persons in or near the parking place, or for or in connection with the selling or offering for hire of his skill or services.

- 39. No person shall:
 - (1) use a parking place for the purpose of displaying or distributing advertising material, or
 - (2) place any advertising material on any vehicle left in a parking bay or parking place,

save with the prior written consent of the Council, and in the case of (2) above, unless the express prior written consent of the vehicle owner has also been obtained.

- 40. No person shall in a parking place:
 - (1) erect or cause or permit to be erected any tent, booth, stand, building or other structure without the prior written consent of the Council, or
 - (2) light or cause or permit to be lit any fire.
- 41. No person shall in a parking place:
 - (1) intentionally obstruct any Council Officer in the proper execution of his duties, or
 - (2) intentionally obstruct any person carrying out any act which is necessary to the proper execution of, or authorised by, any contract with the Council, or
 - (3) intentionally obstruct any other person in the proper use of the parking place, or behave in such a manner as would in the opinion of a Council officer give reasonable cause for annoyance to other persons in or adjacent to the parking place.
- 42. The driver of a vehicle using a parking place shall not sound any horn or other similar instrument except when about to change the position of the vehicle in, or to depart from, the parking place.
- 43. No person shall in a parking place cause or permit to be emitted from a vehicle (whether continuously or intermittently) any noise originating from any fitment or alarm on the vehicle, to the disturbance or annoyance of users of the parking place or occupiers of premises in the neighbourhood, save that this Article shall not be deemed to have been breached if any fitment or alarm on the vehicle shall have been activated by any unauthorised person improperly tampering with the vehicle (but such unauthorised activation of the fitment or alarm shall not prohibit or prevent a Council officer arranging removal of the vehicle under Article 44 or in the alternative making arrangements for that fitment or alarm to be rendered inoperable or silenced);

PART IX REMOVAL OF VEHICLES

- 44. When a vehicle is left in a parking bay or parking place in contravention of any of the provisions of Articles 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 23, 24, 33, 36, 38, 43 or 50 a Council officer may remove the vehicle or arrange for it to be removed from that parking place, PROVIDED THAT when a vehicle is waiting in a parking place in contravention of the provisions of Articles 7, 8, 9 or 10 the Council officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with the relevant provision.
- 45. Any person removing or altering the position of a vehicle by virtue of Article 44 may do so by towing or driving the vehicle or in such other manner as he may think necessary and may take such measures in relation to the vehicle as he may think necessary to enable him to remove it or alter its position as the case may be.
- 46. When a Council officer removes or makes arrangements for the removal of a vehicle from a parking bay or parking place by virtue of Article 44 he shall make such arrangements as he considers to be reasonably necessary for the safe custody of the vehicle, but subject thereto, neither he nor the Council shall be liable for any damage, costs, losses or other liabilities arising out of, in the course of, or in connection with the exercise of any of the powers contained in this Article and/or Articles 44 and 45 (save where the same arise directly or indirectly from the injury or death of any person, or loss or damage to any property (other than the vehicle concerned and the contents thereof) caused by the negligence of any Council officer or any person exercising the powers conferred by Article 45).

PART X

SUSPENSION OF USE OF PARKING BAYS AND/OR PARKING PLACES

- 47. A Council officer may suspend the use of a parking place or any parking bay or parking bays therein or of any part thereof whenever he considers such suspension reasonably necessary and for whatsoever period he considers reasonable:
 - (1) for the purpose of any building operating, demolition or excavation in or over or under or adjacent to the parking place or parking bay concerned or the maintenance, improvement or reconstruction of the parking place or parking bay or the laying, erection, alteration, removal or repair in or adjacent to the parking place or parking bay of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunication system or traffic sign PROVIDED THAT in respect of any of the Rail Bays 7 days notice (except in case of emergency) shall have been given by the Council to Chiltern Railways of its intention to suspend the use of the Rail Bay(s) concerned, or

- (2) on any occasion on which it is likely that the parking place or parking bay will be required for the exclusive use of specific individual groups or for the parking of a particular class or classes of vehicle, or
- (3) for the purpose of holding any display, public show, performance or exhibition authorised by the Council (or any authorised officer thereof) and for activities subsidiary thereto, or
- (4) for such other purposes as may be authorised by the Council or any authorised officer thereof

PROVIDED THAT a suspension for the purposes set out in Articles 47(2) and (3) shall not apply to the Rail Bays, and may only be effected under the provisions of Article 47(4) after consultation with an appropriate officer of Chiltern Railways.

- 48. A police constable in uniform may suspend for not longer than twenty-four hours the use of a parking place or parking bay or any part thereof whenever he considers such suspension reasonably necessary.
- 49. Any person suspending the use of a parking place or parking bay or any part thereof in accordance with the provisions of Articles 47 or 48 shall thereupon place or cause to be placed in or adjacent to that parking place or parking bay, or the part thereof the use of which is suspended, a sign or notice indicating that waiting by vehicles therein is prohibited.
- 50. No person shall cause or permit a vehicle to be parked in any parking bay, parking place or part of a parking place during such period as there is in or adjacent to that parking bay, parking place or part of a parking place a sign or notice placed in pursuance of Article 49, provided that nothing in this Article shall render it unlawful to cause or permit any vehicle being used for emergency purposes by the Fire Brigade, Ambulance Service, Police or armed services of the Crown to be parked in the parking bay, parking place or part of a parking place concerned during any such period or to cause or permit any other vehicle to be so parked if that vehicle is parked with the permission:
 - (1) of the person suspending the use of the parking bay, parking place or part thereof in pursuance of Article 47, or
 - (2) of a police constable in uniform.

PART XI PROCEEDINGS

51. In any proceedings for an offence under this Order the provisions of Sections 47 (4) and (6) of the Road Traffic Regulation Act 1984 (as amended) apply.
