AYLESBURY VALE (OFF-STREET PARKING PLACES, BUCKINGHAM) ORDER 1999

The Aylesbury Vale District Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 32, 33, 35, 35A and Schedule 9 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic Regulation Act 1991) (hereinafter referred to as "the Act") and all other enabling powers, and with the consent of Buckinghamshire County Council given under Section 39(3) of the Act, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

<u>PART I</u> <u>INTERPRETATION</u>

- 1. This Order shall come into operation on 15th September 1999, and may be cited as the Aylesbury Vale (Off-Street Parking Places, Buckingham) Order 1999.
- 2. The Aylesbury Vale (Off-Street Parking Places, Buckingham) Order 1998 (hereafter referred to as "the Principal Order") is hereby varied in the manner and to the extent hereinafter appearing.
- 3. In this Order, save where the context otherwise requires:
 - (1) any reference to a numbered Article is a reference to the article bearing that number in this Order:
 - (2) other words and expressions shall have the meanings respectively assigned to them in the Principal Order.

PART II USE OF LAND AND PARKING PLACES

- 5. The area of land located immediately adjacent to the eastern boundary of the Cornwalls Meadow, Buckingham (west side) Parking Place (Parking Place reference no. 1 in Schedule 1 to the Principal Order) and shown hatched black on the plan annexed to this Order shall be removed from the said Parking Place and included within the Cornwalls Meadow, Buckingham (east side) Parking Place (Parking Place reference no. 2 in Schedule 1 to the Principal Order) with effect from the date upon which this Order comes into effect, and may henceforth be used as a place for the parking of such classes of vehicles in such positions and on such days and during such hours and on payment of such charges as are specified in relation to the latter parking place in Schedule 1 to the Principal Order.
- 6. The Principal Order is hereby varied to the extent and in the manner specified in Article 5 of this Order.
