THE AYLESBURY VALE (OFF-STREET PARKING PLACES, AYLESBURY) (VARIATION No1) ORDER 2000

The Aylesbury Vale District Council (hereinafter referred to as "the Council" in exercise of their powers under Sections 32, 35, 35A, and 35C and Schedule 9 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic Regulation Act 1991) (hereinafter referred to as "the Act") and all other enabling powers, and with the consent of Buckinghamshire County Council given under Section 39(3) of the Act, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

PART I INTERPRETATION

- 1. This Order shall come into operation on 3rd April 2000, and may be cited as the Aylesbury Vale (Off-Street Parking Places, Aylesbury) (Variation No 1) Order 2000.
- 2. The Aylesbury Vale (Off-Street Parking Places, Aylesbury) Order 1999 (hereafter referred to as "the Principal Order") is hereby varied in the manner and to the extent hereinafter appearing.
- 3. In this Order, save where the context otherwise requires:
 - (1) any reference to a numbered Article is a reference to the article bearing that number in this Order;
 - (2) other expressions shall have the meanings respectively assigned to them in the Principal Order.

<u>PART II</u> <u>METHOD OF PAYMENT OF CHARGES</u>

- 4. The Principal Order is varied by the addition of the following Articles:
 - 19A. (1) Persons who are employed at business premises located in the town centre area may on application to the Council purchase an annual Town Centre Employee Permit for a concessionary charge of £450 (inclusive of Value Added Tax) (reduced pro rata for any period of less than 12 months);
 - (2) A Town Centre Employee Permit shall only be valid in relation to such classes of vehicle and for use in such parking places (or where appropriate, in such parking bays in such parking places) as shall be specified by the Council from time to time during the period for which it is issued.

- (3) For the purposes of this Article business premises shall be treated as falling within the 'town centre area' if they are within the area encompassed by the Aylesbury inner ring road, namely that bounded by the following highways:
 - Friarage Road (north side);
 - Exchange Street (north-west side);
 - Vale Park Drive (part) (north-west side);
 - Upper Hundreds Way (south side);
 - New Street (south side);
 - Oxford Road between its junctions with New Street and Friarage Road (south-east side).
- (4) Application for a Town Centre Employee Permit shall:
 - (a) be made in writing by the employee intending to use the same; and
 - (b) be supported by such evidence as to his eligibility as shall from time to time be specified by the Council.
- (5) A Town Centre Employee Permit shall:
 - (a) only be issued to the employee intending to use the same; and
 - (b) shall not be transferable (save upon a change in the vehicle used by that employee).
- (6) The Council's decision as to whether:
 - (a) any premises are 'business premises', or fall within the 'town centre area' for the purposes of this Article, or
 - (b) as to whether it is satisfied as to the eligibility of any person to receive a Town Centre Employee Permit

shall be final.

5. The Principal Order is further varied by the following consequential or additional changes:

Article 2

The definition of "Parking Permit" shall be amended to read as follows:

"means a permit or ticket issued pursuant to Articles 18, 19 or 19A, as the case may be;"

Article 18

The reference to Article 7(2) in this Article shall be deleted and replaced by a reference to Article 10(2).

- 6. Nothing in this Order shall:
 - (i) waive or excuse, or otherwise prevent the commencement or disposition of any proceedings for an offence under the Principal Order, or
 - (ii) affect the validity, or prevent or prohibit the collection, of any charge (including any excess charge) which is or has become due and payable under the terms of the Principal Order

in respect of the use of any Parking Place at any time prior to the date upon which this Order takes effect (or be deemed so to do).

7. The Principal Order is hereby varied to the extent and in the manner specified in Articles 4 and 5 and subject to Article 6 of this Order.
