Buckinghamshire County Council, in exercise of the powers conferred under Sections 1, 2, 4, 32, 35, 35A, 36, 39 45, 46, 46A, 47, 49, 51 and 53, 63A, 65, 66, 67, 68, 69, 70, 71, 101, 102, 116 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and all other enabling powers and having regard to Section 122 of that Act and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to that Act and in accordance with The Road Traffic (Permitted Parking Area and Special Parking Area)(County of Buckinghamshire)(District of Aylesbury Vale) Order 2003, hereby make the following Order.

In accordance with the provisions of Section 37 of the Road Traffic Regulation Act 1984, this Order forms part of a general scheme of traffic control whose boundary is the outer boundary of the area designated by The Road Traffic (Permitted Parking Area and Special Parking Area)(County of Buckinghamshire)(District of Aylesbury Vale) Order 2003.

Citation And Commencement

This Order shall come into force on 2nd October 2003 and may be cited as "The Buckinghamshire County Council (Aylesbury) (Controlled Parking Zone) Order 2003".

Definitions And Interpretation

2 (1) In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them: -

"1984 Act" means the Road Traffic Regulation Act 1984;

"1991 Act" means the Road Traffic Act 1991;

"Authorised Taxi Rank" means any area which is comprised within and indicated by a road marking complying with diagram 1028.2 of the Traffic Signs Regulations;

"Bus Stop Area" means any length of road specified in this Order, which is indicated, by a road marking complying with the appropriate diagram in Schedule 6 of the Traffic Signs Regulations;

"Carer Permit" means a carer permit issued under the provisions of Article 38;

"Carer Permit Holder" means a person to whom a Carer Permit has been issued:

"Controlled Hours" means the hours specified in Schedules 2 to 9 inclusive;

"Controlled Parking Zone" means an area comprising all of the roads or parts of roads or streets or parts of streets described in Schedule 1 to this Order; and the boundaries of which are indicated by traffic signs of a kind shown in diagram 663 of the Traffic Signs Regulations;

"Controlled Street" means any of the streets or roads, lengths of street or road or sides of a street or road, including all carriageways, Footways, Verges, vehicular crossings, reservations and cycle tracks and lay-bys within any such street or road within the Controlled Parking Zone;

"Council" means Buckinghamshire County Council or any person authorised on its behalf;

"Disabled Person's Badge" has the meaning given by Section 142 of the 1984 Act;

"Disabled Person's Vehicle" has the meaning given by Section 142 of the 1984 Act;

"Discretionary Permit" means a permit issued by the Council under the provisions of Article 47;

"Discretionary Permit Holder" means a person who has been issued with a Discretionary Permit;

"Footway" has the same meaning given by Section 329 of the Highways Act 1980;

"Goods" means goods of any kind whether animate or inanimate and includes postal packets of any description and the restocking of vending machines; and "delivering" and "collecting" in relation to any goods includes checking the goods for the purpose of their delivery or collection;

"Goods Vehicle" means a Motor Vehicle, the overall height of which does not exceed 2.8 metres and the overall length of which does not exceed 5.3 metres, constructed or adapted for use for the carriage or haulage of goods or burden of any description, and having no more than four wheels and shall exclude trailers or caravans:

"Hackney Carriage" means a licensed taxi as defined by Section 13(3) of the Transport Act 1985;

"Household" means either one person living alone or a group of people (who may or may not be related) living or staying at the same postal address, with common housekeeping;

"Motor Cycle" has the same meaning given by Section 136 of the 1984 Act;

"Motor Vehicle" has the same meaning given by Section 136 of the 1984 Act;

"Obstruction" in relation to the parking of a vehicle, means a parking position that prevents free flow of traffic along the carriageway, footway or cycleway, access to the carriageway or egress from the carriageway;

"Operational Date" means the date upon which this Order shall come into force as specified in Article 1;

"Owner" in relation to a vehicle, means the person by whom such vehicle is kept and used;

"Parking Attendant" means a person authorised by or on behalf of the Council to supervise and enforce the restrictions imposed by this Order;

"Parking Attendant Signature" means the signature recognised by the Council as that of a Parking Attendant to be used to sign a Penalty Charge Notice;

"Parking Disc" has the meaning given by Regulation 8(5) of the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;

"Parking Place" means any area of a Controlled Street designated as a parking place by this Order;

"Parking Space" means a part of the Parking Place, which is provided for the leaving of a vehicle;

"Parking Zone" means the roads and parts of roads comprised within in each of Schedule 2 to 9 inclusive;

"Passenger Vehicle" means a Motor Vehicle (other than a Motor Cycle or invalid carriage) constructed or adapted solely for the carriage of not more than twelve passengers (exclusive of the driver) and their effects and not drawing a trailer:

"Penalty Charge Notice" means a notice issued by a Parking Attendant to a vehicle parked in contravention of the provisions of this Order;

"Permit" means a permit issued by the Council under the provisions of this Order:

"Professional Carer" means a person as may be defined from time to time by the Council:

"Public Service Vehicle" has the same meaning as in the Public Passenger Vehicles Act 1981;

"Relevant Position" means in respect of:

- (a) a Disabled Person's Badge issued before 1 April 2000:-
 - (i) the badge is exhibited on the dashboard or fascia panel of the vehicle; or
 - (ii) in the case of a vehicle not fitted with a dashboard or fascia panel, the badge is exhibited in a conspicuous position on the vehicle,

so that Part 1 of the badge is clearly legible from the outside of the vehicle.

- (b) a Disabled Person's Badge issued on or after 1 April 2000:-
 - (i) the badge is exhibited on the dashboard or fascia of the vehicle; or

(ii) in the case of a vehicle not fitted with a dashboard or fascia panel the badge is exhibited in a conspicuous position on the vehicle,

so that the front of the badge is clearly legible from the outside of the vehicle.

- (c) a Valid Permit or Valid Resident Visitor Voucher if:-
 - (i) in the case of a vehicle fitted with a front windscreen on the near side of and immediately behind the windscreen in a position so as to allow the details on the obverse face to be legible from outside the vehicle; or
 - (ii) in the case of a vehicle not fitted with a front windscreen the Permit is exhibited in a conspicuous position so as to allow the details on the obverse face to be legible from outside the vehicle.

"Resident" means a person whose usual place of abode is at premises the postal address of which is in any street or part of any street described in the First Part of Schedules 2 to 9 inclusive:

"Resident Permit" means a Permit issued under the provisions of Article 29;

"Resident Permit Holder" means a person to whom a Resident Permit has been issued:

"Resident Visitor" means a person who parks a Motor Vehicle or Motorcycle in a Parking Place whilst visiting a Resident and who has obtained a Resident Visitor Voucher from the said Resident;

"Resident Visitor Permit Holder" means a person to whom a Resident Visitor Permit has been issued under the provisions of Article 70;

"Resident Visitor Voucher" means a voucher issued by the Council under the provisions of Article 54, bearing printed instructions for its validation;

"School Entrance Markings" means any area which is comprised within and indicated by a road marking complying with the Traffic Signs Regulations;

"Traffic Signs Regulations" means the Traffic Signs Regulations and General Directions 2002:

"Valid Resident Visitor Voucher" means a Resident Visitor Voucher having indications on its obverse face, in accordance with the instructions on its reverse face, of the date and time, to the nearest fifteen minutes, at which the vehicle was first left in a Parking Place which is displayed together with a Valid Tax Disc for that vehicle;

- "Valid Permit" means a valid Resident Permit, a valid Resident Visitor Permit a valid Carer Permit a valid Discretionary Permit or a valid operational Permit which is displayed together with a Valid Tax Disc for that vehicle;
- "Valid Tax Disc" means the vehicle excise licence required to be displayed in the vehicle concerned in order for that vehicle to be legally used on a public road;
- "Verge" means any part of a road, which is not a carriageway and includes a Footway.
- (2) The prohibitions and restrictions imposed by this Order shall be in addition and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the 1984 Act or under any other enactment.
- (3) Any reference in this Order to a numbered Article or Schedule shall, unless the context otherwise requires, be construed as a reference to the Article or Schedule bearing that number in this Order.
- (4) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.
- (5) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.

Designation Of Controlled Parking Zone

- The area of the Controlled Parking Zone shall be an area comprising all of the streets as specified in Schedule 1, and the boundaries of which are indicated by traffic signs of a kind shown in diagram 663 of the Traffic Signs Regulations.
 - (2) The streets which constitute the Controlled Parking Zone shall not be subject to the provisions of this Order unless those streets are specified in Schedules 2 to 22 inclusive.

Restrictions Within The Controlled Parking Zone

- Save as provided in Article 6 no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Parking Attendant, cause or permit any vehicle to wait:
 - (1) between the hours of 8.00 am and 5.30 pm, Monday to Saturday in the lengths of road as specified in Schedule 10:-
 - (a) for a longer period than one hour; or
 - (b) if a period of less than one hour has elapsed since the termination of the last period of waiting (if any) by that vehicle on the same side of the road.
 - (2) between the hours of 8.00 am and 6.00 pm, Monday to Saturday in the lengths of road as specified in Schedule 11:-
 - (a) for a longer period than one hour; or
 - (b) if a period of less than one hour has elapsed since the termination of the last period of waiting (if any) by that vehicle on the same side of the road.
 - (3) between the hours of 10.00 am and 11.00 am, and 3.00 pm and 4.00 pm Monday to Saturday in the lengths of road as specified in Part I of Schedule 12;
 - (4) between the hours of 10.00 am and 11.00 am, and 3.00 pm and 4.00 pm Monday to Saturday in the lengths of road as specified in Part II of Schedule 12;
 - (5) between the hours of 10.00 am and 11.00 am, and 3.00 pm and 4.00 pm Monday to Saturday in the lengths of road as specified in Part III of Schedule 12;
 - (6) at any time in the lengths of road as specified in Schedule 13;

- (7) between the hours of 8.00 am and 6.30 pm in the lengths of road as specified in Schedule 14;
- (8) between the hours of 8.00 am and 6.00 pm in the lengths of road as specified in Schedule 15;
- (9) between the hours of 8.00 am and 6.00 pm Monday to Saturday in the lengths of road as specified in Schedule 16;
- (10) between the hours of 8.00 am and 5.30 pm Monday to Saturday in the lengths of road as specified in Schedule 17;
- (11) between the hours of 10.00 am and 11.00 am, and 3.00 pm and 4.00 pm Monday to Friday in the lengths of road as specified in Schedule 18;
- (12) at any time in the lengths of road as specified in Parts I, II, III, IV and V, of Schedule 19.
- Save as provided in Article 7 no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Parking Attendant, cause or permit any vehicle to stop or remain at rest in the lengths of road as specified in Schedule 20.

General Exemptions From Prohibitions and Restrictions

- 6 (1) Nothing in Article 4(1) to (11) inclusive, shall render it unlawful to cause or permit any vehicle to wait in any of the lengths of road referred to therein for so long as may be necessary if:
 - (a) the vehicle is waiting to enable a person to board or alight from the vehicle;
 - (b) the vehicle is waiting owing to the driver being obliged by law to stop or is prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid an accident:
 - (c) the vehicle is waiting in a location and for a purpose authorised and described on a Discretionary Permit;
 - (d) the vehicle if it cannot be reasonably used for such purposes in any other road, to be used in connection with any of the following:-
 - (i) use for police, fire brigade or ambulance purposes;
 - (ii) the removal of any Obstruction to traffic;

- (iii) use by a universal service provider (as defined by Section 4(3) of the Postal Services Act 2000) in connection with the provision of a universal postal service (within the meaning of the Postal Services Act 2000);
- (iv) in pursuance of statutory duties;
- (v) in connection with building, industrial or demolition operations;
- (vi) the laying, erection, alteration or repair in or on land adjacent to the said length of road of any sewer, main, pipe or apparatus for the supply of gas, water, electricity or of any telecommunication system as defined in the Telecommunications Act 1984;
- (vii) the maintenance, improvement or reconstruction of the length of road;
- (viii) in connection with posting or removing advertising material in the form of posters on or from or cleaning windows or chimneys in premises adjacent to the length of road in which the vehicle is waiting;
- (ix) in connection with any wedding or funeral;
- (e) the vehicle being a Public Service Vehicle is waiting in a Bus Stop Area for as long as may be reasonably necessary;
- (f) the vehicle is waiting to enable Goods to be loaded onto or unloaded from the vehicle.
- (2) Nothing in Article 4(12) shall render it unlawful to cause or permit any vehicle to wait in any of the lengths of road referred to therein for so long as may be necessary:-
 - (a) if the vehicle is waiting in accordance with any one of Paragraphs (a) to (f) of Article 6(1):-
 - (i) between the hours of 6.30 pm and 8.00 am, and 9.30 am and 4.00 pm in the lengths of road as specified in Part II of Schedule 19;
 - (ii) between the hours of 6.00 pm and 8.45 am, and 9.15 am and 5.00 pm in the lengths of road as specified in Part III of Schedule 19;
 - (iii) between the hours of 5.30 pm and 9.00 am in the lengths of road as specified in Part IV of Schedule 19;

- (iv) between the hours of 4.00 pm and 10.00 am in the lengths of road as specified in Part V of Schedule 19.
- (b) if the vehicle is waiting in accordance with Article 7(1)(a) and (b):-
 - (i) at any time in the lengths of road as specified in Part I of Schedule 19:
 - (ii) between the hours of 8.00 am and 9.30 pm, and 4.00 pm and 6.30 pm in the lengths of road as specified in Part II of Schedule 19;
 - (iii) between the hours of 8.45 am and 9.15 am, and 5.00 pm and 6.00 pm in the lengths of road as specified in Part III of Schedule 19;
 - (iv) between the hours of 9.00 am and 5.30 pm in the lengths of road as specified in Part IV of Schedule 19;
 - (v) between the hours of 10.00 am and 4.00 pm in the lengths of road as specified in Part V of Schedule 19.
- (c) Nothing in Article 4(7) shall render it unlawful to cause or permit any Hackney Carriage to wait in an Authorised Taxi Rank in the length of road referred to therein.
- (d) Nothing in Article 4(3) shall render it unlawful to cause or permit any vehicle to wait in the lengths of road specified therein if the vehicle displays in the Relevant Position:-
 - (i) a Valid Resident Permit or a Valid Resident Visitor Voucher which has been issued to a postal address specified in Part I of Schedule 6 to wait in the lengths of road specified therein.
 - (ii) a Valid Carer or operational permit authorised by the Council for use in the lengths of road specified in Article 4(3).
- (e) Nothing in Article 4(4) shall render it unlawful to cause or permit any vehicle to wait in the lengths of road specified therein if the vehicle displays in the Relevant Position:
 - (i) a Valid Resident Permit or a Valid Resident Visitor Voucher which has been issued to a postal address specified in Part I of Schedule 7 to wait in the lengths of road specified therein.

- (ii) a Valid Carer or operational permit authorised by the Council for use in the lengths of road specified in Article 4(4).
- (f) Nothing in Article 4(5) shall render it unlawful to cause or permit any vehicle to wait in the lengths of road specified therein if the vehicle displays in the Relevant Position:-
 - (i) a Valid Resident Permit or a Valid Resident Visitor Voucher which has been issued to a postal address specified in Part I of Schedule 8 to wait in the lengths of road specified therein.
 - (ii) a Valid Carer or operational permit authorised by the Council for use in the lengths of road specified in Article 4(5).
- (3) Nothing in this Order shall render it unlawful to cause or permit a Disabled Person's Vehicle which displays in the Relevant Position a Disabled Person's Badge to wait:-
 - (a) for a period not exceeding three hours:-
 - (i) in the lengths of road specified in Article 4(1) and (2) and Article 4(6) to (10) inclusive;
 - (ii) between the hours of:-
 - (a) 6.30 pm and 8.00 am, and 9.30 am and 4.00 pm in the lengths of road as specified in Part II of Schedule 19;
 - (b) 6.00 pm and 8.45 am, and 9.15 am and 5.00 pm in the lengths of road as specified in Part III of Schedule 19;
 - (c) 5.30 pm and 9.00 am in the lengths of road as specified in Part IV of Schedule 19;
 - (d) 4.00 pm and 10.00 am in the lengths of road as specified in Part V of Schedule 19;

not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same length of road on the same day) provided that there is also displayed in the Relevant Position on the vehicle, a Parking Disc on which there has been marked the quarter hour period during which the period of waiting began.

- (b) without limit of time in the lengths of road specified in Article 4(3), (4), (5) and (11).
- 7 (1) Nothing in Article 5 shall render it unlawful to cause or permit any vehicle to stop or remain at rest in any of the lengths of road referred to therein for so long as may be necessary if:-
 - (a) the vehicle is waiting owing to the driver being obliged by law to stop or is prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid an accident;
 - (b) the vehicle if it cannot be reasonably used for such purposes in any other road, to be used in connection with any of the following:-
 - (i) use for police, fire brigade or ambulance purposes;
 - (ii) the removal of any Obstruction to traffic.

Designation Of Parking Places And Parking Spaces

- 8 (1) The extent of each Parking Place is as described in Schedules 2 to 9 inclusive or Schedules 21 and 22 as appropriate.
 - (2) The extent of each Parking Place shall comprise those lengths of road as indicated by a road marking of a kind shown in diagrams 1028.2, 1028.3, 1028.4 (a) or (b) or 1033 of the Traffic Signs Regulations.
 - (3) Within each Parking Place, individual Parking Spaces are not indicated by road markings, (except for Alexander Road and Nelson Terrace) but shall comprise the extent of the Parking Place BUT EXCLUDING those parts of a Parking Place indicated by a road marking of a kind shown in diagrams 1017, 1018.1 or 1026.1 of the Traffic Signs Regulations.

Vehicles for Which Parking Places Are Designated

- 9 (1) Subject to the provisions of this Order, each Parking Place referred to in Schedules 2 to 8 inclusive may only be used for the leaving during the Controlled Hours of such vehicles as are of the class specified in Part (3) of this Article provided that they shall:
 - (a) display in the manner specified in Article 28, a valid Resident Permit issued in respect of that vehicle; or

- (b) display in the manner specified in Article 55, a Valid Resident Visitor Voucher; or
- (c) display in the Relevant Position a valid Disabled Person's Badge; or
- (d) display in the manner specified in Article 46, a valid Discretionary Permit; or
- (e) display in the manner specified in Article 37 a valid Carer Permit; or
- (f) display in the manner specified in Article 60 a valid operational Permit.
- (2) Subject to the provisions of this Order each Parking Place referred to in Schedule 9 may only be used during the Controlled Hours for the leaving of such vehicles as are of the class specified in Part (3) of this Article provided that they shall:
 - (a) display a Valid Permit of a kind specified and in accordance with Paragraphs (a), (d), (e) and (f) inclusive of Part (1) of this Article; or
 - (b) display in the manner specified in Article 69 a Valid Resident Visitor Permit; or
 - (c) display in the Relevant Position a valid Disabled Person's Badge.
- (3) The class of vehicles referred to in Part (1) to (2) inclusive of this Article shall be:-
 - (a) Passenger Vehicles, or
 - (b) Motor Cycles; or
 - (c) Goods Vehicles.

- (4) Notwithstanding the provisions of Part (3) of this Article the overall height, length and number of wheels of a Goods Vehicle as specified therein may be exceeded in exceptional or special circumstances at the absolute discretion of the Council.
- (5) Nothing in the foregoing provisions of this Article shall render it unlawful to cause or permit any vehicle to wait in a Parking Place specified in this Article, provided that it is waiting in accordance with any one of Paragraphs (a) to (f) inclusive of Part (1) of Article 6 to this Order.

Use Of Parking Place

- 10 (1) A driver of a vehicle shall not use a Parking Place:-
 - (a) so as unreasonably to prevent access to any premises adjoining a road or the use of a road by other persons or so as to be a nuisance; or
 - (b) when such Parking Place has been suspended in accordance with Article 16.
 - (2) The driver of a Motor Vehicle using a Parking Place shall stop the engine as soon as the vehicle is in position in the Parking Place and shall not start the engine except when about to change the position of the vehicle in or to depart from the Parking Place.
 - (3) No person shall carry out upon any vehicle while it is in a Parking Place any work, construction or repair except such as may be necessary to enable the vehicle to be moved from the Parking Place.
 - (4) Subject to the provisions of Part (5) and (6) of this Article no person shall:-
 - (a) sell, offer or exhibit for sale or hire any vehicle while it is in a Parking Place; or
 - (b) use a vehicle, while it is in a Parking Place, in connection with the selling, display or offering for sale of any article to persons in or near the Parking Place or in connection with the selling or offering for hire of their skills in handicraft or services in any capacity.
 - (5) Nothing in Part (4) of this Article shall prohibit persons employed in connection with a licensed Public Service Vehicle or a licensed driver of a Hackney Carriage from plying for hire or accepting passengers for hire in accordance with any regulation or condition under which the service is required by law to operate.

- (6) Nothing in Part (4) of this Article shall prohibit the sale of Goods from a vehicle if the Goods are immediately delivered at or taken into premises adjacent to the vehicle from which the sale is affected.
- (7) Contravention of Parts (1) to (4) inclusive of this Article may result in the withdrawal of any Permit issued for that vehicle.

Manner Of Waiting In A Parking Place

- Every vehicle left in a Parking Place in accordance with the provisions of this Order shall so stand:
 - (1) so that every part of the vehicle is within the limits of the Parking Space; and
 - (2) so that no part of the vehicle obstructs any vehicular means of ingress to or egress from the premises adjacent to the side of the road on which the vehicle is waiting.

Manner Of Waiting Other Than In A Parking Place

- Where parking is permitted in accordance with the provisions of Article 5 of this Order, every vehicle shall so stand:-
 - (1) so that no part of the vehicle obstructs any vehicular means of ingress to or egress from the premises adjacent to the side of the road on which the vehicle is waiting; and
 - (2) so that no part of the vehicle obstructs any part of a cycle lane, dropped Footway crossing, or bus stop.

Permitted Parking Places

- 13 (1) Save as provided in Article 16 and 13(3) **and (4),** no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Parking Attendant, cause or permit any vehicle to wait:-
 - (a) between the hours of 8.00am and 5.30 pm on any day other than a Sunday in any Parking Place specified in Part I of Schedule 21:-
 - (i) for a longer period than one hour; or
 - (ii) if a period of less than one hour has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle in the same Parking Place.

- (b) between the hours of 8.00am and 6.00pm on any day other than a Sunday in any Parking Place specified in Part II of Schedule 21 for:-
 - (i) a longer period than one hour; or
 - (ii) if a period of less than one hour has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle in the same Parking Place.
- (2) Save as provided in Article 16 and 13(3), except upon the direction or with the permission of a Police Constable in uniform or of a Parking Attendant, only vehicles within the class specified in Article 9(3) may wait:-
 - (a) between the hours of 8.00 am and 6.00 pm on any day other than a Sunday in any Parking Place specified in Part III of Schedule 21 provided that they shall not wait:-
 - (i) for a longer period than one hour; or
 - (ii) if a period of less than one hour has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle in the same Parking Place.
- (3) Nothing in the foregoing provisions of this Article shall render it unlawful to cause or permit:
 - (a) any vehicle displaying in the Relevant Position a Valid Permit (other than a Resident Permit) or Valid Resident Visitor Voucher applicable to the Parking Place; or
 - (b) a Disabled Person's Vehicle displaying in the Relevant Position a Disabled Person's Badge,

to wait in a Parking Place specified in this Article provided that a vehicle displaying a valid Resident Visitor Voucher shall not be permitted to wait in a Parking Place beyond 10.00 am on the day following the date of validation.

(4) Nothing in the foregoing provisions of this Article shall render it unlawful to cause or permit any vehicle to wait in a Parking Place specified in this Article, provided that it is waiting in accordance with any one of Paragraphs (a) to (f) inclusive of Part (1) of Article 6 to this Order.

Parking Penalties

- 14 (1) For the purposes of this Article, if a vehicle is left otherwise than as authorised by or under this Order, or where there has been a contravention of, or failure to comply with, any provision made by or under this Order, a penalty charge shall be payable.
 - (2) In the case of a vehicle in respect of which a penalty charge is payable, a Penalty Charge Notice showing the information required by Section 66(3) of the 1991 Act may be issued by a Parking Attendant in accordance with the requirements of Section 66(1) of the said Act.
 - (3) Where a Penalty Charge Notice is issued in accordance with this Article a Parking Attendant shall, when signing an issued Penalty Charge Notice include his Parking Attendant Signature.
 - (4) The penalty charge shall be paid to the Council by such means as may be approved by the Council and which shall be delivered or sent by post to the address shown on the Penalty Charge Notice and in accordance with the instructions on that notice, to arrive no later than the end of:-
 - (a) the twenty-eighth day beginning with the date of the notice; or
 - (b) in the case of a reduced penalty charge as indicated on the notice, the fourteenth day beginning with the date of the notice,

provided that if the said fourteenth or twenty-eighth day falls upon a day on which the said Council offices are closed, the period within which payment of the said penalty charge shall be extended until the next following day upon which the said offices are open.

Period For Which Vehicle May Be Left After Penalty Charge Notice Affixed To Vehicle

- 15 (1) The period for which a vehicle may be left after the Penalty Charge Notice has been issued in accordance with Article 14 shall not exceed thirty minutes where the vehicle is left within a Parking Place.
 - (2) Where a vehicle is left in any Parking Place after the Penalty Charge Notice has been served, and the time period specified in Part (1) of this Article has expired, a further Penalty Charge Notice may be served.

Power To Suspend The Use Of A Parking Place

- 16 (1) The Council may suspend the use of a Parking Place or any part thereof, subject to such conditions or exceptions as the Council consider necessary:-
 - (a) if it is satisfied that use of the Parking Place should be restricted or prohibited by reason that works are being or are proposed to be executed on or near the road;
 - (b) if it is satisfied that use of the Parking Place should be restricted or prohibited by reason of the likelihood of danger to the public or of serious damage to the highway;
 - (c) for the purpose of facilitating the movement of traffic or promoting its safety;
 - (d) for preventing Obstruction of the streets on the occasion of any public attraction or when the streets are thronged or liable to be obstructed;
 - (e) for the convenience of occupiers of premises adjacent to the Parking Place on any occasion of the removal of furniture from one office or dwelling-house to another or the removal of furniture from such premises to a depository or to such premises from a depository;
 - (f) for the convenience of access to premises being used for a wedding or a funeral, or other special occasions.
 - (2) A Police Constable in uniform may suspend for no longer than seven days the use of a Parking Place or any part thereof whenever he considers such suspension reasonably necessary:-
 - (a) for the purpose of facilitating the movement of traffic or promoting its safety; or
 - (b) on any occasion on which it is likely by reason of some special attraction that any street will be throughd or obstructed.
 - (3) Where the use of a Parking Place or any part thereof is suspended in accordance with Parts (1) or (2) of this Article the Council or Police Constable in uniform as the case may be shall place or cause to be placed in or adjacent to the Parking Place or the part thereof the use of which is suspended such traffic signs as are necessary to indicate that waiting by vehicles is prohibited.

Alteration Of Position Of A Vehicle In A Parking Place

Where any vehicle is standing in a Parking Place in contravention of the provisions of Article 11, a Police Constable in uniform or a Parking Attendant may alter or cause to be altered the position of the vehicle in order that its position shall comply with the provisions of Article 11.

Movement Of A Vehicle In A Parking Place In An Emergency

In case of emergency, a Police Constable in uniform or a Parking Attendant may move or cause to be moved any vehicle left in a Parking Place to any place they think fit.

Movement Of A Vehicle In A Parking Place Causing An Obstruction

In case of Obstruction, a Police Constable in uniform or a Parking Attendant may move or cause to be moved any vehicle left in a Parking Place to a convenient Parking Place nearest to where the vehicle was originally parked.

Clamping Of A Vehicle In A Parking Place

Notwithstanding the provisions of Article 21 where a vehicle has been served two Penalty Charge Notices by a Parking Attendant in accordance with Article 14 the Parking Attendant or a Police Constable in uniform may authorise the clamping of the vehicle.

Removal Of A Vehicle From A Parking Place

- Where a vehicle:
 - (1) is parked in a Parking Place and is parked in a position that a Police Constable in uniform or Parking Attendant considers to cause an Obstruction to other users of the highway; or
 - (2) has been served two Penalty Charge Notices by a Parking Attendant in accordance with Article 14:

the Police Constable in uniform or Parking Attendant may authorise the removal of the vehicle and where it is so removed, shall provide for the safe custody of the vehicle. The Council shall notify the Police of the details of any vehicle so removed, and the arrangements that may be made for the Owner to recover the vehicle.

Clamping Of A Vehicle Other Than In A Parking Place

Notwithstanding the provisions of Article 23 where a vehicle has been served two Penalty Charge Notices by a Parking Attendant in accordance with Article 14 the Parking Attendant or Police Constable in uniform may authorise the clamping of the vehicle.

Removal Of A Vehicle Other Than In A Parking Place

Where a vehicle:-

- (1) is parked other than in a Parking Place and is parked in a position that a Parking Attendant or Police Constable in uniform considers to cause an Obstruction to other users of the highway; or
- (2) has been served two Penalty Charge Notices by a Parking Attendant in accordance with Article 14,

the Parking Attendant or Police Constable in uniform may authorise the removal of the vehicle and, where it is so removed, shall provide for the safe custody of the vehicle. The Council shall notify the Police of the details of any vehicle so removed, and the arrangements that may be made for the Owner to recover the vehicle.

- 24 (1) Where a vehicle is removed, the Owner of the vehicle shall produce such documentary evidence as is necessary for the Council to reasonably determine that the person purporting to be the Owner is authorised to take charge of the vehicle.
 - (2) Before a vehicle is returned to the Owner, all outstanding penalty charges accrued in connection with the authorised removal of the vehicle must be paid, together with the charges for removal and storage of such vehicle as follows:
 - (a) A fixed charge as may be approved by the appropriate Secretary of State; and
 - (b) A daily charge as may be approved by the appropriate Secretary of State, BUT EXCLUDING the day on which such vehicle was removed from the street and the day on which the vehicle was collected by the Owner.
 - (3) Where a vehicle has been removed from the street and remains uncollected the Council shall be permitted to sell or dispose of such vehicle, in accordance with Section 101 of the 1984 Act, to reimburse all charges in Part (2) of this Article.

Charges Payable When A Vehicle Is Clamped

- Where a vehicle has been clamped, the Owner of the vehicle shall produce such documentary evidence as is necessary for the Council to reasonably determine that the person purporting to be the Owner is authorised to take charge of the vehicle.
 - (2) Before a vehicle is unclamped, all outstanding penalty charges accrued in connection with the authorised clamping of the vehicle in the place

in which it was clamped, must be paid together with the charge as may be approved by the appropriate Secretary of State.

Resident Permits

- 26 (1) For the purposes of administering Resident Permits the Council shall define by name or unique reference code such Parking Zones, as the Council at its absolute discretion deem necessary.
 - (2) The names, unique reference codes and lengths of road which comprise each Parking Zone, shall be as specified in Schedules 2 to 9 inclusive.

Class Of Vehicles In Respect Of Which A Resident Permit May Be Issued

- 27 (1) The class of vehicles in respect of which a Resident Permit may be issued shall be:-
 - (a) Passenger Vehicles, or
 - (b) Motor Cycles; or
 - (c) Goods Vehicles.
 - (2) Notwithstanding the provisions of Part (1) of this Article, the overall height and length of a vehicle may be exceeded in exceptional or special circumstances at the absolute discretion of the of the Council.

Resident Permit To Be Displayed On Vehicles Left In Parking Places

At all times during the Controlled Hours when a vehicle in respect of which a Resident Permit has been issued is left in a Parking Place, there shall be displayed in the Relevant Position that Resident Permit issued in respect of that vehicle together with a Valid Tax Disc without which the Permit will not be valid.

Application For; And Issue Of Resident Permit

- 29 (1) Any Resident who is the Owner of a vehicle of the class specified in Article 27(1) may apply to the Council for the issue of a Resident Permit in respect of that vehicle and any such application shall be made on a form issued by and obtainable from the Council and shall include the particulars and information required by such form to be supplied. Each Resident eligible to drive will be entitled to apply for one Resident Permit for a vehicle of the class specified in Article 27(1) and may also apply for an additional Resident Permit for a Motor Cycle.
 - (2) (a) The Council may at any time require an applicant for a Resident Permit to provide such evidence in respect of such application as they may reasonably call for to verify any particulars or information given to them.

- (b) The Council may at any time require a Resident Permit Holder to provide such evidence in respect of any Permit issued to the Resident Permit Holder as they may reasonably call for to verify that such Resident Permit is valid.
- (3) (a) Upon receipt of an application duly made under the foregoing provisions of this Article and upon receipt of the appropriate charge specified in Part (4) of this Article, the Council, upon being satisfied that the applicant is a Resident and is the Owner of a vehicle of the class specified in Article 27(1), may issue to the applicant thereof a Resident Permit valid only in the Parking Zone in which the applicant is a Resident, provided that:-
 - (i) the Council shall not issue a Resident Permit to any Resident which would be valid for any period during which any other Resident Permit issued to that Resident is or would be valid except for a Motor Cycle Permit.
 - (ii) the Council at its absolute discretion, and with the agreement of the applicant, may issue a Resident Permit valid for a Parking Zone other than the Parking Zone in which the applicant is a Resident.
 - (b) Such Resident Permit shall allow for the leaving of the vehicle in a Parking Place in the Parking Zone to which such Resident Permit relates by the Owner of such vehicle or by any person using such vehicle with the consent of said Owner other than a person to whom such vehicle has been let for hire or reward.
- (4) The charge for a Resident Permit shall be as specified in Schedule 23, or as may be prescribed from time to time by the Council.
- (5) The Council, at its total discretion, reserves the right to either issue a Resident Permit, refuse to issue a Resident Permit or to withdraw such a Permit if it appears appropriate to them at the time.
- (6) The Permit shall be valid from the day it is issued by the Council unless the applicant requests such other date as the Council may approve.
- (7) The Permit shall remain valid for a period of one month or one year, whichever shall be appropriate, commencing on the first day of the month in which the Permit first becomes valid.
- (8) Any permit applied for and issued before the Operational Date, under the provisions of:-

- (a) The Buckinghamshire County Council (Albion Street, Aylesbury) (Parking Places with Permits) Order, 1983; or
- (b) The Buckinghamshire County Council (St. John's Street, Aylesbury) (Parking Places with Permits) Order, 1983; or
- (c) The Buckinghamshire County Council (Various Roads, Aylesbury) (Parking Places with Permits) Order, 1983; or
- (d) The Buckinghamshire County Council (Aylesbury Old Town)(Prohibition of Waiting and Parking Places With Permits) Order, 2000.

shall remain valid as if those Orders specified above had not been revoked by this Order, until such time as the permit may expire or be surrendered, withdrawn or revoked under the provisions of the relevant Order and any subsequent application for a Permit shall be made under the provisions of this Order.

Refund Of Charge Paid In Respect Of A Resident Permit

- 30 (1) A Resident Permit Holder who surrenders a Resident Permit to the Council before it becomes valid shall be entitled a full refund of any charge paid in respect thereof.
 - (2) A Resident Permit Holder who surrenders a Resident Permit to the Council after it becomes valid shall be entitled to a refund of part of the charge paid in respect thereof in accordance with the provisions of Part (3) of this Article.
 - (3) The part of the charge which is refundable under the provisions of Part (2) of this Article shall be calculated pro rata on the remaining whole days for which the Permit being surrendered would have remained valid less an administrative charge as specified in Schedule 23.

Lost Or Destroyed Permit

If a Permit is lost or destroyed the Permit holder may apply to the Council for the issue of a duplicate and the Council, on being satisfied as to the loss or destruction shall upon payment of an administrative charge as specified in Schedule 23, issue a duplicate Permit so marked and upon such issue the Permit which it duplicated shall become invalid.

Mutilated Or Defaced Permit

If a Permit is mutilated, defaced or otherwise becomes illegible the Permit holder shall surrender the Permit to the Council for the issue of a duplicate and the Council shall upon being satisfied as to the veracity of the Permit and upon payment of an administrative charge as specified in Schedule 23 issue a

duplicate Permit so marked and upon such issue the Permit which it duplicated shall become invalid.

Surrender, Withdrawal And Validity Of Resident Permit

- A Resident Permit Holder may surrender a Resident Permit to the Council at any time and shall surrender a Resident Permit to the Council on the occurrence of any one of the events set out in Part (3) of this Article or in accordance with the provisions of Part (4) of this Article.
 - (2) The Council may, by notice, withdraw a Resident Permit if it appears to the Council that any of the events set out in Part (3) of this Article have occurred and the Resident Permit Holder shall surrender the Permit to the Council within seventy-two hours of the delivery of the aforementioned notice.
 - (3) The events referred to in the foregoing provisions of this Article are:
 - (a) the Resident Permit Holder ceasing to be a Resident of the Parking Zone in respect of which the Resident Permit was issued: or
 - (b) the Resident Permit Holder ceasing to be the Owner of the vehicle in respect of which the Resident Permit was issued; or
 - (c) the vehicle in respect of which such Resident Permit was issued being adapted or used in such a manner that it is not a vehicle of the class specified in Article 27(1); or
 - (d) the vehicle in respect of which such Resident Permit was issued ceasing to display a Valid Tax Disc for that vehicle; or
 - (e) the issue of a duplicate Resident Permit by the Council under the provisions of this Order; or
 - (f) the Resident Permit ceasing to be valid pursuant to the provisions of Part (4) of this Article.
 - (4) Where a Resident Permit is issued to any person upon receipt of a cheque or credit card and the payment is subsequently dishonoured, the Resident Permit shall cease to be of any effect and the Council shall, by notice, require that person to surrender the Resident Permit to the Council within seventy-two hours of the delivery of such notice.

Form Of Resident Permit

34 (1) A Resident Permit shall be in writing and shall include the following particulars:-

- (a) the registration mark of the vehicle in respect of which the Resident Permit has been issued; and
- (b) a serial number; and
- (c) the Parking Zone in which the Resident Permit is valid; and
- (d) the last date on which the Resident Permit is valid; and
- (e) an indication that the Resident Permit has been issued by the Council.

Change Of Vehicle By Permit holder

In the event of the Permit holder disposing of the vehicle in respect of which the Permit has been issued and acquiring another vehicle, the Council shall on surrender of the Permit by the Permit holder and upon payment of such administrative charge as specified in Schedule 23, issue a replacement Permit having the same expiry date and validity as the original Permit.

Carer Permits

- 36 (1) For the purposes of administering Carer Permits the Council may define by name or unique reference code such Parking Zones, as the Council at its absolute discretion deem necessary.
 - (2) The names, unique reference codes and roads or lengths of road, which comprise each Parking Zone, shall be as detailed in Schedules 2 to 9 inclusive.

Carer Permit To Be Displayed On Vehicles Left In Parking Places

At all times during the Controlled Hours when a vehicle in respect of which a Carer Permit has been issued is left in a Parking Place, there shall be displayed in the Relevant Position that Carer Permit issued in respect of that vehicle.

Application For; And Issue Of Carer Permit

- Any person, who is the Owner of a vehicle may apply to the Council for the issue of a Carer Permit in respect of that vehicle and any such application shall be made on a form issued by and obtainable from the Council and shall include the particulars and information required by such form to be supplied.
 - (2) (a) The Council may at any time require an applicant for a Carer Permit to provide such evidence in respect of such application as they may reasonably call for to verify any particulars or information given to them.
 - (b) The Council may at any time require a Carer Permit Holder to provide such evidence in respect of any Permit issued to the

Carer Permit Holder as they may reasonably call for to verify that such Carer Permit is valid.

- (3) (a) Upon receipt of an application duly made under the foregoing provisions of this Article and upon receipt of the appropriate charge specified in Schedule 23 the Council, upon being satisfied that the applicant is a carer and is the Owner of a vehicle, and that the use of a Carer Permit would be for the benefit of a Resident in the Controlled Parking Zone by virtue of providing care to a Resident in their home may issue to the applicant thereof a Carer Permit.
 - (b) Such Carer Permit shall allow for the leaving during the Controlled Hours in a Parking Place in the Parking Zone to which such Carer Permit relates of a vehicle by the Owner or by any person with the consent of said Owner other than a person to whom such vehicle has been let for hire or reward.
 - (c) Provided that, the Council shall not issue a carer Permit to any carer, which would be valid for any period, during which any other Carer Permit issued to that person is or would be valid unless at the absolute discretion of the Council, a specific exception is made.
- (4) In the case of an application for which the Carer Permit, if issued, would on the day on which it first becomes valid, be the only Valid Permit issued to that carer, the charge shall be as specified in Schedule 23 or as may be prescribed from time to time by the Council.
- (5) The Council, at its total discretion, reserves the right to either issue a Carer Permit, refuse to issue a Carer Permit or to withdraw such a Permit if it appears appropriate to them at the time.
- (6) The Permit shall be valid from the day it is issued by the Council unless the applicant requests such other date as the Council may approve.
- (7) The Permit shall remain valid for a period of one year commencing on the first day of the month in which the Permit first becomes valid.

Refund Of Charge Paid In Respect Of A Carer Permit

- 39 (1) A Carer Permit Holder who surrenders a Carer Permit to the Council before it becomes valid shall be entitled a full refund of any charge paid in respect thereof.
 - (2) A Carer Permit Holder who surrenders a Carer Permit to the Council after it becomes valid shall be entitled to a refund of part of the charge

- paid in respect thereof in accordance with the provisions of Part (3) of this Article.
- (3) The part of the charge which is refundable under the provisions of Part (2) of this Article shall be calculated pro rata on the remaining complete days for which the Permit being surrendered would have remained valid less an administrative charge as specified in Schedule 23.

Lost Or Destroyed Permit

If a Permit is lost or destroyed the Permit holder may apply to the Council for the issue of a duplicate and the Council, on being satisfied as to the loss or destruction shall upon payment of an administrative charge as may be prescribed from time to time by the Council, issue a duplicate Permit so marked and upon such issue the Permit which it duplicated shall become invalid.

Mutilated Or Defaced Permit

If a Permit is mutilated, defaced or otherwise becomes illegible the Permit holder shall surrender the Permit to the Council for the issue of a duplicate and the Council shall upon being satisfied as to the veracity of the Permit and upon payment of an administrative charge as specified in Schedule 23 or as may be prescribed from time to time by the Council, issue a duplicate Permit so marked and upon such issue the Permit which it duplicated shall become invalid.

Surrender, Withdrawal And Validity Of Carer Permit

- 42 (1) A Carer Permit Holder may surrender a Carer Permit to the Council at any time and shall surrender a Carer Permit to the Council on the occurrence of any one of the events set out in Part (3) of this Article or in accordance with the provisions of Part (4) of this Article.
 - (2) The Council may, by notice, withdraw a Carer Permit if it appears to the Council that any of the events set out in Part (3) of this Article have occurred and the Carer Permit Holder shall surrender the Permit to the Council within seventy-two hours of the delivery of the aforementioned notice.
 - (3) The events referred to in the foregoing provisions of this Article are:
 - (a) the Carer Permit Holder ceasing to care at the address within the Parking Zone in respect of which the Carer Permit was issued:
 - (b) the Carer Permit Holder ceasing to be the Owner of a vehicle;

- (c) the vehicle in respect of which such Carer Permit was issued ceasing to display a Valid Tax Disc for that vehicle;
- (d) the issue of a duplicate Carer Permit by the Council under the provisions of this Order;
- (e) the Carer Permit ceasing to be valid pursuant to the provisions of Part (4) of this Article.
- (4) Where a Carer Permit is issued to any person upon receipt of a payment and the payment is subsequently dishonoured, the Carer Permit shall cease to be of any effect and the Council shall, by notice, require that person to surrender the Carer Permit to the Council within seventy-two hours of the delivery of the aforementioned notice.

Form Of Carer Permit

- 43 (1) A Carer Permit shall be in writing and shall include the following particulars:-
 - (a) the registration mark of the vehicle in respect of which the Carer Permit was issued; and
 - (b) a serial number; and
 - (c) the Parking Zone in which the Carer Permit is valid; and
 - (d) the last date on which the Carer Permit is valid; and
 - (e) an indication that the Carer Permit has been issued by the Council.

Change Of Vehicle By Permit Holder

In the event of the Permit holder disposing of the vehicle in respect of which the Permit has been issued and acquiring another vehicle, the Council shall on surrender of the Permit by the Permit holder and upon payment of an administrative charge as specified in Schedule 23 or as may be prescribed from time to time by the Council, issue a replacement Permit having the same expiry date and validity as the original Permit.

Discretionary Permits

- 45 (1) The Council may at its absolute discretion issue a Discretionary Permit where:-
 - (a) It is necessary to identify a vehicle that is lawfully parked in a Parking Place without requiring that vehicle to display a Valid Permit or Valid Resident Visitor Voucher.

- (b) The Council deems it appropriate to Permit a vehicle to be parked in a Parking Place for a longer period of time than would normally be permitted; or
- (c) The Council deems it appropriate to permit a vehicle to be parked in a position that would not normally be lawful.

Discretionary Permit To Be Displayed On Vehicles

At all times when a vehicle in respect of which a Discretionary Permit has been issued there shall be displayed in the Relevant Position the Discretionary Permit issued in respect of that vehicle.

Application For; And Issue Of Discretionary Permit

- 47 (1) Any person who is the Owner of a vehicle may apply to the Council for the issue of a Discretionary Permit in respect of that vehicle and any such application shall be made on a form issued by and obtainable from the Council and shall include the particulars and information required by such form to be supplied.
 - (2) (a) The Council may at any time require an applicant for a Discretionary Permit to provide such evidence in respect of such application as they may reasonably call for to verify any particulars or information given to them.
 - (b) The Council may at any time require a Discretionary Permit Holder to provide such evidence in respect of a Permit issued to the Discretionary Permit Holder as they may reasonably call for to verify that such Discretionary Permit is valid.
 - (3) Upon receipt of an application duly made under the foregoing provisions of this Article and upon receipt of the appropriate charge specified in Part (7) of this Article the Council, upon being satisfied that the applicant is the Owner of a vehicle, may issue a Discretionary Permit for the leaving of the vehicle in a Parking Place or any particular position specified in the Discretionary Permit by the Owner of such vehicle or by any person using such vehicle with the consent of said Owner other than a person to whom such vehicle has been let for hire or reward.
 - (4) (a) Upon receipt of an application duly made under the foregoing provisions of this Article and upon receipt of the appropriate charge specified in Part (7) of this Article the Council, upon being satisfied that the applicant is the Owner of a vehicle, may issue to the applicant thereof a Discretionary Permit.
 - (b) Such Discretionary Permit shall allow for the leaving in a Parking Place or any particular position of the vehicle to which such Discretionary Permit relates by the Owner of such vehicle

or by any person using such vehicle with the consent of said Owner other than a person to whom such vehicle has been let for hire or reward.

- (5) The Council, at its total discretion, reserves the right to either issue a Discretionary Permit, refuse to issue a Discretionary Permit or to withdraw such a Permit if it appears appropriate to them at the time.
- (6) The Permit shall be valid from the day it is issued by the Council unless the applicant requests such other date as the Council may approve.
- (7) The Council may make a charge for the issue of the Discretionary Permit as specified in Schedule 23 or as may be prescribed by the Council from time to time.
- (8) The Permit shall expire on the date stated on the Permit.

Refund Of Charge In Respect Of A Discretionary Permit

- 48 (1) A Discretionary Permit Holder who surrenders a Discretionary Permit to the Council before it becomes valid shall be entitled a full refund of any charge paid in respect thereof.
 - (2) A Discretionary Permit Holder who surrenders a Discretionary Permit to the Council after it becomes valid shall be entitled to a refund of part of the charge paid in respect thereof in accordance with the provisions of Part (3) of this Article.
 - (3) The part of the charge which is refundable under the provisions of Part (2) of this Article shall be calculated pro rata on the remaining complete days for which the Permit being surrendered would have remained valid less an administrative charge as specified in Schedule 23.

Lost Or Destroyed Permit

If a Permit is lost or destroyed the Permit holder may apply to the Council for the issue of a duplicate and the Council may, on being satisfied as to the loss or destruction and upon payment of an administrative charge as specified in Schedule 23 or as may be prescribed from time to time by the Council, issue a duplicate Permit so marked and upon such issue the Permit which it duplicated shall become invalid.

Mutilated Or Defaced Permit

If a Permit is mutilated, defaced or otherwise becomes illegible the Permit holder shall surrender the Permit to the Council for the issue of a duplicate and the Council, shall upon being satisfied as to the veracity of the Permit and upon payment of an administrative charge as specified in Schedule 23 or as

may be prescribed from time to time by the Council, issue a duplicate Permit so marked and upon such issue the Permit which it duplicated shall become invalid.

Surrender, Withdrawal And Validity Of Discretionary Permit

- A Discretionary Permit Holder may surrender a Discretionary Permit to the Council at any time and shall surrender a Discretionary Permit to the Council on the occurrence of any one of the events set out in Part (3) of this Article or in accordance with the provisions of Part (4) of this Article.
 - (2) The Council may, by notice, withdraw a Discretionary Permit if it appears to the Council that any of the events set out in Part (3) of this Article have occurred and the Discretionary Permit Holder shall surrender the Permit to the Council within seventy-two hours of the delivery of the aforementioned notice.
 - (3) The events referred to in the foregoing provisions of this Article are:
 - (a) the circumstances that caused the Discretionary Permit to be issued no longer apply; or
 - (b) the Discretionary Permit Holder ceasing to be the Owner of the vehicle in respect of which the Discretionary Permit was issued; or
 - (c) the vehicle in respect of which such Discretionary Permit was issued ceasing to display a Valid Tax Disc for that vehicle; or
 - (d) the issue of a duplicate Discretionary Permit by the Council under the provisions of this Order; or
 - (e) the Discretionary Permit ceasing to be valid pursuant to the provisions of Part (4) of this Article.
 - (4) Where a Discretionary Permit is issued to any person upon payment and the payment is subsequently dishonoured, the Discretionary Permit shall cease to be of any effect and the Council shall, by notice, require that person to surrender the Discretionary Permit to the Council within seventy-two hours of the delivery of the aforementioned notice.
 - (5) The part of the charge which is refundable under the provisions of Part (2) of this Article shall be calculated pro rata on the remaining whole days for which the Permit being surrendered would have remained valid less an administrative charge as specified in Schedule 23.

Form Of Discretionary Permit

- 52 (1) A Discretionary Permit shall be in writing and shall include the following particulars:-
 - (a) the registration mark of the vehicle in respect of which the Discretionary Permit has been issued; and
 - (b) a serial number; and
 - (c) the Parking Zone or location in which the Discretionary Permit is valid; and
 - (d) the earliest date and time at which the Discretionary Permit is valid; and
 - (e) the latest date and time at which the Discretionary Permit is valid; and
 - (f) where the Discretionary Permit allows a vehicle to be parked in a location other than in a Parking Place, an indication of the precise location in which the Discretionary Permit is valid; and
 - (g) an indication that the Discretionary Permit has been issued by the Council.

Change Of Vehicle By Permit Holder

In the event of the Permit holder disposing of the vehicle in respect of which the Permit has been issued and acquiring another vehicle, the Council shall on surrender of the Permit by the Permit holder and upon payment of an administrative charge as specified in Schedule 23 or as may be prescribed from time to time by the Council, issue a replacement Permit having the same expiry date and validity as the original Permit.

Application For; And Issue Of Resident Visitor Voucher

- Any Resident within Parking Zones specified in Schedules 2 to 8 inclusive may apply to the Council for the issue of one or more books of five or ten visitor vouchers for a vehicle belonging to a person visiting that Household and any such application shall be made on a form issued by and obtainable from the Council and shall include the particulars and information required by such form and shall be accompanied by the appropriate charge specified in Part (2) of this Article.
 - (2) The appropriate charge for a book of five or ten visitor vouchers shall be as specified in Schedule 23.

- (3) Upon receipt of an application duly made under the foregoing provisions of this Article and upon receipt of the appropriate charge specified in Part (2) of this Article, the Council upon being satisfied that the applicant is a Resident, may issue to the applicant thereof subject to the provisions of Part (8) and (9) of this Article, the number of books requested valid only in the Parking Zone in which the applicant is a Resident.
- (4) Such a Resident Visitor Voucher shall only allow for the leaving of the vehicle in a Parking Place in the Parking Zone to which such Resident Visitor Voucher relates other than a vehicle which has been let for hire or reward.
- (5) Where a book of Resident Visitor Vouchers is issued to any person upon payment and the payment is subsequently dishonoured, the individual Resident Visitor Voucher shall cease to be of any effect and the Council shall, by notice, require that person to surrender the Resident Visitor Voucher to the Council within seventy-two hours of the delivery of the aforementioned notice.
- (6) The Council may at any time require an applicant for a book of Resident Visitor Vouchers to produce to the Council such evidence in respect of that application as they may reasonably require to verify any particulars or information given to them.
- (7) The Council at its total discretion, reserves the right to either issue a book of Resident Visitor Vouchers, refuse to issue a Resident Visitor Voucher or to withdraw such a book of visitor vouchers if it appears appropriate to the Council at the time.
- (8) A Resident who surrenders an unused book of visitor vouchers to the Council shall be entitled to a full refund of any charge paid in respect thereof. A part used book of visitors vouchers shall not be refundable.
- (9) Subject to Part (10) of this Article, the Council shall not issue more than 50 visitor vouchers in any three month period to any one Household and in any event, may at its absolute discretion, limit the number of visitor vouchers that are issued in respect of a particular Household.
- (10) Notwithstanding the provisions of Part (9) of this Article, the maximum number of visitor vouchers, which may be issued in any three-month period, as specified therein, may be exceeded at the absolute discretion of the Council.

Validity Of Resident Visitor Voucher

A Resident Visitor Voucher shall be valid on a particular day or days provided that the obverse face of the Resident Visitor Voucher, in accordance with the instructions printed on its reverse face, shall have

exhibited thereon the Parking Zone in which the Resident Visitor Voucher is valid, the registration mark of the vehicle in respect of which the voucher is to be used and the date and time, to the nearest fifteen minutes, at which the vehicle is first left in a Parking Place; and further provided that:-

- (a) at all times during the Controlled Hours when a vehicle in respect of which a Resident Visitor Voucher has been validated is left in a Parking Place, there shall be displayed in the Relevant Position that Resident Visitor Voucher together with a Valid Tax Disc without which the Voucher will not be valid.
- (b) the vehicle in respect of which a Resident Visitor Voucher has been validated has been left in a Parking Place for a period of time during the Controlled Hours up to but not exceeding 10.00am on the day following its validation.
- (c) the vehicle in respect of which a Resident Visitor Voucher has been validated is a vehicle of a class specified in Article 27(1)
- Where a book of Resident Visitor Vouchers are issued to any Resident upon receipt of a payment and the payment is subsequently dishonoured, the book of Resident Visitor Vouchers shall cease to be of any effect and the Council shall, by notice, require that person to surrender the book of Resident Visitor Permits within seventy-two hours of the delivery of the aforementioned notice.
- Once a Resident Visitor Voucher is validated to include the registration mark of the vehicle in accordance with Article 55(1), that voucher may not be transferred to another vehicle.

Form Of Resident Visitor Voucher

- 58 (1) A Resident Visitor Voucher shall be in writing and shall include the following particulars:-
 - (a) the registration mark of the vehicle in respect of which the Resident Visitor Voucher is valid; and
 - (b) a serial number; and
 - (c) the Parking Zone in which the Resident Visitor Voucher is valid; and
 - (d) the date upon which the Resident Visitor Voucher is valid; and
 - (e) an indication that the Resident Visitor Voucher has been issued by the Council.

Operational Permits

- 59 (1) For the purpose of administering operational Permits the Council may define by name or unique reference code such Parking Zones as the Council at its absolute at its direction deem necessary.
 - (2) The names, unique reference codes and roads or lengths of roads, which comprise each Parking Zone, shall be as detailed in Schedules 2 to 9 inclusive

Operational Permit To Be Displayed On Vehicles Left In Parking Places

At all times during the Controlled Hours when a vehicle in respect of which an operational Permit has been issued, is left in a Parking Place, there shall be displayed in the Relevant Position that operational Permit issued in respect of that vehicle.

Application For; And Issue Of Operational Permit

- 61 (1) Any person, giving professional personal care to a Resident within the Controlled Parking Zone who is the Owner of a vehicle may apply to the Council for the issue of an operational Permit in respect of that vehicle and any such application shall be made on a form issued by and obtainable from the Council and shall include the particulars and information required by such form to be supplied.
 - (2) (a) The Council may at any time require an applicant for an operational Permit to provide such evidence in respect of such application as they may reasonably call for to verify any particulars or information given to them.
 - (b) The Council may at any time require an operational Permit holder to provide such evidence in respect of any Permit issued to the operational Permit holder as they may reasonably call for to verify that such operational Permit is valid.
 - (3) (a) Upon receipt of an application duly made under the foregoing provisions of this Article and upon receipt of the appropriate charge specified in Schedule 23, the Council, upon being satisfied that the applicant is a professional personal carer and is the Owner of a vehicle, and that the use of an operational Permit would be for the benefit of a Resident within the Controlled Parking Zone by virtue of providing personal professional care to a Resident in their home may issue to the applicant thereof an operational Permit.
 - (b) Such an operational Permit shall allow for the leaving during the Controlled Hours in a Parking Place in the Parking Zone to which such operational Permit relates, of a vehicle by the Owner or by any person with the consent of said Owner other

than a person to whom such vehicle has been let for hire or reward.

- (c) Provided that the Council shall not issue an operational Permit to any personal Professional Carer, which would be valid for any period during which any other operational Permit, would be valid unless at the absolute discretion of the Council, a specific exception is made.
- (4) In the case of an application for which an operational Permit, if issued, would on the day on which it first becomes valid, be the only Permit issued to the Professional Carer, the charge shall be as specified in Schedule 23 or as may be prescribed from time to time by the Council.
- (5) The Council, at its total discretion, reserves the right to either issue an operational Permit, refuse to issue an operational Permit or to withdraw such a Permit if it appears appropriate to them at the time.
- (6) The operational Permit shall be valid from the day it is issued by the Council unless the applicant requests such other date as the Council may approve.
- (7) The operational Permit shall remain valid for a period of one year commencing on the first day of the month in which the operational Permit first becomes valid.

Refund Of Charge Paid In Respect Of An Operational Permit

- 62 (1) An operational Permit holder who surrenders an operational Permit to the Council before it becomes valid shall be entitled a full refund of any charge paid in respect thereof.
 - (2) An operational Permit holder who surrenders an operational Permit to the Council after it becomes valid shall be entitled to a refund of part of the charge paid in respect thereof in accordance with the provisions of Part (3) of this Article.
 - (3) The part of the charge which is refundable under the provisions of Part (2) of this Article shall be calculated pro rata on the remaining complete days for which the Permit being surrendered would have remained valid less an administrative charge as specified in Schedule 23.

Lost Or Destroyed Permit

If a Permit is lost or destroyed the Permit holder may apply to the Council for the issue of a duplicate and the Council, on being satisfied as to the loss or destruction shall upon payment of an administrative charge specified in Schedule 23 or as may be prescribed from time to time by the Council, issue a duplicate Permit so marked and upon such issue the Permit which it duplicated shall become invalid.

Mutilated Or Defaced Permit

If a Permit is mutilated, defaced or otherwise becomes illegible the Permit holder shall surrender the Permit to the Council for the issue of a duplicate and the Council shall upon being satisfied as to the veracity of the Permit and upon payment of an administrative charge as specified in Schedule 23 or as may be prescribed from time to time by the Council, issue a duplicate Permit so marked and upon such issue the Permit which it duplicated shall become invalid.

Surrender, Withdrawal And Validity Of Operational Permit

- An operational Permit holder may surrender an operational Permit to the Council at any time and shall surrender an operational Permit to the Council on the occurrence of any one of the events set out in Part (3) of this Article or in accordance with the provisions of Part (4) of this Article.
 - (2) The Council may, by notice, withdraw an operational Permit if it appears to the Council that any of the events set out in Part (3) of this Article have occurred and the operational Permit holder shall surrender the Permit to the Council within seventy-two hours of the delivery of the aforementioned notice.
 - (3) The events referred to in the foregoing provisions of this Article are:
 - (a) the operational Permit holder ceasing to be employed as a Professional Carer in the Parking Zone in respect of which the operational Permit was issued;
 - (b) the operational Permit holder ceasing to be the Owner of the vehicle in respect of which the operational Permit was issued;
 - (c) the vehicle in respect of which such operational Permit was issued ceasing to display a Valid Tax Disc for that vehicle;
 - (d) the issue of a duplicate operational Permit by the Council under the provisions of this Order;
 - (e) the operational Permit ceasing to be valid pursuant to the provisions of Part (4) of this Article.
 - (4) Where an operational Permit is issued to any person upon receipt of a payment and the payment is subsequently dishonoured, the operational Permit shall cease to be of any effect and the Council shall, by notice, require that person to surrender the operational Permit to the Council within seventy-two hours of the delivery of such notice.

Form Of Operational Permit

- An operational Permit shall be in writing and shall include the following particulars:-
 - (a) the registration mark of the vehicle in respect of which the operational Permit has been issued; and
 - (b) a serial number; and
 - (c) the Parking Zone in which the operational Permit is valid; and
 - (d) the last date on which the operational Permit is valid; and
 - (e) an indication that the operational Permit has been issued by the Council.

Change Of Vehicle By Permit Holder

In the event of the Permit holder disposing of the vehicle in respect of which the Permit has been issued and acquiring another vehicle, the Council shall on surrender of the Permit by the Permit holder and upon payment of such administrative charge as specified in Schedule 23 or as may be prescribed from time to time by the Council, issue a replacement Permit having the same expiry date and validity as the original Permit.

Class Of Vehicles In Respect Of Which A Resident Visitor Permit May Be Issued

- 68 (1) The class of vehicles in respect of which a Resident Visitor Permit may be issued shall be:
 - (a) Passenger Vehicles,
 - (b) Motor Cycles, or
 - (c) Goods Vehicles.
 - (2) Notwithstanding the provisions of Part (1) of this Article, the overall height and length of a vehicle may be exceeded in exceptional or special circumstances at the absolute discretion of the Council.

Resident Visitor Permit To Be Displayed On Vehicles Left In Parking Places

At all times during the Controlled Hours when a visitor's vehicle is left in a Parking Place, there shall be displayed in the Relevant Position that Resident Visitor Permit issued to the Resident whom that visitor is visiting together with a Valid Tax Disc without which the Permit will not be valid.

Application For; And Issue Of Resident Visitor Permit

- 70 (1) Any Resident of an address specified in Part I of Schedule 9 may apply to the Council for the issue of a Resident Visitor Permit for the parking by a visitor of the visitor's vehicle and any such application shall be made on a form issued by and obtainable from the Council and shall include the particulars and information required by such form supplied.
 - (2) (a) The Council may at any time require an applicant for a Resident Visitor Permit to provide such evidence in respect of such application as they may reasonably call for to verify any particulars or information given to them.
 - (b) The Council may at any time require a Resident Visitor Permit Holder to provide such evidence in respect of any Permit issued to the Resident Permit Holder as they may reasonably call for to verify that such Resident Visitor Permit is valid.
 - (3) (a) Upon receipt of an application duly made under the foregoing provisions of this Article and upon receipt of the appropriate charge specified in Part (4) of this Article, the Council, upon being satisfied that the applicant is a Resident of an address specified in Part I of Schedule 9, may issue to the applicant thereof one Resident Visitor Permit valid only in Parking Zone H.
 - (b) Such Resident Visitor Permit shall allow for the leaving of the visitor's vehicle in a Parking Place in Parking Zone H other than a vehicle which has been let for hire or reward provided that the Council shall not issue a Resident Visitor Permit to any Resident:-
 - (i) which would be valid for any period during which any other Permit issued to that Resident is or would be valid: or
 - (ii) if there is in force a Resident Permit which relates to the postal address of which an application for a Resident Visitor Permit has been made or received by the Council; or
 - (iii) if there exists a parking space within the curtilage of the Resident's postal address.
 - (c) At no time shall more than one current and valid Resident Visitor Permit be issued to any postal address in respect of which an application may be made or received.
 - (4) The charge for a Resident Visitor Permit shall be as specified in Schedule 23 or as may be prescribed from time to time by the Council.

- (5) The Council, at its total discretion, reserves the right to either issue a Resident Visitor Permit, refuse to issue a Resident Visitor Permit or to withdraw such a Permit if it appears appropriate to them at the time.
- (6) The Permit shall be valid from the day it is issued by the Council unless the applicant requests such other date as the Council may approve.
- (7) The Permit shall remain valid for a period of one year or one month, whichever shall be appropriate, commencing on the first day of the month in which the Permit first becomes valid.
- (8) Any visitor Permit applied for and issued before the Operational Date under the provisions of the Buckinghamshire County Council (Aylesbury Old Town)(Prohibition of Waiting and Parking Places With Permits) Order, 2000, shall remain valid as if the said Order had not been revoked by this Order, until such time as the Permit may expire or be surrendered, withdrawn or revoked under the provisions of the said Order and any subsequent application for a Permit shall be made under the provisions of this Order.

Refund Of Charge Paid In Respect Of A Resident Visitor Permit

- 71 (1) A Resident Visitor Permit Holder who surrenders a Resident Visitor Permit to the Council before it becomes valid shall be entitled a full refund of any charge paid in respect thereof.
 - (2) A Resident Visitor Permit Holder who surrenders a Resident Permit to the Council after it becomes valid shall be entitled to a refund of part of the charge paid in respect thereof in accordance with the provisions of Part (3) of this Article.
 - (3) The part of the charge which is refundable under the provisions of Part (2) of this Article shall be calculated pro rata on the remaining whole days for which the Permit being surrendered would have remained valid less an administrative charge as specified in Schedule 23.

Lost Or destroyed Permit

If a Permit is lost or destroyed the Permit holder may apply to the Council for the issue of a duplicate and the Council, on being satisfied as to the loss or destruction shall upon payment of an administrative charge as specified in Schedule 23 or as may be prescribed from time to time by the Council, issue a duplicate Permit so marked and upon such issue the Permit which it duplicated shall become invalid.

Mutilated Or Defaced Permit

If a Permit is mutilated, defaced or otherwise becomes illegible the Permit holder shall surrender the Permit to the Council for the issue of a duplicate and the Council shall upon being satisfied as to the veracity of the Permit and upon payment of an administrative charge as specified in Schedule 23 or as may be prescribed from time to time by the Council, issue a duplicate Permit so marked and upon such issue the Permit which it duplicated shall become invalid.

Surrender, Withdrawal And Validity Of Resident Permit

- A Resident Visitor Permit Holder may surrender a Resident Visitor Permit to the Council at any time and shall surrender a Resident Visitor Permit to the Council on the occurrence of any one of the events set out in Part (3) of this Article or in accordance with the provisions of Part (4) of this Article.
 - (2) The Council may, by notice, withdraw a Resident Visitor Permit if it appears to the Council that any of the events set out in Part (3) of this Article have occurred and the Resident Visitor Permit Holder shall surrender the Permit to the Council within seventy-two hours of the delivery of the aforementioned notice.
 - (3) The events referred to in the foregoing provisions of this Article are:
 - (a) the Resident Visitor Permit Holder ceasing to be a Resident of the addresses specified in Part I of Schedule 9; or
 - (b) the vehicle in respect of which such Resident Visitor Permit is displayed in accordance with Article 68(1) being adapted or used in such a manner that it is not a vehicle of the class specified in Article 68(1); or
 - (c) the vehicle in respect of which such Resident Visitor Permit is displayed in accordance with Article 69 ceasing to display a Valid Tax Disc for that vehicle; or
 - (d) the Resident Visitor Permit ceasing to be valid pursuant to the provisions of Part (4) of this Article.
 - (4) Where a Resident Visitor Permit is issued to any person upon receipt of a cheque or credit card and the payment is subsequently dishonoured, the Resident Visitor Permit shall cease to be of any effect and the Council shall, by notice, require that person to surrender the Resident Visitor Permit to the Council within seventy-two hours of the delivery of such notice.

Form Of Resident Visitor Permit

- A Resident Visitor Permit shall be in writing and shall include the following particulars:-
 - (a) a serial number; and
 - (b) the Parking Zone in which the Resident Visitor Permit is valid; and
 - (d) the last date on which the Resident Visitor Permit is valid; and
 - (e) an indication that the Resident Permit has been issued by the Council.

Service Of Notice

Any Notice in pursuance of this Order shall be given in writing addressed to the applicant for, holder of or former holder of the Permit concerned and left at or sent by the recorded delivery service to the address given upon the relevant application form for the Permit or to any other place believed to be that person's place of abode.

Spaces Reserved For Disabled Person's Vehicles

- 77 (1) Save as provided for in Article 16 no person shall, except upon the direction or with the permission of a Police Constable in uniform or a Parking Attendant, cause or permit any vehicle to wait:-
 - (a) at any time in any part of the Parking Places specified in Part I of Schedule 22, except for a Disabled Person's Vehicle, which displays in the Relevant Position a Disabled Person's Badge.
 - (b) between the hours of 8.00 am to 6.30 pm in any part of the Parking Places specified in Part II of Schedule 22, except for a Disabled Person's Vehicle which displays in the Relevant Position a Disabled Person's Badge.
 - (2) Nothing in the foregoing provisions of this Article shall render it unlawful to cause or permit any vehicle to wait in a Parking Place specified in this Article, provided that it is waiting in accordance with any one of Paragraphs (a) and (b) of Part (1) of Article 7 to this Order.
