



THE ESSEX COUNTY COUNCIL (BASILDON BOROUGH) (PROHIBITION OF WAITING, LOADING AND STOPPING) AND (ON-STREET PARKING PLACES) (CIVIL ENFORCEMENT AREA) AMENDMENT NO.2 ORDER 2020

NOTICE IS HEREBY GIVEN that Chelmsford City Council acting on behalf of the South Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an agreement dated 31 March 2011 (and subsequently varied by Deed of Variation on 15 June 2011 and 27 July 2012) has made the above Order under Sections 1(1), 2 (1) to (3), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984.

Effect of the Order:

All measurements are taken as accurately as possible and are taken from the extended kerb line unless stated otherwise.

1. To revoke 'All Parking Restrictions' on the following length of road in the Borough of Basildon:

Perry Street, Billericay	Both sides – from the roundabout with Gooseberry Green north-eastwards to a point 17 metres northeast of its junction with Knightbridge Walk.

Perry Street, Billericay	South side – from a point 15 metres east of its junction with Lakeside westwards for 35 metres. Northwest side – from a point 1 metre southwest of its junction with Upland Road south-westwards for 10 metres.
