



THE ESSEX COUNTY COUNCIL (BASILDON BOROUGH) (PROHIBITION OF WAITING, LOADING AND STOPPING) AND (ON-STREET PARKING PLACES) (CIVIL ENFORCEMENT AREA) (AMENDMENT NO. 23) ORDER 2023

NOTICE IS HEREBY GIVEN that Chelmsford City Council acting on behalf of the South Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an agreement dated 31 March 2011 (and subsequently varied by Deed of Variation on 15 June 2011 and 27 July 2012) has made the above Order under Sections 1(1), 2 (1) to (3), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984.

Effect of the Order:

All measurements are taken as accurately as possible and are taken from the extended kerb line unless stated otherwise.

1. To revoke all waiting and parking restrictions on the following lengths of roads in the Borough of Basildon and substitute with those listed in the below Articles:

Emanuel Road, Laindon, Basildon	Both sides: From its junction with Berry Lane eastwards to its junction with High Road.
Vowler Road, Langdon Hills, Basildon	Both sides: From its junction with Berry Lane eastwards to its junction with High Road.
Great & Little Oxcroft, Laindon, Basildon	Both sides: From a point 2.5 metres southeast of the boundary between Nos. 48 & 49 Little Oxcroft north-westwards, then northwards and north-eastwards to its junction with Hatterill including the access roads to, and including, the parking areas, on the eastern & southern sides of Hatterill, and including the parking area between Nos.50 & 51.
Bedford Road, Laindon, Basildon	Both sides: From a point 15 metres south of its junction with Somerset Road southwards to a point 15 metres north of its junction with Durham Road.

2. To introduce 'Permit Parking Area, Zone C, Mon – Fri 10am – 2pm' on the following lengths of roads in the Borough of Basildon:

Emanuel Road, Laindon, Basildon	Both Sides: From a point 15 metres east of its junction with Berry Lane eastwards to a point 15 metres west of its junction with High Road.
Vowler Road, Langdon Hills, Basildon	North Side: From a point 15 metres east of its junction with Berry Lane eastwards to a point 15 metres west of its junction with High Road. South Side: From a point 12 metres east of its junction with Berry Lane eastwards to a point 15 metres west of its junction with High Road.
Great & Little Oxcroft, Laindon, Basildon	Both sides: From a point 2.5 metres southeast of the boundary between Nos. 48 & 49 Little Oxcroft north-westwards, then northwards and north-eastwards to its junction with Hatterill including the access roads to, and including, the parking areas, on the eastern & southern sides of Hatterill, and including the parking area between Nos.50 & 51.
Bedford Road, Laindon, Basildon	Both Sides: From a point 15 metres south of its junction with Somerset Road southwards to a point 15 metres north of its junction with Durham Road.

3. To introduce 'Permit Parking Zone C, Mon – Fri 10am – 2pm' on the following lengths of road in the Borough of Basildon:

Great & Little Oxcroft, Laindon, Basildon	Southwest Side: From a point 15 metres northwest of its junction with Hatterill, north-westwards for 20 metres.

4. To introduce 'No Waiting at Any Time' on the following lengths of roads in the Borough of Basildon:

Emanuel Road, Laindon, Basildon	Both Sides: From its junction with Berry Lane, eastwards for 15 metres. Both Sides: From its junction with High Road, westwards for 15 metres.
Vowler Road, Langdon Hills, Basildon	North Side: From its junction with Berry Lane eastwards for 15 metres. South Side: From its junction with Berry Lane eastwards for 12 metres. Both Sides: From its junction with High Road, westwards for 15 metres.
Great & Little Oxcroft, Laindon, Basildon	Southwest Side: From its junction with Hatterill north-westwards for 15 metres. Southwest Side: From a point 35 metres north-westwards with its junction with Hatterill north-westwards for 17 metres. Northeast Side: From its junction with Hatterill north-westwards for 50 metres. <u>Within the permit parking area</u> Both Sides: From a point 37 metres northwest of its junction with High Road for 4 metres. Both Sides: From a point 79 metres northwest of its junction with High Road for 4 metres. Both Sides: From a point 305 metres north-westwards & northwards of its junction with High Road for 4 metres.

5. To revoke 'Permit Holders Only, Zone D' and introduce 'Disabled Permit Holder BAS014 Only' on the following length of road in the Borough of Basildon:

Priors Close, Basildon	South side – from a point 2 metres west of the boundary of Nos 86 & 88 Pinmill eastwards for 7 metres, a bay measuring 2.5 metres x 7 metres.

Date of operation: This Order will come into operation on **20 February 2023**.

Application to the High Court: Anyone who wishes to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of that Act, or any instrument made under it, has not been complied with in relation to the Order, may within six weeks from the making of the Order apply to the High Court for this purpose.

The Chelmsford City Council acting on behalf of the South Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an agreement dated 31 March 2011 (and subsequently varied by Deed of Variation on 15 June 2011 and 27 July 2012) and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") hereby makes the following Order under Sections 1(1), 2(1) to (3), 4(1) 4(2), 32(1), 35(1), 45, 46, 49, 53 and Part IV of Schedule 9 of the Act and of all other enabling powers.

1. This Order shall come into operation for all purposes on the 20th day of February 2023 and may be cited as The Essex County Council (Basildon Borough) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.23), Order 2023.
