

COUNTY COUNCIL OF AVON

(CITY OF BATH) (CENTRAL AREA) (STREET PARKING PLACES)
(CONSOLIDATION) (VARIATION NO. 1) ORDER 1987

The County Council of Avon (hereinafter referred to as "the Council") in exercise of its powers under sections 32(1) and 35(1) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- 1 This Order shall come into operation on 19th October 1987 and may be cited as the County Council of Avon (City of Bath) (Central Area) (Street Parking Places) (Consolidation) (Variation No.1) Order 1987.
- 2 The County Council of Avon (City of Bath) (Central Area) (Street Parking Places) (Consolidation) Order 1986 is hereby varied and shall have effect as though:
 - a) in Article 2 (1) thereof there were substituted for the expressions relating to "goods vehicle" and "heavy goods vehicle" the following expressions respectively:

"goods vehicle" means a motor vehicle constructed or adapted for use for the carriage of goods, or a trailer so constructed or adapted, the maximum laden weight of which does not exceed two tonnes;" and

"heavy goods vehicle" means a motor vehicle constructed or adapted for use for the carriage of goods, or a trailer so constructed or adapted, the maximum laden weight of which exceeds two tonnes;".
 - b) in Schedule 1 thereto the items as numbered in column 1 of the Schedule to this Order relating to the road indicated in relation to that number in column 2 of the Schedule to this Order were omitted.
