(HALLATROW ROAD, B.3355, HALLATROW, DISTRICT OF WANSDYKE)

(RESTRICTED ROADS) ORDER 1986

The County Council of Avon (hereinafter referred to as "the Council") in exercise of its powers under sections 82(2) and 83(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order may be cited as the County Council of Avon (Hallatrow Road, B.3355, Hallatrow, District of Wansdyke) (Restricted Roads) Order 1986 and shall come into operation on 19th May 1986
2. The County Council of Somerset (Built-up Areas) No. 2 Order, 1937 by virtue of which the length of road specified in Schedule 1 to this Order became a restricted road for the purposes of section 81 of the Act of 1984 is hereby revoked to the extent that it relates to the said length of road.
3. The lengths of road specified in Schedule 2 to this Order shall be restricted roads for the purposes of section 81 of the Act of 1984.

Schedule 2

Lengths of road at Hallatrow in the District of Wansdyke in the County of Avon

1. That length of Hallatrow Road, B3355 (Hallatrow to Paulton) which extends from its junction with the Bath to Wells road (A39) in a south-easterly direction for a distance of 360 metres.
2. The whole length of the spur of Hallatrow Road, B.3355 (Hallatrow to Paulton) south-east of the junction with the Bath to Wells road (A39) which extends from its junction with Hallatrow Road, B.3355 in a northerly direction for a distance of 65 metres.
