

COUNTY COUNCIL OF AVON(A4 LONDON ROAD, OUTER AREA, CITY OF BATH) (RESERVED BUS LANES)
(PEAK HOURS) (PROHIBITION AND RESTRICTION OF WAITING)
(VARIATION) ORDER 1995

The County Council of Avon (hereinafter referred to as "the Council") in exercise of its powers under sections 1(1), 2(1) to (3) and 4(1) and (2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended (hereinafter referred to as "the Act of 1984") and of all other enabling powers, after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following order:-

1. This order shall come into operation on the 21st August 1995 and may be cited as the County Council of Avon (A4 London Road, Outer Area, City of Bath) (Reserved Bus Lanes) (Peak Hours) (Prohibition and Restriction of Waiting) (Variation) Order 1995.
2. The County Council of Avon (A4 London Road, Outer Area, City of Bath) (Reserved Bus Lanes) (Peak Hours) Order 1995 is hereby varied and shall have effect as though:-
 - a) in in paragraph (1) of Article 2 thereto, the definition of "bus lane 4" were omitted;
 - b) in Article 4 thereto, the words and number "or bus lane 4" were omitted;
 - c) in in paragraph (1) of Article 5 thereto, the words and number "or bus lane 4" were omitted;
 - d) in Article 5 thereto, there were substituted for the sub-paragraph numbered (ii) in paragraph (3) thereof the following sub-paragraph (ii), namely:-

" (ii) in a north easterly direction in bus lane 2 or bus lane 3 - ";
 - e) in Article 5 thereto, there were inserted after the paragraph numbered (4) the following additional paragraph numbered (5), namely:-

" (5) Nothing in this order shall render it unlawful for any person to cause or permit any ambulance to enter or proceed in any of the bus lanes in the direction specified in relation to that bus lane in paragraph (3) of this Article whilst it is in execution of official duties."; and
 - f) in Article 6 thereto, the words and number "and bus lane 4" were omitted.
