# BATH AND NORTH EAST SOMERSET COUNCIL

## (VARIOUS ROADS, BATH) (BUS LANES) (VARIATION) ORDER 2013

The Bath and North East Somerset Council ("the Council") in exercise of its powers under sections 1, 2 and 4 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended ("the 1984 Act") and of all other enabling powers, after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the 1984 Act, makes the following Order: -

1. This Order shall come into operation on 2<sup>nd</sup> August 2013 and may be cited as the Bath and North East Somerset Council (Various Roads, Bath) (Bus Lanes) (Variation) Order 2013.

From a point 50 metres west of the eastern kerbline of Northgate Street to its junction with Northgate Street, which is bounded on the southern side by the southern kerbline of New Bond Street as shown on the plan headed **Northgate** Street.

From a point 40 metres south of its junction with Upper Borough Walls to its junction with Northgate Street, which is bound on the western side by the western kerbline of High Street as shown on the plan headed **Northgate Street**.

From a point 20 metres south of its junction with Upper Borough Walls to its junction with Northgate Street, which is bound on the western side by the western kerbline of High Street as shown on the plan headed **Northgate Street**.
