

BEDFORDSHIRE COUNTY COUNCIL (BEDFORD CONTROLLED PARKING ZONE)

(PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING

PLACES) ORDER 2008 (AMENDMENT NO 1) ORDER 2009

Bedfordshire County Council, pursuant to arrangements made under Section 101 of the Local Government Act 1972 with Bedfordshire County Council, in exercise of the powers conferred under Sections 1(1), 2(1) to 2(3), 4(2), 9 (iv) 32, 35, 35A, 35B, 35C, 36, 45, 46, 47, 49, 51, 53, 99 and 101 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) (the 1984 Act), and The Road Traffic (Permitted Parking Area and Special Parking Area) (County of Bedfordshire) (Borough of Bedford) Order 2000, and after consultation with the Chief Officer of Bedfordshire Police, hereby make the following Order.

The Bedfordshire County Council (Bedford Controlled Parking Zone) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2008 shall have effect subject to the following amendments:-

Article 3 (1) Interpretation

Add to Article 3 (1)

“School Keep Clear” means a part of the carriageway outside a school entrance where vehicles must not stop as specified on the Plans.

Article 56      Period for which vehicle may be left after penalty charge notice affixed to vehicle.

Add 56 (1) (f)

56 (1) (f)      Where the vehicle is left within a parking place listed in Schedule 8 thirty minutes.

Section 11 – Revocation

Existing restrictions within the CPZ to be revoked.

Add to Article 99

99 The North Bedfordshire Borough Council (Various Roads, Bedford) (Prohibition and Restriction of Waiting, Loading and Unloading) Consolidation Order 1992 as amended is hereby revoked insofar as it relates to streets within the Bedford Controlled Parking Zone specified in Schedule 1 as amended by this Order.

Section 12 – Controlled Parking Zone Schedules

Schedule 1 – Identification of streets within the Controlled Parking Zone

<b>Streets within the Controlled Parking Zone</b>
Pemberley Avenue
St. Andrews Road (From it's junction with Pemberley Avenue to a point 10 meters north of it's junction with Pemberley Avenue).

Schedule 2 – Resident Permit Schemes

Add to Schedule 2

**Zone H – List of streets where residents are eligible for resident's permits and visitor permits (all properties except new developments of flats/apartments constructed after 1<sup>st</sup> April 2008) and list of streets where Zone H permits are valid.**

Residents having an address in a street described in this column may purchase a resident permit bearing the above identification letter (subject to above)	Streets in which a resident permit bearing the above identification letter may be used to park without time limit or further payment in designated parking spaces

Schedule 5 – Identification of streets having a pay and display parking period limited to 4 hours.

Schedule 8 – Identification of streets having a pay and display parking period limited to 30 minutes.

Charging hours Monday – Saturday 9am – 5pm

Maximum stay – 30 minutes

No return within 1 hour

(Vehicles displaying a valid permit no maximum stay no restriction on returns)

This Amendment shall be read and construed as one with the Bedford Controlled Parking Zone Order 2008.

This Order shall come into force on 6th day of April 2009 and may be cited as the "Bedfordshire County Council (Bedford Controlled Parking Zone) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2008 (Amendment No 1) Order 2009".

The above Order amends the following plans, which form part of the "Bedfordshire County Council (Bedford Controlled Parking Zone) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2008":

(i) "Grid Ref: K23: Sheet Revision No 1" shall be added to the plans attached to the Order.

(ii) "Grid Ref: K24: Sheet Revision No 1" shall be deleted and "Grid Ref: K24: Sheet Revision No 2" shall be substituted.


