

**BEDFORD BOROUGH COUNCIL (BEDFORDSHIRE COUNTY COUNCIL
(BEDFORD CONTROLLED PARKING ZONE)) (PROHIBITION AND
RESTRICTION OF WAITING AND LOADING AND PARKING PLACES)
ORDER 2008 (AMENDMENT NO 3) ORDER 2009**

Bedford Borough Council, pursuant to arrangements made under Section 101 of the Local Government Act 1972 with Bedford Borough Council, in exercise of the powers conferred under Sections 1(1) and (2), 2 (1) to 2(3), 4 (2), 9 (iv) 32, 35, 36, 53, 99 and 101 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) (the 1984 Act), and of all other enabling powers and after consultation with the Chief Officer of Bedfordshire Police, hereby make the following Order.

The Bedfordshire County Council (Bedford Controlled Parking Zone) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2008 as amended shall have effect subject to the following amendments:-

Article 3 (1) Interpretation

Add to Article 3 (1)

“permit holder” means a person to whom a permit has been issued under the provisions of this Order.

“Road” and “Street” have the same meaning for the purposes of this Order.

“wait” and “waiting” refer to the stopping of a vehicle and it remaining at rest for some time whether or not the driver is still in the vehicle.

Article 34

Delete the existing entry in its entirety and substitute with

34 A pay and display ticket is valid only in the parking place in respect of which it was issued. This is defined by the identification on the parking ticket machine located in respect of that parking place and the information printed on the pay and display ticket.

Add to Article 35

35 A contravention shall have occurred when during the permitted hours, a vehicle is left within a pay and display place after the time purchased has expired.

Add 56 (1) (g)

56 (1) (g) Where the vehicle is left within a parking place listed in Schedule 9 fifteen minutes.

Section 11 – Revocation

Existing restrictions within the CPZ to be revoked

Add to Article 99

The North Bedfordshire Borough Council (Various Roads, Bedford) Prohibition and Restriction of Waiting, Loading and Unloading) Consolidation Order 1992 as amended is hereby revoked insofar as it relates to streets within the Bedford Controlled Parking Zone specified in Schedule 1 as amended by this Order.

Schedule 2 – Resident Permit Schemes

Zone K – List of streets where residents are eligible for resident’s permits and visitor permits (all properties except new developments of flats/apartments constructed after 1st April 2008) and list of streets where zone K permits are valid.

Residents having an address in a street described in this column may purchase a resident permit bearing the above identification letter (subject to above)	Streets in which a resident permit bearing the above identification letter may be used to park without time limit or further payment in designated parking spaces

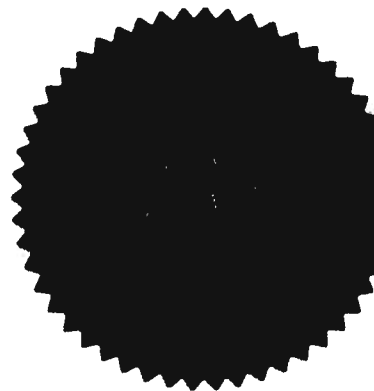
This Amendment shall be read and construed as one with the Bedford Controlled Parking Zone Order 2008.

The Order shall come into force on 30th November 2009 and may be cited as the "Bedford Borough Council (Bedfordshire County Council (Bedford Controlled Parking Zone)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2008 (Amendment No 3) Order 2009".

The above Order amends the following plans, which form part of the "Bedfordshire County Council (Bedford Controlled Parking Zone) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2008".

- (i) "Grid Reference H26 Sheet Revision No 1" shall be deleted and "Grid Reference H26 Sheet Revision No 2" shall be substituted
- (ii) "Grid Reference I24 Sheet Revision No 1" shall be deleted and "Grid Reference I24 Sheet Revision No 2" shall be substituted
- (iii) "Grid Reference I25 Sheet Revision No 1" shall be deleted and "Grid Reference I25 Sheet Revision No 2" shall be substituted
- (iv) "Grid Reference J24 Sheet Revision No 1" shall be deleted and "Grid Reference J24 Sheet Revision No 2" shall be substituted
- (v) "Grid Reference J25 Sheet Revision No 1" shall be deleted and Grid Reference J25 Sheet Revision No 2" shall be substituted
