ORDER 2008 (AMENDMENT NO 12) ORDER 2011**


BEDFORD BOROUGH COUNCIL in exercise of the powers under Section 1(1), 2(1), to (3) and 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:


1. This Order shall come into operation on the 17th October 2011 and may be cited as "Bedford Borough Council (Bedfordshire County Council (Bedford Controlled Parking Zone) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2008 (Amendment No 12) Order 2011"
2. As from the date upon which the Order comes into operation, the provisions of the "Bedfordshire County Council (Bedford Controlled Parking Zone) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2008 as amended" shall be varied as follows:
 - (i) The plan schedule reference "Grid Reference K26 Revision 3" shall be deleted and "Grid reference K26 Revision No 4" shall be substituted.
 - (ii) The plan schedule reference "Grid Reference J28 Revision No 4" shall be deleted and "Grid Reference J28 Revision No 5" shall be substituted

Statement of Reasons

The three existing Taxi stands at the southern end of De Parys Avenue and in the northern slip road of The Broadway, Bedford could be utilised better by allowing shared use dependent on the time of day. This proposed Order will change these areas to provide a short length of Loading only at any time (with a 15 min max stay, no return within 30 minutes) and to provide areas where taxis will have use late at night (9:30pm – 4:30am) and where from Monday to Saturday disabled badge holder only parking will apply during the day.

The proposed change will enable the areas to be available to a wider range of users. The shared use areas will be unrestricted during the day on Sundays.
