

## BEDFORD BOROUGH COUNCIL (BEDFORD URBAN AREA (SOUTH OF THE RIVER AND QUEENS PARK)) (PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES) ORDER 2009 (AMENDMENT NO. 14) ORDER 2014

Bedford Borough Council, pursuant to arrangements made under Section 101 of the Local Government Act 1972 with Bedford Borough Council, in exercise of the powers conferred under Sections 1(1) and (2), 2 (1) to 2(3), 4 (2), 9 (iv) 32, 35, 36, 59, 99 and 101 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) (the 1984 Act), and of all other enabling powers and after consultation with the Chief Officer of Bedfordshire Police, hereby make the following Order.

The Bedford Borough Council (Bedford Urban Area (South of the River and Queens Park)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended shall have effect subject to the following amendments:-

- (iv) "Grid Ref: J31 Sheet Revision No 2" shall be deleted and "Grid Ref: J31 Sheet Revision No 3" shall be substituted.
- (v) "Grid Ref: J32 Sheet Revision No 2" shall be deleted and "Grid Ref: J32 Sheet Revision No 3" shall be substituted.
- (vi) "Grid Ref: J33 Sheet Revision No 1" shall be deleted and "Grid Ref: J33 Sheet Revision No 2" shall be substituted.
- (vii) "Grid Ref: J34 Sheet Revision No 1" shall be deleted and "Grid Ref: J34 Sheet Revision No 2" shall be substituted.
- (viii) "Grid Ref: K30 Sheet Revision No 1" shall be deleted and "Grid Ref: K30 Sheet Revision No 2" shall be substituted.
- (ix) "Grid Ref: K31 Sheet Revision No 1" shall be deleted and "Grid Ref: K31 Sheet Revision No 2" shall be substituted.

This Amendment shall be read and construed as one with the Bedford Borough Council (Bedford Urban Area (South of the River and Queens Park) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009.



This Order shall come into force on 16<sup>th</sup> June 2014 and may be cited as the "Bedford Borough Council (Bedford Urban Area (South of the River and Queens Park)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 (Amendment No. 14) Order 2014.

## STATEMENT OF REASONS

BEDFORD BOROUGH COUNCIL (BEDFORD URBAN AREA (SOUTH OF THE RIVER AND QUEENS PARK)) (PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES)
ORDER 2009 (AMENDMENT NO. 14) ORDER 2014

Bedford Borough Council has consulted with residents in the area with respect to residents struggling to find places to park near to their homes.

The introduction of the Controlled Parking Zone N, and the waiting restriction changes in this Order, aim to improve the parking provision for residents and improve the safety of the road for all road users at junctions and other places where parking would cause a safety concern. It also aims to reduce traffic congestion in roads where parking pressure is currently high.

Councillors and officers have considered all feedback received at all stages of the scheme design and various consultations, and feel this scheme best balances the needs of residents and the wider community.
