BEDFORD BOROUGH COUNCIL (BUS LANES AND BUS ONLY STREETS, THE BOROUGH OF BEDFORD) CONSOLIDATION ORDER 2014 (AMENDMENT NO. 1) ORDER 2015

Bedford Borough Council (the "Council") in exercise of the powers under sections 1(1) and (2), 2(1) and (2) and 4(1) of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:-

1. This Order shall come into operation on the 05th day of October 2015 and may be cited as the "Bedford Borough Council (Bus Lanes and Bus Only Streets, The Borough of Bedford) Consolidation Order 2014 (Amendment No.1) Order 2015".
2. From the date this Order comes into effect, the "Bedford Borough Council (Bus Lanes and Bus Only Streets, The Borough of Bedford) Consolidation Order 2014" shall take the following effect:

3. **Article 14**

Remove

Save as provided in Article 16 to this Order, no person shall cause or permit any mechanically propelled vehicle to be in the length of road specified in Schedule 2 to this Order and shown as restricted on the Plans to this Order during the its restricted hours.

And in its place Insert

Save as provided within Article 16 and specifically defined within Schedule 2 to this Order, no person shall cause or permit any vehicle to be in the length of road specified in Schedule 2 to this Order and shown as restricted on the Plans to this Order during the its restricted hours

4. **Schedule 2 – Identification of street forming a Bus Only Street**

Remove the existing Schedule 2 and

Insert with Schedule 2 as shown below.

5. As from the date upon which this Order comes into operation, the provision of the "Bedford Borough Council (Bus Lanes and Bus Only Streets, The Borough of Bedford) Consolidation Order 2014" shall be varied as follows:

- (i) The plan schedule reference "Grid Reference J27 Revision No 0" shall be deleted and "Grid Reference J27 Revision No 1" shall be substituted

This Amendment shall be read and construed as one with "Bedford Borough Council (Bus Lanes and Bus Only Streets, The Borough of Bedford) Consolidation Order 2014"
