OFF STREET PARKING PLACES NO.2 ORDER 2013

(AMENDMENT NO.3) ORDER 2016

Bedford Borough Council, (hereinafter referred to as "the Council") in exercise of the powers conferred under Sections 35(1) and (3) of the Road Traffic Regulation Act 1984 as amended ("the Act"), and The Civil Enforcement of Parking Contraventions (Bedford) Designation Order 2009, the Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Bedfordshire Police, hereby make the following Order.

1. This Order shall come into operation on the 04th July 2016 and may be cited as "Bedford Borough Council Off Street Parking Places No.2 Order 2013 (Amendment No.3) Order 2016"
2. As from the date upon which the Order comes into operation, the provisions of the "Bedford Borough Council Off Street Parking Places No.2 Order 2013" shall be varied as follows:

**Part 1 – Preliminary
Interpretation**

2.(1)

Insert the following:

"drop off only" means a parking bay which has been marked and intended for the sole use of dropping or collecting of passengers within the allotted time specified upon the corresponding traffic sign and where no payment for occupying the bay is required

**Part 4 - Charge for Use of Parking Places
Exemptions from parking charges**

16.

Insert the following:

(7) When a vehicle is parked within a drop off only parking bay only it shall be exempt from any parking charge

**Part 8 - Reserved parking places
Spaces reserved for particular classes of vehicle**

44.

Insert the following:

(8) Save as provided for in paragraphs (a) to (c) inclusive of Article 5 no person shall cause or permit any vehicle to wait at any time in any parking space marked for drop off only other than the purpose of dropping or collecting a passenger within the allotted time period specified upon the corresponding traffic sign






