**BIRMINGHAM CITY COUNCIL**  
**(PARKING PLACES AND CONTROLLED PARKING ZONE)**  
**(BIRMINGHAM) (CONSOLIDATION)**  
**(VARIATION) (NO. 8) ORDER 1997**

The Birmingham City Council ("the Council") in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46, 49, 53 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

1. The Order shall come into operation on the 31st day of March one thousand nine hundred and ninety-seven and may be cited as Birmingham City Council (Parking Places and Controlled Parking Zone) (Birmingham) (Consolidation) (Variation) (No. 8) Order 1997.
2. (i) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.  
(ii) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament. --
3. The Birmingham City Council (Parking Places and Controlled Parking Zone) (Birmingham) (Consolidation) Order 1995 as amended shall continue in full force and effect subject to the variations specified in the Schedule to this Order.

**SCHEDULE**

**Variations of The Birmingham City Council (Parking Places and Controlled Parking Zone) (Birmingham) (Consolidation) Order 1995**

In Article 2(1) of the Order the definition of a "parking meter" shall be deleted and the following definition shall be substituted:

" "parking meter" means apparatus designed to indicate the time by a clock and to issue a numbered parking ticket indicating the payment of a charge the period in respect of which it has been paid and the date and time at which the charge was paid."

In Article 8 sub-article "(1)(b)" and "(1)(c)" shall be deleted and the following sub-articles shall be substituted:

- "(1) (b) one pound and thirty pence (£1.30) for an initial period of not more than one hour; or  
(c) two pounds and fifty pence (£2.50) for an initial period of not more than two hours."

In Article 8 sub-article "(2)(c)" shall be deleted and the following sub-article shall be substituted:

- "(2) (c) one pound and twenty pence (£1.20) for an initial period of not more than four hours;"

Article 17 sub-article "(1)(b)", "(1)(c)" and "(2)" shall be deleted and the following sub-articles shall be substituted:

- (1) (b) where it is an amount of One Pound and thirty pence (£1.30), by the issue by the parking meter relating to the parking space in which the vehicle is left of a ticket indicating that the charge has been paid in respect of one hour and the day and time of payment of the charge, and by the display of that ticket on the vehicle in accordance with the provisions of Article 8(4) of this Order; and  
(c) where it is an amount of Two Pounds and fifty pence (£2.50), by the issue by the parking meter relating to the parking space in which the vehicle is left of a ticket indicating that the charge has been paid in respect of two hours and the day and time of payment of the charge, and by the display of that ticket on the vehicle in accordance with the provisions of Article 8(4) of this Order.

- (2) The expiry of the initial period for which the initial charge has been paid shall be indicated when there is exhibited on the vehicle a ticket issued by the parking meter relating to the parking space in which the vehicle is left showing the day and time of payment of the charge and the time shown by the clock on the said parking meter is more than thirty minutes, or as the case may be, one hour or, two hours later than the time shown on a ticket issued in respect of a payment of One Pound (£1.00) or more than one hour later or as the case may be two hours later than the time shown on a ticket issued in respect of a payment of One Pound and thirty pence (£1.30) or more than two hours later than the time shown on a ticket issued in respect of a payment of Two Pounds and fifty pence (£2.50)".

In Article 18 sub-article "(1)(c)" and "(2)" shall be deleted and the following sub-articles shall be substituted:

- "18. (1) (c) where it is an amount of One Pound and twenty pence (£1.20), by the issue by the parking meter relating to the parking space in which the vehicle is left of a ticket indicating that the charge has been paid in respect of four hours and the day and time of payment of the charge, and by the display of that ticket on the vehicle in accordance with the provisions of Article 8(4) of this Order.
- (2) The expiry of the initial period for which the initial charge has been paid shall be indicated when there is exhibited on the vehicle a ticket issued by the parking meter relating to the parking space in which the vehicle is left showing the day and time of payment of the charge and the time shown by the clock on the said parking meter is more than one hour or, as the case may be, two or four hours later than the time shown on a ticket issued in respect of a payment of thirty pence (30p) or more than two hours or as the case may be, four hours later than the time shown on a ticket in respect of a payment of fifty pence (50p). or more than four hours later than the time shown on a ticket issued in respect of a payment of One Pound and twenty pence (£1.20)."
