

BIRMINGHAM CITY COUNCIL (PARKING PLACES AND CONTROLLED PARKING ZONE) (BIRMINGHAM) (CONSOLIDATION) (VARIATION) (NO.9) ORDER 1998

The Birmingham City Council ("the Council") in exercise of its powers under Sections 1,2,4,32,35,45,46,49,and 53 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

- 1. The Order shall come into operation on the 11th day of May one thousand nine hundred and ninety-eight and may be cited as the Birmingham City Council (Parking Places and Controlled Parking Zone) (Birmingham) (Consolidation) (Variation) (No.9) Order 1998.
- 2. (i) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
 - (ii) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. The Birmingham City Council (Parking Places and Controlled Parking Zone) (Birmingham) (Consolidation) Order 1995 as amended shall continue in full force and effect subject to the variations specified in the Schedule to this Order.

SCHEDULE

Variations of The Birmingham City Council (Parking Places and Controlled Parking Zone) (Birmingham) (Consolidation) Order 1995

In Article 8 sub-article "(1)(b)" and "(1)(c)" shall be deleted and the following sub-articles shall be substituted:

- "(1) (b) one pound and forty pence (£1.40) for an initial period of not more than one hour; or
 - (c) two pounds and seventy pence (£2.70) for an initial period of not more than two hours."





In Article 8 sub-article "(2)(b)" and "(2)(c)" shall be deleted and the following sub-articles shall be substituted:

- "(2) (b) sixty pence (60p) for an initial period of not more than 2 hours; or
 - (c) one pound and thirty pence (£1.30) for an initial period of not more than four hours."

Article 17 sub-article "(1) (b)", "(1)(c)" and "(2)" shall be deleted and the following sub-articles shall be substituted:

(2)

- "(1) (b) where it is an amount of one pound and forty pence (£1.40), by the issue by the parking meter relating to the parking space in which the vehicle is left of a ticket indicating that the charge has been paid in respect of one hour and the day and time of payment of the charge, and by the display of that ticket on the vehicle in accordance with the provisions of Article 8(4) of this Order; and
 - (c) where it is an amount of two pounds and seventy pence (£2.70), by the issue by the parking meter relating to the parking space in which the vehicle is left of a ticket indicating that the charge has been paid in respect of two hours and the day and time of payment of the charge, and by the display of that ticket on the vehicle in accordance with the provisions of Article 8(4) of this Order.
 - The expiry of the initial period for which the initial charge has been paid shall be indicated when there is exhibited on the vehicle a ticket issued by the parking meter relating to the parking space in which the vehicle is left showing the day and time of payment of the charge and the time shown by the clock on the said parking meter is more than thirty minutes, or as the case may be, one hour or, two hours later than the time shown on a ticket issued in respect of a payment of one pound (£1.00) or more than one hour later or as the case may be two hours later than the time shown on a ticket issued in respect of a payment of one pound and forty pence (£1.40) or more than two hours later than the time shown on a ticket issued in respect of a payment of two pounds and seventy pence (£2.70)."

In Article 18 sub-articles "(1)(b)", (1)(c)" and "(2)" shall be deleted and the following sub-articles shall be substituted:

- "18. (1) (b) where it is an amount of sixty pence (60p), by the issue by the parking meter relating to the parking space in which the vehicle is left of a ticket indicating that the charge has been paid in respect of two hours and the day and time of payment of the charge, and by the display of that ticket on the vehicle in accordance with the provisions of Article 8 (4) of this Order.
 - (c) where it is an amount of one pound and thirty pence (£1.30), by the issue by the parking meter relating to the parking space in which the vehicle is left of a ticket indicating that the charge has been paid in respect of four hours and the day and time of payment of the charge, and by the display of that ticket on the vehicle in accordance with the provisions of Article 8(4) of this Order.
 - (2) The expiry of the initial period for which the initial charge has been paid shall be indicated when there is exhibited on the vehicle a ticket issued by the parking meter relating to the parking space in which the vehicle is left showing the day and time of payment of the charge and the time shown by the clock on the said parking meter is more than one hour or, as the case may be, two or four hours later than the time shown on a ticket issued in respect of a payment of thirty pence (30p) or more than two hours or as the case may be, four hours later than the time shown on a ticket in respect of a payment of sixty pence (60p), or more than four hours later than the time shown on a ticket issued in respect of a payment of one pound and thirty pence (£1.30)."

Birmingham City Council ("the Council") in exercise of its powers under Sections 1, 2, 4, 32. 35, 45, 46, 49, and 53 of the Road Traffic Regulation Act 1984 (as amended) ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order.

- 1. This Order shall come into operation on the 5th day of January One thousand nine hundred and ninety eight and may be cited as "Birmingham City Council (Parking Places and Controlled Parking Zone) (Birmingham) (Consolidation) (Vanation) (No. 9) Order 1998".
- (1) Except where otherwise stated, any reference to this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
 - (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. The Birmingham City Council (Parking Places and Controlled Parking Zone) (Birmingham) (Consolidation) Order 1995 shall continue in full force and effect subject to the variations described in the Schedule of this Order.

SCHEDULE (ARTICLE 3)

Variations to the Birmingham City Council (Parking Places and Controlled Parking Zone) (Birmingham) (Consolidation) Order 1995 (as amended)

In Article 2 the reference to "permitted hours" shall be deleted and the following new reference substituted therefor:

" 'permitted hours' means:

- (i) with respect to parking spaces within parking places specified in Schedule 1 Part I the period between 0800 hours and 1800 hours on any day such day not being Christmas Day, Easter Sunday or on Bank Holiday being a public holiday.
- (ii) with respect to parking spaces within parking places specified in Schedule 1 part if the period between 0800 hours and 1800 hours Monday to Saturday inclusive any such day not being Christmas Day Good Friday or a Bank Holiday being a public holiday. "

In Article 2 reference to 'restricted hours' item (a) the words 'Monday to Saturday inclusive' shall be deleted and the words 'any day' substituted therefor.

In Article 2 reference to 'restricted hours' item (c) the words 'Monday to Saturday inclusive and the periods between 0001 hours and 0400 hours and 1800 and 2400 hours on Sunday' shall be deleted and the words 'on any day' substituted therefor.

In Article 2 reference to 'restricted hours' immediately following item (d) there shall be inserted a new item (e).

"(e) in relation to any restricted road specified in Part V of Schedule 2 to this Order the periods between midnight and 1800 hours Monday to Saturday inclusive and between 0800 hours to 1800 hours on Sunday".

In Article 2 reference to 'restricted hours' the words

"Provided that any restricted roads or part of restricted road which is specified in both parts I and II of Schedule 2 to this Order shall be subject to the restricted hours as defined at item (b)" shall be deleted and the words

"Provided that:

- (i) any restricted road or part of restricted road which is specified in both parts I and II of Schedule 2 to this Order shall be subject to the restricted hours as defined in item (b).
- (ii) any restricted road or part of restricted road which is specified in both parts I and III of Schedule 2 to this Order shall be subject to the restricted hours as defined at item (c).
- (iii) any restricted road or part of restricted road which is specified in both parts I and IV of Schedule 2 to this Order shall be subject to the restricted hours as defined in item (d).
- (iv) any restricted road or part of restricted road which is specified in both parts I and V of Schedule 2 to this Order shall be subject to the restricted hours as defined at item (e).

In Article 8 (I) item (a) following the word 'minutes' there shall be inserted the words 'Monday to Saturday inclusive'

In Article 8 (I) item (b) following the word "hour" there shall be inserted the words "Monday to Saturday inclusive.

In Article 8 (I) item (c) following the word "hours" there shall be inserted the words "Monday to Saturday inclusive".

In Article 8 (I) following item (c) there shall be inserted the following new reference (d)

"(d) one pound (£1) for an initial period of not more than two hours on any Sunday".

In Article 9 the words "a season ticket" and "any of" shall be deleted and the words "an appropriate season ticket" and "any parking space within" be substituted therefor.

Following Article 9 a new article 9A shall be inserted.

9(a) While 8 (I) shall not apply to any vehicle displaying an appropriate season ticket in accordance with the provisions of Article 11 and left in any of the designated parking places designated in Schedule 1 part 1 to this Order between 0800 and 1400 hours on any Sunday.

Following Article 10 a new Article 10(a) shall be inserted.

10(a) The annual specified fee for a season ticket to be used in accordance with the provisions of Article 9 (a) shall be £10. Applications my be made by Church or other religious organisations on behalf of elderly or infirm members of their congregation.

In Article 13 (2) item (e) following the word "parking" there shall be inserted the words "space within a designated parking".

In sub article 17 (I) (a) before the word "where" there shall be inserted the words "with respect to Monday to Saturday inclusive".

In sub article 17 (I) (b) before the word "where" there shall be inserted the words "with respect to Monday to Saturday inclusive".

Sub article 17 (I) (c) shall be deleted and the following sub article substituted therefor.

(c) with respect to Monday to Saturday inclusive where it is any amount of two pounds and fifty pence (£2.50), by the issue by the parking meter relating to the parking space in which the vehicle is left of a ticket indicating that the charge has been paid in respect of two hours and the day and time of payment of the charge and by the display of that ticket on the vehicle in accordance with the provision of article 8 (4) of this Order;

Following sub article 17 (I) (c) there shall be added the following new sub article 17 (I) (d)

(d) with respect to any day being a Sunday, where it is an amount of One Pound (£1) by the issue by the parking meter relating to the parking space in which the vehicle is left of a ticket indicating that the charge has been paid in respect of two hours and the day and time of payment of the charge, and by the display of that ticket on the vehicle in accordance with the provisions of Article 8 (4) of this Order.

Sub article 17 (2) shall be deleted and the following sub articles substituted therefor.

- (2) (a) With respect to any day not being a Sunday the expiry of the initial period for which the initial charge has been paid shall be indicated when there is exhibited on the vehicle a ticket issued by the parking meter relating to the parking space in which the vehicle is left showing the day and time of payment of the charge and the time shown by the clock on the said parking meter is more than thirty minutes or as the case may be, one hour or two hours later than the time shown on the ticket issued in respect of a payment of One Pound (£1) or more than one hour later or as the case may be two hours later than the time shown on a ticket issued in respect of a payment of One Pound and thirty pence (£1.30) or more than two hours later than the time shown on a ticket issued in respect of a payment of Two Pounds and fifty pence (£2.50).
- (2) (b) With respect to any day being a Sunday the expiry of the initial period for which the initial charge has been paid shall be indicated when there is exhibited on the vehicle a ticket issued by the parking meter relating to the parking space in which the vehicle is left showing the day and time of payment of the charge and the time shown by the clock on the said

parking meter is more than two hours later than the time shown on a ticket issued in respect of a payment of One Pound (£1).

Schedule 2 Part I the words "Roads in which waiting is restricted between 0800 and 1800 hours Monday to Saturday inclusive" shall be deleted and the words "roads in which waiting is restricted between 0800 and 1800 hours on any day" shall be substituted therefor.

Schedule 2 Part III the words "No waiting between 0001 hours and 0400 hours and 0400 hours and 2400 hours Monday to Saturday inclusive and between 0001 hours and 0400 hours and 1800 hours and 2400 hours on Sunday" shall be deleted and the words "No waiting between 001 hours to 0400 and 0800 to 2400 hours on any day" substituted therefor.

Schedule 2 Part V following the words "from Monday to Saturday" there shall be inserted the words "and from 8am to 6pm on Sunday".

Schedule 2 Part VI the words "Monday to Saturday inclusive" shall be deleted and the words "on any day" substituted therefor.
