(PARKING PLACES AND CONTROLLED PARKING ZONE)(BIRMINGHAM

(CONSOLIDATION)(VARIATION) (NO. 10) ORDER 1998

Birmingham City Council ("the Council") in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984 (as amended) ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order.

1. This Order shall come into operation on the 21st day of August One thousand nine hundred and ninety eight and may be cited as "Birmingham City Council (Parking Places and Controlled Parking Zone) (Birmingham) (Consolidation) (Variation) (No. 10) Order 1998".
2. In this Order:
 - (1) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the article or schedule bearing that number in this Order.
 - (2) The Interpretation act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The Birmingham City Council (Parking Places and Controlled Parking Zone)(Birmingham)(Consolidation) Order 1995 shall continue in full force and effect subject to the variations described in the Schedule to this Order.

SCHEDULE (ARTICLE 3)

Variations to the Birmingham City Council (Parking Places and Controlled Parking Zone)(Birmingham)(Consolidation) Order 1995(as amended)

SCHEDULE 1 PART 1

Immediately following parking place No. 127 there shall be inserted a new Parking Place numbered 127A.

127A	ALL that part of the north east side of Whittall Street which is bounded on the north east by so much of the edge of the carriageway of that highway as extends from a point 136 metres north west of the north west kerbline of Steelhouse Lane for a distance of 25 metres in a north westerly direction and which has a width throughout of 2 metres.	24	1	-

In parking place No. 128 the figures "44.2" and "70" in the second column and "69" in the third column shall be deleted and the figures "16.2", "98" and "97" respectively shall be substituted therefore.

SCHEDULE 2 PART II

In the third reference to Whittall Street the figure "44.2" shall be deleted and the figure "16.2" substituted therefor.

In the eight reference to Whittall Street the figure "61.9" shall be deleted and the figure "35" substituted therefor.


Immediately following the eight reference to Whittall Street there shall be inserted the following new reference.

WHITTALL STREET

North east side, from a point 121.9 metres south east of the line of the kerb on the south east side of St. Chad's Queensway for a distance of 24 metres in a south easterly direction.
