The Birmingham City Council ("the Council") in exercise of its powers under Sections 1,2,4,32,35,45,46,49, and 53 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

**1. Citation and Commencement**

This Order may be cited as the Birmingham City Council (Parking Places and Controlled Parking Zone) (Birmingham) (Consolidation)(Variation) (No.28) Order 2001.

**2. Interpretation**

- (1) In this Order "the Order" means the Birmingham City Council (Parking Places and Controlled Parking zone)(Birmingham) (Consolidation) Order 1995;
- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted or as having affect by virtue of any subsequent enactment;
- (3) Unless the context otherwise requires any expression used in this Order which is also used in the Order shall have the same meaning as in the Order.

**2. Amendment of the Order**

Without Prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Order shall have affect as though:-

- (a) In Article 8 sub-article "(1)(b)" and "(1)(c)" shall be deleted and the following sub-articles shall be substituted:
  - "(1) (b) one pound and eighty pence (£1.80) for an initial period of not more than one hour; or
  - (c) three pounds and fifty pence (£3.50) for an initial period of not more than two hours."

- (b) In Article 8 sub-article "(2)(c)" and "(2)(d)" shall be deleted and the following sub-articles shall be substituted:

"(2) (c) one pound and forty pence (£1.40) for an initial period of not more than three hours."

(d) one pound and eighty pence (£1.80) for an initial period of not more than four hours."

- (c) Article 17 sub-article "(1) (b)", "(1)(c)" and "(2)" shall be deleted and the following sub-articles shall be substituted:

"(1) (b) where it is an amount of one pound and eighty pence (£1.80), by the issue by the parking meter relating to the parking space in which the vehicle is left of a ticket indicating that the charge has been paid in respect of one hour and the day and time of payment of the charge, and by the display of that ticket on the vehicle in accordance with the provisions of Article 8(4) of this Order; and

(c) where it is an amount of three pounds and fifty pence (£3.50), by the issue by the parking meter relating to the parking space in which the vehicle is left of a ticket indicating that the charge has been paid in respect of two hours and the day and time of payment of the charge, and by the display of that ticket on the vehicle in accordance with the provisions of Article 8(4) of this Order.

- (2) The expiry of the initial period for which the initial charge has been paid shall be indicated when there is exhibited on the vehicle a ticket issued by the parking meter relating to the parking space in which the vehicle is left showing the day and time of payment of the charge and the time shown by the clock on the said parking meter is more than thirty minutes, or as the case may be, one hour or, two hours later than the time shown on a ticket issued in respect of a payment of one pound (£1.00) or more than one hour later or as the case may be two hours later than the time shown on a ticket issued in respect of a payment of one pound and eighty pence (£1.80) or more than two hours later than the time shown on a ticket issued in respect of a payment of three pounds and fifty pence (£3.50)."

- (d) In Article 18 sub-articles "(1)(c)", "(1)(d)" and "(2)" shall be deleted and the following sub-articles shall be substituted:


"(1) (c) where it is an amount of one pound and forty pence (£1.40), by the issue by the parking meter relating to the parking space in which the vehicle is left of a ticket indicating that the charge has been paid in respect of three hours and the day and time of payment of the charge, and by the display of that ticket on the vehicle in accordance with the provisions of Article 8(4) of this Order.

(d) where it is an amount of one pound and eighty pence (£1.80), by the issue by the parking meter relating to the parking space in which the vehicle is left of a ticket indicating that the charge has been paid in respect of four hours and the day and time of payment of the charge, and by the display of that ticket on the vehicle in accordance with the provisions of Article 8(4) of this Order.

(2) The expiry of the initial period for which the initial charge has been paid shall be indicated when there is exhibited on the vehicle a ticket issued by the parking meter relating to the parking space in which the vehicle is left showing the day and time of payment of the charge and the time shown by the clock on the said parking meter is more than one hour or, as the case may be, two, three or four hours later than the time shown on a ticket issued in respect of a payment of thirty pence (30p) or more than two hours or as the case may be, three or four hours later than the time shown on a ticket in respect of a payment of seventy pence (70p), or more than three hours or as the case may be, four hours later than the time shown on a ticket issued in respect of a payment of one pound and forty pence (£1.40) or more than four hours later than the time shown on a ticket issued in respect of a payment of one pound and eighty pence (£1.80)."
