## THE BIRMINGHAM CITY COUNCIL (OFF-STREET PARKING PLACES) (AMENDMENT) (NO. 1) ORDER 1995 PART III (INNER CITY)

Birmingham City Council in exercise of its powers under Section 35(1) and (3) of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police of the West Midlands in accordance with Part III of Schedule 9 to the Act hereby make the following Order.

- 1. The City of Birmingham District Council (Off-Street Parking Places) Order 1986 Part III (Inner City) shall have effect subject to the amendments specified in the Schedule to this Order.
- 2. This Order may be cited as the Birmingham City Council (Off-Street Parking Places) (Amendment) (No. 1) Order 1995 Part III (Inner City) and shall come into operation on Monday, 19th June 1995.

## SCHEDULE

## **ARTICLE 7**

- 1. Article 7(b)(i) of the Order shall be deleted and the following Article shall be substituted therefor:
  - "7(b)(i) Where the vehicle is fitted with a front glass windscreen, facing forward behind the glass of such windscreen; or"
- 2. In Article 7(b)(ii) of the Order, the words "so that the time stated on the front of the ticket is clearly visible" shall be deleted.
- 3. In Article 7(c) of the Order, the words "in accordance with paragraph (c) of Article 5" shall be deleted and the following words shall be substituted therefor:
  - "in accordance with paragraph (b) of this Article."
- 4. Immediately following Article 7(c) there shall be added to the Order the following Article:
  - "7(d) The ticket referred to in this Article shall be so displayed that the day and time and all other information recorded on the front of the ticket are clearly visible to a person standing at the front or nearside of the vehicle."
