THE BIRMINGHAM CITY COUNCIL (OFF-STREET PARKING PLACES) (AMENDMENT) (NO. 1) ORDER 1996 PART III (INNER CITY)

The Birmingham City Council in exercise of their powers contained in Section 35(1) and (3) of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to this Act and of all other enabling powers, and after consultation with the Chief Officer of Police of the West Midlands in accordance with Part III of Schedule 9 of the Act of 1984, hereby makes the following Order.

- 1. The City of Birmingham District Council (Off-Street Parking Places) Order 1986 Part III (Inner City) shall have effect subject to the amendments specified in the Schedule to this Order.
- 2. This Order may be cited as the Birmingham City Council (Off-Street Parking Places) (Amendment) (No. 1) Order 1996 Part III (Inner City) and shall come into operation on the 30th March 1996.

SCHEDULE

Article 7(a) shall be numbered "7(a)(i)" and the following sub-article shall be inserted into the Order:

"7(a)(ii) Where a driver in seeking to pay an initial charge inserts into a ticket machine a coin or coins which exceeds the charge for a specified number of hours, a ticket will be issued only for the number of hours, for which the whole of the charge has been paid."

Article 8(a) of the Order shall be deleted and the following Articles shall be substituted:

"8(a)(i) If a vehicle is left in a parking place during the charging hours for longer than the period for which payment has been made by the initial charge, an additional amount of Twenty Five Pounds (£25.00) shall be payable for any period in excess of the parking period purchased.

8(a)(ii) In the case where the provisions of Article 11 apply, an additional amount of Fifty Pounds (£50.00) shall be payable.

8(a)(iii) The additional amounts referred to in Articles 8(a)(i) and 8(a)(ii) are hereinafter referred to as the "excess charge".

In Article 8(c)(iii) of the Order the words "£35.00" shall be deleted and the words "Twenty Five Pounds (£25.00) or as the case may be Fifty Pounds (£50.00)" shall be substituted.

The scale of initial charges enumerated in Part II of the Schedule to the Order shall be deleted in respect of Irving Street and the following scale of charges substituted:
