The Birmingham City Council in exercise of their powers in section 35(1) and(3) of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to this Act and of all other enabling powers, and after consultation with the Chief Officer of Police of the West Midlands in accordance with Part III of Schedule 9 of the Act of 1984, hereby makes the following Order.

1. The City of Birmingham District Council (Off-Street Parking Places) Order 1986 - Part III (Inner City) shall have effect subject to the amendments specified in the Schedule to this Order.
2. This Order may be cited as the Birmingham City Council (Off-Street Parking Places) (Amendment) (No.1) Order 1997 - Part III (Inner City) and shall come into operation on the 31st March 1997.

SCHEDULE

In Article 2(a) of the Order the definition of a "Ticket Machine" shall be deleted and the following definition shall be substituted:

" "Ticket Machine" means apparatus designed to indicate the time by a clock and to issue parking tickets indicating the payment of a charge and the date and time at which the charge was paid."

PART I

The following Parking Places shall be deleted from Part I of the Schedule to the Order:

"Buckingham Street"
"Ward Street"

Part I of the Schedule to the Order shall be amended as follows in respect of:

(a) Irving Street

In Column 4, immediately following the word "Friday", the words "and Saturday" shall be inserted.

(b) Blucher Street and Tennant Street

In Column 5, the Hours of Operation of the Parking Place shall be deleted and the following Hours shall be substituted:

"0800 hours to 2200 hours"

In Column 6, the Maximum Period for which Vehicles may Wait shall be deleted and the following Period shall be substituted:

"14 hours"

PART II

The scale of charges enumerated in Part II of the Schedule to the Order shall be deleted and the following scale of charges substituted in respect of:

(a) Blucher Street, Irving Street and Tennant Street
